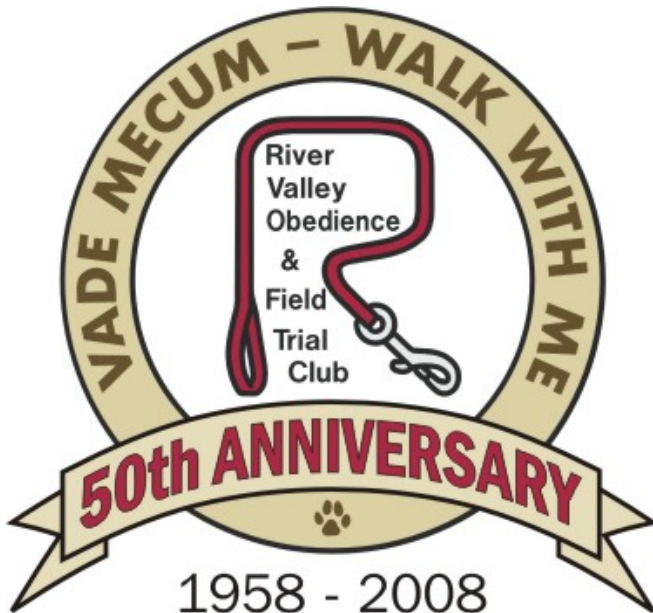

**Acceptance date** - 8:00 AM, Wednesday, May 07, 2008. Entries received before this date and time will be returned.

**Closing date** - 6:00 PM, Monday, May 26, 2008. Entries must be delivered to the Test Secretary by the closing date. The club cannot accept entries delivered after this date and time. After the closing date, the club will send out acceptance letters, advising entrants of the status of their entry. A map showing directions to the rendezvous site will be provided.

*CKC rules (6.5.1): On the closing date, the test giving club shall notify the person making the entry, that the entry has been received and accepted. When the advertised limit has been reached, all remaining entries shall be assigned a position on an alternate list in the order received. At the time of the draw, entries from the alternate list may fill any absentee spaces. An absentee is defined as an entrant who is not present at the time of the draw. The person making the entry shall be notified of his position on the alternate list. Entries will be refunded within 10 days of the tracking test to those on the alternate list who did not participate in the test.*

**Entries** must be mailed or sent by courier to the postal address of the event secretary. Faxed, e-mailed or hand delivered entries are not acceptable. Each entry must be mailed in a separate envelope. Entries will close automatically when the advertised limit has been reached, even if the official closing date for entries has not arrived. All entries must be made on an official CKC entry form. Owners are responsible for errors in making out entry forms, regardless of who completes the entry form. *Incomplete or improper entry forms will not be accepted.* To prevent delays, entrants using couriers are encouraged to mark their envelope with the instructions "no signature required".

**Draw for tracks (UTD then UTDX) on Saturday, June 7th**, will occur at **5.00PM** at the Student Union Parking Lot, University of New Brunswick, 21 Pacey Drive, Fredericton, NB E3B 5A3.

**Prizes** –Passing dogs will receive a rosette.

**Entry fees** : \$80.00- UTD and UTDX

**Listing fee** - \$8.56 “A listing fee as established by the Canadian Kennel Club must accompany the entry of a dog which a Canadian Kennel Club individual registration number or Event Registration Number (ERN) is not shown on the entry form.”

**Fees** are payable to: **River Valley Obedience & Field Trial Club, Inc. (or RVO & FTC)**. Post-dated cheques will not be accepted. NSF Cheques will be considered non-payment of entry fees. Please note that fees are due and payable in Canadian dollars. Due to constantly fluctuating currency rates, discounted cheques will not be accepted. Personal cheques will be accepted, however, they are to be payable in Canadian funds. If you send a cheque in US funds, it must be made out for the full amount of the entry and no exchange will be refunded to the exhibitor. Postdated cheques will not be accepted. Please do not make cheques “Payable in Canadian funds” or “At Par”. The banks will not clear them. To simplify the process we urge that you purchase bank drafts or INTERNATIONAL money orders payable in Canadian funds. Your understanding and cooperation is appreciated.

**Withdrawals and Entry Fee Refunds** - If an entry withdraws between the closing date and the test date, and is replaced by an alternate, the entry fee will be refunded. Withdrawals must be made in writing to the Test Secretary. Entries will be refunded within ten days of the tracking test to those on the alternate list who did not participate in the test. Entry fees will not be refunded if a dog is absent, disqualified, excused by a Judge, or barred from competition by action of the Test Committee.

**Bitches in Season** - Bitches in season **will** be allowed to participate but must run last and must be kept separated from all other dogs during the event.

River Valley Obedience & Field Trial Club will use all reasonable care to ensure the safety of dogs and persons at the test. However neither RVO&FTC nor any individual will accept the responsibility for loss or injury, however caused, to any dog, person or property.

*CKC Tracking Rules (13.7): It shall be the duty and obligation of the test-giving club to see that a judge, club official, volunteer, or any participant at an event held under these rules, is not subject to indignities of any kind. The Tracking Test Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred. A copy of this regulation shall be prominently placed in every premium list and catalogue*
