

To obtain an ERN, mail or fax a photocopy of the dog's foreign registration certificate with cheque or VISA/Mastercard number (expiry date, cardholder's name and signature). Provide your complete address for return of ERN to you. The cost is \$64.07. Dog may initially be entered as listed but the ERN must be applied for within 30 days of winning CKC points, awards, or scores to avoid cancellation. # CLASSIFICATION

Please see CKC rule books for specific class descriptions. CKC members may access these books at www.ckc.ca (member services). Non-members who require class details are asked to call the Show Secretary at 780-988-5020 or by email at Maldawn@aol.com It is the responsibility of the exhibitor to be familiar with the Conformation, Obedience & Rally rules as set out by the Canadian Kennel Club

#### **CONFORMATION**

The following CKC conformation classes (divided by sex) will be offered:

Junior Puppy: for dogs 6 mths of age but under 9 mths of age.

Senior Puppy: for dogs 9 mths of age but under 12 mths of age

12-18 Months: for dogs 12 mths of age and under 18 mths of age

Canadian Bred: for dogs born in Canada; champions in any country excluded.

Bred by Exhibitor: for dogs owned and handled in the ring by the breeder.

Open: for all dogs.

<u>Specials Only:</u> dogs which are registered individually in the records of the Canadian Kennel Club and have attained championship status may be entered in the 'Specials Only' class.

Exhibition Only: for all dogs over 6 mths of age and eligible for registration with the CKC (non-competitive class).

<u>Exhibition Only Baby Puppy</u>: dogs 3 months of age and under 6 months of age on the day of the show may be entered in Exhibition Only providing that the owner of the puppy has also entered a dog in one of the regular official classes.

#### OBEDIENCE

- <u>Pre-Novice:</u> for any dog that has not earned the title PCD (Pre Companion Dog) title. Dogs in this class may be handled by the owner or any other person. A dog may be entered in this class that has not earned the title of CD.
- <u>Novice A:</u> for any dog that has not earned the title of CD. Only one dog per handler is allowed in this class, and that person must handle the dog in all exercises. No person who has trained or exhibited a dog that has earned a CDX title shall be allowed to handle in this class.
- <u>Novice B:</u> for any dog that has not won the title of CD. Dogs in this class may be handled by any person. More than one dog may be entered by any handler, but each dog must have a separate handler for the group exercises.

<u>Novice C:</u> for any dog that has earned the title CD or any higher obedience titles and exercises will be performed and judged as described in the official Novice classes. Scores earned in this class are not eligible for High in Trial. This is an elective class and offered for those people who feel the dog requires ring experience. Dogs may be entered in Novice C class in addition to any of the Official Classes or Unofficial classes they are eligible.

- <u>Novice Intermediate</u>: For any dog which has earned the title of CD, or any higher obedience titles. Scores earned in this class are not eligible for High in Trial. Dogs may be entered in Novice Intermediate class in addition to any of the Official Classes or Unofficial classes they are eligible
- <u>Open A</u>: for any dog that has earned the title of CD but has not earned the title of CDX. Only one dog per handler is allowed in this class, and that person must handle the dog in all exercises. No person who has trained or exhibited a dog that has earned a UD title shall be allowed to handle in this class.
- <u>Open B:</u> for any dog that has earned the title of CD, CDX or UD. Dogs in this class may be handled by any person. More than one dog may be entered by any handler, but each dog must have a separate handler for the group exercises
- <u>Utility A:</u> for any dog that has earned the title of CDX. Handlers may enter more than one dog in this class. No person who has trained or exhibited a dog that has earned a MOTCh title shall be allowed to handle in this class.
- <u>Utility B:</u> for any dog and handler where the dog has achieved a CDX and/or a UD title and for dogs and handlers where the handler has put a MOTCH title on any dog.
- <u>Versatility</u>: for any dog that has attained the title of CDX and at least 1 qualifying score towards the Utility title, prior to the closing date of the trial in which it is to be entered. A person may enter more than one dog in this

class. The exercises to be performed by each dog will be determined by the handler's drawing 1 of a set of 4 cards listing a combination of 6 exercises after the handler has entered the ring. <u>Dogs entered in the Versatility</u> <u>Class must also be entered in any Regular class or for Exhibition Only.</u>

<u>Veterans</u>: for any dog that has earned the title of CD or higher and is 7 years old or older on the day of the trial. The exercises shall be performed and judged as in the Novice Classes. <u>Dogs entered in the Veterans Class</u> <u>must also be entered in any Regular class or for Exhibition Only.</u>

#### <u>RALLY</u>

- Rally Novice A: Dogs entered in this class may not have earned a R.N title or any CKC Obedience title other than PCD. No handler who has exhibited a dog through its CKC CDX title shall be eligible to enter this class.
- <u>Rally Novice B:</u> Any dog may compete in this class until a qualifying score in the Rally Advanced Class is earned. No dog may be entered in Rally Novice A and Rally Novice B at any one trial.
- <u>Rally Intermediate:</u> This class shall be for dogs that have earned the Rally Novice (RN) title. A dog competing in Rally Intermediate or any other obedience or rally titles may continue to compete in this class indefinitely.
- <u>Rally Advanced A</u>: For dogs that have earned the Rally Novice title but have not won the Rally Advanced title or any CKC Obedience title other than PCD. No handler who has exhibited a dog through its CKC CDX title shall be eligible to enter this class.
- <u>Rally Advanced B</u>: for dogs that have earned the Rally Novice title. No dog may be entered in both Rally Advanced A and Rally Advanced B at any one trial.

<u>Rally Excellent A:</u> for dogs that have earned the Rally Advanced title but have not earned the Rally Excellent title or any CKC Obedience title other than PCD. No handler who has exhibited a dog through its CKC CDX title shall be eligible to enter this class.

<u>Rally Excellent B</u>: for dogs that have earned the Rally Advanced title. No dog may be entered in the Rally Excellent A and Rally Excellent B class at any one trial.

## **GENERAL INFORMATION**

- ENTRY FEES WILL BE REFUNDED WHEN A BITCH ENTERED IN OBEDIENCE COMES INTO SEASON
  after entry of the bitch has been submitted if a Veterinarians certificate (certifying that the bitch was in season
  within the ten day period preceding the trials) is delivered to the Show Secretary on or before the date of the
  trial.
- 2. "A judge officiating at a dog show held under these rules shall not be subjected to indignities of any kind during the progress of the show. It shall be the duty and obligation of the club holding the show to see that this rule is effectively carried out."
- 3. "The participation in any manner or in any capacity at a competitive event held under these Rules shall be considered a privilege accorded to any person by the CKC and such privilege may be extended and withdrawn by the Discipline Committee". "Any person availing himself of the privilege of participating in any manner, shape or form and in any capacity, including that of a spectator at a competitive event held under these rules shall, by such participation, be deemed to have agreed to the authority of the CKC and its Board of Directors."

#### WITHDRAWAL OF ENTRIES

Please note: An exhibitor has the right to withdraw an entry up to the closing date and time as published in this premium list. This may be done by telephone <u>but written or electronic notification must be</u> received by the Show Secretary no later than the official closing date and time. If written notification is not received by that time, the dog will remain entered in the show.
