


Directions to the Trial Site: From US take Hwy. 61 to Harbourview Expressway Turn right. At 3rd set of traffic lights Fort William Rd. (Sears Store on right) turn left. 2 blocks up turn right on Burbidge St. (beside Leon's Store) turn left on Fortune St. CDC is at end of Fortune St.. Last door on right hand side.

From Kakabeka follow highway to Fort William Rd.(Sears Store on right) turn left, 2 blocks up turn right on Burbidge St. (beside Leon Store) and left on Fortune. CDC is at end of Fortune St.. Last door on right hand side..

NOTE: Trial Site opens 9:00 am Thursday and 7:00 am Friday . NO DOGS may be left in the building overnight.

US Exhibitors: You may be required proof of ownership of dogs and show current rabies certificate. Arm bands picked up at Trial Sect. Table.

JUDGING SCHEDULE: To expedite judging, in event of absent dogs, no trial times have been posted. It is the responsibility of exhibitor to be ringside when called. Check with the Trial Secretary for approximate times. Break will be at Judge's discretion. Check white board ringside for info regarding breaks.

Schedule was prepared in haste to notify exhibitors. Should you notice errors kindly inform me. Pull up & unloading beside building, but exhibitors must park in designated area beyond building to the north behind the fenced in area. There will no lots of heavy equipment moving in yard. PLEASE BE CAFEFUL.

There are 8 crates available for rental @ \$1.00 a day. This saves space in the building & allows more 'warm up area'

The schedule should allow those doing show & performance ample time to travel between sites.
