ADDITIONAL INFORMATION

- ONLY APPROVED CKC collars will be allowed in the precincts of the Trials.
- ♦ SHOWING correct information on the entry form is the responsibility of the etrant. However, Exhibitors incorrectly entered in the "A" class are permitted to move the dog to the corresponding "B" class up to one hour before the start of the trial. The SKOC takes no responsibility for omissions or errors made on the entry forms. The Show Committee reserves the right to refuse any entry subject to the CKC rules.
- BITCHES IN SEASON: Obedience entry fees WILL be gladly refunded to exhibitors whose females are in season during the trials (and must be withdrawn) IF: a dated veterinarian's certificate is produced prior to the trial.
- ♦ THE PRECINCTS of these trials shall be the **basement of the Eastview Shopping Centre**. No dog will be allowed in the building unless entered in the Trials or Exhibition Only.
- ♦ KNOWLEDGE of the Canadian Kennel Club Rules is the responsibility of the entrant. Rule books may be obtained from the CANADIAN KENNEL CLUB, 200 Ronson Drive, Suite 400, ETOBICOKE ON M9W 5Z9 Phone: 416-675-5511

NOTICE TO EXHIBITORS

Rally Novice A – may not have earned the R.N. title or any CKC obedience title other than PCD. No handler who has exhibited a dog through its CKC CDX title shall be eligible to enter this class. Handler of any dog in this class must be the owner, co-owner, or a member of their immediate families. A person may enter more than one dog in this class. No dog may be entered in both Rally Novice A & Rally Novice B at any one trial.

Rally Novice B – for any dog. May compete until a qualifying score in the Rally Advanced Class is earned. The owner or any other person may handle dogs in this class. A person may enter more than one dog in this class.

<u>Rally Intermediate Class</u> – is an elective class and earning the title is not a requirement to enter Rally Advanced Classes.

Rally Advanced Class – shall be for dogs that have earned the RN title but have not earned the RA title or any CKC Obedience title other than PCD. No handler who has exhibited a dog through its CKC CDX title shall be eligible to enter this class. The handler must be the owner, co-owner, or a member of their immediate families. A person may enter more than one dog in this class.

Rally Advanced A – Same requirements as in Novice A

<u>Rally Advanced B</u> – will be for dogs that have earned the RN title. A dog completing the RA title may continue to compete in this class indefinitely. The owner or any other person may handle dogs in this class. A person may enter more than one dog in this class.

Rally Excellent A – for dogs that have earned the RA title, but have not earned the RE title or any CKC Obedience title other than PCD. No handler who has exhibited a dog through its CKC CDX title shall be eligible to enter this class. The handler – same as other A classes.

Rally Excellent B – for dogs that have earned the RA title. A dog completing the RE title may continue to compete in this class indefinitely. The handler – same as other B classes.

<u>Rally Advanced Excellent Class</u> – Upon completion of the Rally Excellent title, qualifying scores may be accumulated from the Rally Advanced B Class and the Rally Excellent B Class to earn the Rally Excellent (RAE) title.

In order to receive the RAE title, a dog must qualify 10 times in both the Rally Advanced B Class and the Rally Excellent B Class at the same trial. See more in the Rule Book.

<u>Veteran Dogs</u>: There are no breed or age exceptions to the required jump heights. <u>Unofficial Classes:</u>

Dogs entered in unofficial classes must also be entered in an official Rally class or Exhibition Only. All ribbons, and/or trophies will only be awarded to those teams with a qualifying score.

Rally Brace Classes: requirements shall be the same as those listed for the Obedience Brace Class, except that they are open to any 2 dogs that have earned a title of RN or higher. Clubs may offer one or all levels of classes: Rally Novice, Advanced and/or Excellent.

Rally Team Classes: Eligibility for Team Classes shall be the same as that listed for the Obedience Team Class, Except that the class is open to any 4 dogs that have earned a title of RN or higher. Levels offered by the clubs are the same as Rally Brace Classes. Each team member will run the course individually, with the team time running continuously. The judge will give the first member of the team the "Forward" command from the "Start" sign. Each subsequent dog and handler will start when the previous dog and handler pass the "Finish" sign, without any additional command of "Forward" by the judge. Timing for each team will begin when the judge commands "Forward" to the first handler in the team and will stop when the fourth handler and dog pass the finish line. If jumps are required, the height will be based on the smallest dog on the team. There is no "Sit/Stay" included if the class is offered at the Excellent level.

Exhibition Only: the same as listed in the Obedience Trial Rules & Regulations.
