Mr. Bruce Fraser

Bruce began training Miniature Schnauzers for conformation with his 1st Miniature Schnauzer in 1996. Catching the "show bug" after taking Best Puppy in Show and Group Third the first weekend out, next on the horizon was a breeding program, focusing on Black Miniature Schnauzers. The top American lines (Kelly's and Jubilee) figured prominently in the pedigree and by the second generation his kennel "Advocate" produced its third black champion, "Granite". Bruce decided this was the dog he wanted to do obedience with and in 1995 began a concentrated obedience training regimen. By 1999 "Granite" became Ch & OTCh Advocate's Black Gemstone and the Number One Miniature Schnauzer in Canada in obedience in 2000. Following in Granite's footsteps (and jumps) is his grandson Ch & OTCh Advocate's Bentley, who completed his Utility degree in August 2007.

For Bruce, a lawyer by profession, it was a natural progression to become a CKC licensed obedience trial judge in 2004. He also devotes considerable time to dog club activities. Bruce has been a member of the BC All Terrier Club since 1987 and currently serves on the executive of the club, as Obedience Director. Bruce is also treasurer of the Richmond Dog Fanciers, which in recent years has focused on presenting "quality venue" obedience trials.

Bruce continues to train and trial Miniature Schnauzers with Bentley and his grandson "Harlow" and to show in conformation with Bentley's 2008 grandkids "JJ" and "Justin".

Bruce is also an all class Rally Obedience Judge.

Dogs have been a major part of my life since early childhood. I currently maintain and operate a canine training facility in Edmonton, instructing obedience and Rally-O classes. In 2006 I became licensed by the Canadian Kennel Club to judge Obedience and Rally-O.

Rally Obedience Trials

Sections 6.1.1 - 3 of the CKC's Event Rule Book

for Rally Obedience Trials state:

- 6.1.1 Every dog entered in an approved rally obedience trial or sanctioned rally obedience match must be one of the following:
- (a) Registered with the CKC
- (b) Have an Event Registration Number
- (c) Have a Performance Event Number
- (d) Eligible for registration with the CKC
- (e) Have a Miscellaneous Class Certification number
- (MCN) if it belongs to a CKC listed breed.
- 6.1.2 To be eligible to compete at approved rally obedience trials or sanctioned rally obedience matches a dog must meet the requirements of Section 6.1.1, and:
- (a) Must be at least 6 months of age.
- (b) May be spayed, neutered, or debarked.
- (c) May not be lame (it is the judge's responsibility to determine whether a dog is lame).
- (d) May not compete if it has tape or bandages that may impair its working ability (such a dog must be immediately excused and under no circumstances may it be returned later for judging after the tape or bandages have been removed).
- (e) Entries in each class may be arranged according to the size of the dog.
- 6.1.3 If a dog is not registered individually in the records of the CKC, it may be entered at a trial held under these rules as a "listed" dog, provided that:
- (a) If born in Canada, it is eligible for individual CKC registration.
- (b) If not born in Canada it is eligible for individual registration in the records of the CKC.
- (c) If it is a foreign born and owned dog, an Event Registration Number or CKC registration number is obtained from the CKC within 30 days of the first trial entered.
