It is the responsibility of the exhibitor to be at ringside when their classes are called. It is not the responsibility of the Ring Steward to locate dogs. Judges will not wait for any dog delaying a class. Group judging will follow the last breed in the Group. BIS, RBIS, BPIS RBPIS & BBIS will follow immediately after the last group. The precinct of the shows and trials is the building and its entrances. The building will open each day at 7 AM and will be open Thursday Evening for those who wish to set up early. The Show/Trial Superintendent will be in complete charge of these shows and trials. Junior Handling will be at the lunch break Saturday and Sunday.

DIRECTIONS TO THE SHOW:

Coming from the Bridge, take Hwy 1 to Charlottetown. Past Cornwall & the Outlet Shops (on Left) take the next left at the lights (Upton Rd). There is a strip Mall with an RCMP depot located there on the right. There will be a sign indication BYPASS.

Stay on this road for approx. 1 mile following the signs that will bear to the right past the PEPSI Bottling Co. Stay on this road for 3 Miles.

Take the Kensington Rd Exit to your right. Stay on this road for about 1.5 miles past the golf course on the left. You will see the Racetrack (Charlottetown Driving Park & Entertainment Center) and the dog show is located in the attached blue portion of the Building.

Entrance for loading and unloading will be just to the left of the main doors. Green doors will be clearly marked.

Vehicles may use hazard lights for unloading, but vehicles MUST be moved upon completion and parked at the PARK street parking Lot, (Far right at the end of the building). Please obey parking officers and handicap restrictions, as vehicles not parked properly may be towed. Building will be open between 4 PM & 8PM for set up. Limited Xpens due to space.
