Entries OPEN May 1st, 2017 and CLOSES June 5, 2017 at 6:00 pm Day of Show entries will be taken unless trial fills.

Dogs may enter both the Instinct Test and Novice class in the same trial until the dog has earned the RATN title and then they cannot enter the Instinct Test.

All entries must be accompanied by entry fees to be valid. A returned check does not constitute a valid entry. There will be a \$40 fee for all returned checks. NO entries will be taken over the phone or electronically. Make check payable to NOWDA. Send entries and fees to the trial secretary. Dogs MUST have a Barn Hunt registration number to enter this event.

Open to all breeds and mixed breeds ages 6 months or older.

If coming from the US.. Hwy 61 to Mountain Rd, turn right onto Mountain Rd and proceed to Feaver Rd, right onto Feaver Rd.. Barn at the end of the road on the lefthand side

EXHIBITOR INFORMATION

All dogs must be on a short leash and under control while on trial grounds except while showing. FLEXI LEASHES ARE NOT PERMITTED INSIDE ANY BUILDINGS. Electronic collars/devices are not allowed anywhere on the site-this includes electronic bark collars as well as citronella collars. Head halters are also not allowed at BH trials. Approved collars include flat snap or buckle collars of solid construction and leather or nylon leads. Limited slip martingale and single piece slip collars/leads are allowed. Harnesses are allowed. Dogs MUST run "naked", without a collar/harness. Dogs should be brought into the ring with collars/harnesses which can be easily and quickly removed and replaced.

CRATING: All dogs must be on lead or crated at all times unless actively working.

RUNNING ORDER:

Dogs will be run in height order with dogs being handled by the same person separated into different staged groups.

AWARDS: Ribbons will be given for a qualifying run. Rosettes will be given for 1st through 4th place in each height category. Rosettes will be given for High in Class in each division. New Title rosettes will be given to dogs completing a title. Some additional sponsored awards may be given.

Bitches in season are eligible for entry but will be required to be kept separate from all other dogs and will be run at the end of their class/trial. Entry fees for bitches that come into season will be refunded until closing time of the trial if you wish to withdraw. After the trial closes, entry fees will not be refunded. If bringing a bitch in season, please inform the trial secretary prior to the trial and inform all exhibitors at the judge's briefing. Please bring adequate water for you and your dogs.

Food will be available for purchase. There will be a porta pottie on site. The building is unheated without power so dress accordingly for whatever weather is forecasted.

Cancellation Policy

Every attempt will be made to hold this event as scheduled. In the event of an "Act of God" such as fire, flood, etc., an event may be canceled. We will make every attempt to contact entrants and inform them of the cancellation. We will return all or part of the entry fees at our discretion.

Refunds

Refunds minus a \$2 processing fee may be offered only for injured or sick dogs with veterinary note. Requests for refunds must be made by the closing date. Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by action of the Event Committee.

Returned Checks

A returned check does not constitute a valid entry. There will be a \$40 fee for all returned checks.

Dog Aggression

Any dog behaving in a threatening or aggressive manner toward another dog or a person may be dismissed from the trial if justification is found to do so by the judge and/or trial committee Animal Safety The safety of the dogs and the rats are our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and physically able to perform all course elements safely.
