RULES and AWARDS

All dogs between the ages of 6 and 18 months on the date of the show shall be eligible to compete, regardless of place of birth. All dogs entered in the sweepstakes must also be entered in a regular class at the All Breed Show, on the day of the Sweepstakes. Money received as entry fee for the sweepstakes will be pooled and divided as follows:

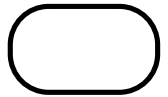

CHAMPIONS & CHAMPIONSHIP POINTS

SECTION 1: A dog awarded WINNERS at a championship show held under these Dog Show Rules shall be credited with a number of championship points (ranging from 0 to 5) and the determination of the number of championship points to be credited to a dog awarded WINNERS shall be as provided hereunder.

SECTION 2: The schedule to be employed in the determination of the number of points to be allocated a dog awarded WINNERS shall be as follows:

To determine the numbers of championship points earned by a dog awarded WINNERS total all the dogs in competition which the dog defeated, directly or indirectly, for the highest of the following official breed awards: Winners, Best of Winners, Best of Breed or Best of Opposite Sex and then consult the schedule set forth above. The new system provides for additional points (provided that the dog has defeated another as listed hereunder):

A class dog awarded Best In Show at an all-breed championship show will be credited with five points inclusive of any points earned at the breed or group level. In no case may a dog earn more than five points at any single show.

- Only dogs which are already registered in the Canadian Kennel Club Stud Book, or are eligible for such registration, can be entered.
- To comply with instructions issued by the Canadian Kennel Club, we will be unable to accept any entry reaching our Show Secretary after the official closing date as published in this premium list.
- No entry will be accepted unless all particulars called for on the entry form are filled in, ex.Birthdate, Class, Sex, Owners address etc.
- NO ENTRY WILL BE ACCEPTED UNLESS ACCOMPANIED BY THE ENTRY FEE.
- TELEPHONE ENTRIES CANNOT BE ACCEPTED.
- Exhibitors must abide by errors made in entering their dogs regardless of how or by whom the entries were made. Change or cancellation of any entry after closing day is prohibited.
- The Kars Community Recreation Association has the right to refuse any entry, subject to C.K.C.Dog Show Rules.
- THE SHOW SUPERINTENDENT WILL BE IN FULL CHARGE OF THE SHOW, which will be governed by C.K.C.Rules.
- Identification cards and judging schedule will be mailed as soon as possible after entries close.
- The person accompanying the dog must show the identification card before the dog is allowed in the show. Unless a dog is officially entered, it will not be allowed in the show precincts.

- Dogs need only arrive 15 minutes before scheduled judging time, and will be excused each show, when not required for further judging.
- It is the responsibility of the exhibitor to have the dog in the ring when the dog's class is scheduled for judging.
- The Show Committee and Diana Edwards Show Services will use due care and diligence for the welfare of the dogs and exhibitors, but will not be responsible for, or assume any liability in the event of an accident, or other misfortune, to either dogs, exhibitors, or patrons.
- The show premises will open not later than one hour before scheduled judging times.
- If because of riot, civil disturbance or other acts beyond the control of the management, it is impossible to open or to complete the show no refund of entry fee will be made.
