

MANITOBA CANINE ASSOCIATION JUDGING SCHEDULE AUGUST 17, 18, 19 & 20, 2017

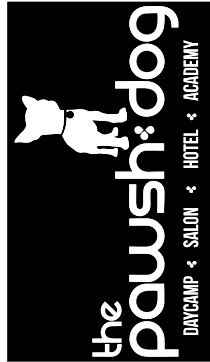
Our shows are held at the East St Paul Community Club, 264 Hoddinott Road, East St Paul, Manitoba. **The arena will be open to exhibitors for setup at 3:00 p.m.** (no exceptions) Wednesday the 16th. No one will be allowed to set up prior to this time except for our vendors. The benching area of the building will be open at 6:00 a.m. and closed at 10:00 p.m. sharp each day. There will be NO security overnight. Please read the schedule carefully --- there are some breeds out of order. It is the exhibitor's responsibility to be at ringside when required. Judging is based upon 20 - 25 dogs per hour. Please allow for errors and omissions due to the fact that this was put together in a short period of time. Please be considerate and ask before setting up. There will be no Mats allowed in the non-reserved benching areas. There is NO power available outdoors except for the reserved power camping areas. Generators can be used, but only at camp sites. There is no vehicle parking at the back of the building or on the grass. Vehicles are not allowed to drive out onto the field to unload. We will have 2 Gators rotating to assist you in getting your equipment onto the field or to the building as you require. Please just flag them down as they will be out looking for people requiring assistance. A ramp will be available if a judge requests it. **MCA Junior handling will be Sunday at noon in the first available ring.** Boosters are designated in bold type. We hope that this weekend will be enjoyable and bring you fond memories of your time in our fair province. Ring 1 - Obedience and Rally ring is indoors, the remainder of the rings are outdoors. We will be having a Sanction Match on Wednesday, August 16th at 6:00pm so come out and get prepared for the weekend. Entry is only \$5.00! Thank you all for supporting our shows and trials. Travel safe and see you in August!

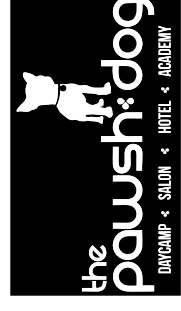
