NON CKC MEMBER PARTICIPATION FEE—CANADIAN RESIDENTS ONLY

Effective Jan 1, 2011, the CKC instituted a Non-Member Participation fee for all Canadian residents who participate in a CKC event but are not CKC members. In order to protect the awards/titles earned, the non-member will have a choice either to become a CKC member or to pay the non-member participation fee. Failure to comply within 30 days of notification will cause all awards and titles to be cancelled. This applies to dogs wholly owned by non-member resident in Canada, and does not apply to U.S. exhibitors OR to CKC members or dogs co-owned with a CKC member.

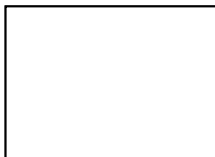

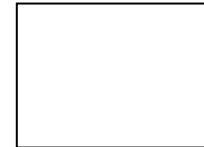
