CKC 6.3.3 Tendering of a dishonoured cheque or credit card in payment of entry fees shall be considered non-payment of entry fee, and is an offence punishable by disciplinary action and cancellation of awards.

Attention Foreign Exhibitors – Please note that fees are due and payable in Canadian dollars. Due to consistently fluctuating currency rates, discounted cheques will not be accepted. Personal cheques will be accepted; however, they are to be payable in Canadian funds. If you send a cheque in US funds, it must be made out for the full amount of the entry and no exchange will be refunded to the exhibitor. Please do not mark cheques “Payable in Canadian Funds” or “At Par”. They will not be cleared by the bank. To simplify the process, we urge that you purchase bank drafts or money orders payable in Canadian funds. Your understanding and cooperation is appreciated. Thank You.

LIMITED ENTRY mean entries will close on the listed closing time or when the Obedience judge’s assignment reaches 7 hours of judging when calculated at a per hour rate of 9 Pre-Novice dogs, 8 Novice dogs, 7 Open dogs and 6 Utility dogs. Where Rally is calculated based on the judging of a maximum of 15 dogs per hour also for 7 hours of judging. (CKC 4.4.2) *‘When the advertised limit has been reached, all remaining entries may be assigned a position (by class) on the reserve list. The person making the entry shall be notified of his position on the list. In the event that the entry of a bitch in season is withdrawn after the closing date, it may be substituted with one from the reserve list up to and including the day of the trial. At the club’s discretion, if the club is notified in writing after the closing date that an entry other than a bitch in season will be absent from a trial, the entry may be substituted with one from the reserve list up to 24 hours prior to the trial. Fees will not be refunded for any reason other than a bitch being in season and to those on the reserve list who did not participate in the trial.’*

New Title Rosettes – The Poodle Club of Canada is pleased to offer a rosette for each dog completing the requirements for a Rally Obedience or an Obedience title at these events.

GENERAL INFORMATION

1. The **trial precincts** shall be the entire show building at The Poodle Farm.
2. Show Superintendent has full charge of the show which is governed by CKC rules.
3. The Poodle Club of Canada and The Poodle Farm will use **due care and diligence** for the welfare of dogs and exhibitors, but will not be responsible for, or assume liability in the event of accident, or other misfortunes, to either dogs, exhibitors or patrons.
4. **Obedience Rules & Regulations. Chapter 20.7, It shall be the duty and obligation of the trial-giving club to see that a judge, club official, ring steward, volunteer, or competitor at an Obedience or Rally Trial held under these regulations, is not subject to indignities of any kind. The Trial Committee Chair shall promptly report to the CKC**

any infringement of this regulation, and the CKC shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.

5. **BITCHES IN SEASON** are not permitted to compete. When a bitch comes into season after entries close, a Veterinarian's certificate, certifying that the bitch was in season within ten days of the trial, must reach the Trial Secretary on or before the day of the trial, prior to the judging of the class, and the club will refund the entry fees.
6. **CKC Non-membership participation fee** – i) A non-member participation fee for awards and titles will be charged to a Canadian non-member of CKC. ii) The non-member participation fee is paid in any year a title is earned and covers all titles and dogs owned by that individual. iii) In order for titles to be awarded, the non-member will have a choice to either become a CKC member or pay the non-member participation fee. Failure to comply within 30 days of notification will result in the title being withheld and the dog cannot be moved up to the next level. iv) All Premium Lists will carry a note stating that these fees apply only to dogs wholly owned by non-member residents of Canada and are not applicable to CKC members.
7. **Mix Breeds and Unrecognized Breeds** must have a Canine Companion Number (CCN) from the CKC to enter the trials.
8. If, because of riot, civil disturbance, or other acts beyond the control of management, it is impossible to open or complete the trials, no refund of Entry Fees will be made.

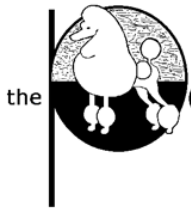


Directions from London:

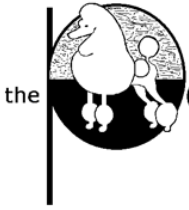
