PARKING

Golden Reins has requested that we do not park in areas where horses, and trailers, may be moving. This includes the area along the fields adjacent to the arena (right hand side – where gat openings are) and the area directly in front of the big house – the obvious circle turn-around.

Parking is anywhere between the arena and the barn that faces the arena, and anywhere up against the arena itself (sides and back). We will have no-parking signs in the critical areas!

DIRECTIONS TO THE AGILITY TRIAL.

Driving From Fredericton/St. John way: Take exit into Salisbury (SALISBURY BIG STOP exit), turn right at top of exit ramp. Heading into Salisbury, go to end of that road, turn right. Take the first road to the left, RIVERROAD, you will go past the school, and over the Pedicodiac River BRIDGE. About 500 feet past the bridge, you will see the Golden Reins Equestrian Center on your left. We will also have a sign marker at the end of the driveway.

Driving From Moncton way: Take exit into Salisbury (SALISBURY BIG STOP exit), turn left at top of exit ramp. Follow directions as above.
