

### **CKC RULES EFFECTIVE JANUARY 1, 2010**

8.2.5—An error in the age specified class, date of birth or sex of the dog may be amended on the entry form up to ONE hour before to the start of the show.

8.5.8—In case of a judge change (substitute or overload) an exhibitor may enter a dog under the replacement judge providing that the dog is entered in one of the regular classes of a show being held at the same venue by the same club and has been assigned a competition number. A new entry, along with accompanying fees will be accepted by the Show Secretary up to ONE hour PRIOR to the start of the show (see section 3.3.1, 3.5.1, 8.5.4) 8.9.3—When one or more all-breed and /or Specialty shows are held on the same day, in the same venue, the request for moving of class dogs to specials MUST be made a minimum of one hour prior to the scheduled start of the show for which the dog is being moved up to.

12.3.f—A puppy awarded Best Puppy In Breed is NOT required to stay to compete for Best Puppy in Group.

### NOTICE TO U.S. EXHIBITORS RE: ERN NUMBERS

Effective January 1, 1992; dogs that are foreign born and foreign-owned and enter Canada for the sole purpose of entering CKC events will no longer require a CKC registration number but will require an Event Registration Number (ERN). This ERN does not register a dog with the CKC for breeding purposes as defined in the Animal Pedigree Act but rather enables a foreign-born and foreign-owned dog to be awarded titles by the Canadian Kennel Club. Each dog must have its own number. This Event Registration Number must be applied for within 30 days of the first day of entering a CKC event. Please forward your request to: The Canadian Kennel Club, Shows and Trials Division, Suite 400 - 200 Ronson Dr, Etobicoke, Ontario, M9W 5Z9.

Tendering of a dishonored cheque or declined credit card in payment of an entry fee shall be considered non-payment of entry fees and is an offense punishable by disciplinary action and cancellation of awards. (Chapter 13, Section 7.2, CKC Dog Show Rules). Any dishonored cheque or declined credit card(s) will be assessed a \$25.00 service charge. The owner of a dog entered in this show is entirely responsible for any error in the entering of his dog, regardless of how, or by whom the entry was made.

Cheques post-dated to closing date WILL be accepted.

EXHIBITORS PLEASE NOTE: Withdrawal of entries prior to closing may be made by telephone, but MUST BE FOLLOWED UP <u>IN WRITING</u>, and be received by the Show Secretary <u>no later than the official closing</u>. If written, or electronic notification is not received, the dog will remain entered in the show.

<u>IN THE EVENT OF A POSTAL STRIKE</u>: Telephone entries may be made in accordance with the CKC Dog Show Rules. Telephone: 1-403-264-9559 Collect calls will not be accepted. ### CANADIAN KENNEL CLUB - SCHEDULE OF CHAMPIONSHIP POINTS

### Chapter 20 – Champions and Championship points

SECTION 1 A dog awarded winners at a Championship Show held under these Dog Show Rules shall be credited with a number of championship points (ranging from 1 to 5) and the determinator of the number of championship points to be credited to a dog awarded Winners shall be as provided hereunder.

SECTION 2: The schedule to be employed in the determination of the number of points to be allocated a dog awarded Winners shall be as follows:

Dogs competing *	1	2	3 to 5	6 to 9	10 to 12	13+
Points Allocated	0	1	2	3	4	5

To determine the number of championship points by a dog awarded Winners, total all the dogs in competition which the dog defeated, directly or indirectly, for the highest of the following official breed awards: Winners, Best of Winners, Best of Breed or Best of Opposite Sex, and then consult the schedule set forth above. In counting the number of eligible dogs in competition, a dog that is disqualified, dismissed, excused or ordered from the ring by the judge shall NOT be included in the calculation for championship points. This system provides for additional points if a dog awarded Winners also placed in the Group as listed below:

Breeds competing	Dog Placed	Dog Placed	Dog Placed	Dog Placed
At Group Level	First	Second	Third	Fourth
13 or more breeds	5	4	3	2
10 to 12 breeds	4	3	2	1
6 to 9 breeds	3	2	1	1
less than 6 breeds	2	1	1	1

A class dog awarded Best in Show at an all-breed championship show will be credited with five points inclusive of any points earned at the breed or group level. In no case may a dog earn more than five points at a single show. A dog must earn at least one 2-point win either at the breed or group level to be awarded championship status.

Best Puppy in Breed: A puppy awarded Best Puppy in Breed is NOT required to stay to compete for Best Puppy in Group

### SHOW RULES AND GENERAL INFORMATION

- 1. Showing correct information on entry forms is the responsibility of the entrant. The show committee reserves the right to refuse any entry subject to CKC rules. Entry forms must be the same size and format as those included or they will be rejected.
- 2. No entry will be accepted unless accompanied by entry fees paid in full. Telephone entries will not be accepted. Fax entries will be accepted. See instructions elsewhere in this premium list.
- 3. Post dated cheques are not acceptable. Tendering of an N.S.F. cheque in payment of entry fees shall be considered non-payment of entry fees and is an offence punishable by disciplinary action and cancellation of awards. A \$25.00 service charge will be levied on all N.S.F. cheques.
- 4. Withdrawal of entries prior to closing date may be made by telephone, but MUST BE FOLLOWED UP IN WRITING to the Show Secretary so as to be received not more than 7 days after closing. Entry fees will not be refunded in the event that a dog is absent, sick, lame, excused by the veterinarian or judge, in season or barred from competition because it has been entered incorrectly.
- 5. The entry of any dog cannot be altered or cancelled after entries close, except as provided in the Dog Show Rules.
- 6. After the closing of entries, an identification/receipt and judging schedule will be mailed to each exhibitor or agent. Owners making entries please include agent's address.
