# **ERN - EVENT REGISTRATION NUMBER**

Effective Jan 1, 1992, all dogs that are foreign born and foreign owned and enter Canada for the sole purpose of entering CKC events, will no longer require a CKC registration number but will require an Event Registration Number (ERN). The ERN number *must* be applied for within 30 days of the first day of entering a CKC event. To obtain an ERN, mail or fax a photocopy of the dog's foreign registration certificate with cheque or Visa/MasterCard number (expiry date, cardholder's name and signature). Fee is \$58.85 per dog. ### **GENERAL INFORMATION**

1. The Show Superintendent will be in complete charge of the show, which is governed by CKC rules.

2. Entries received without fee will not be accepted. Acknowledgement of entries with a judging schedule will be made as soon as possible after closing date. No entry will be accepted unless all particulars called for on the entry form, are shown thereon. Telephone entries cannot be accepted in the case of a postal disruption.

3. Make all cheques/money orders payable to Algoma Dog Fanciers. The Club and its members will assume no responsibility for cash sent through the mail.

4. Returned cheques do not constitute a valid entry fee. A collection of \$20.00 will be added by Algoma Dog Fanciers in addition to any bank charges, for each returned cheque. NO REFUND for duplicate entries. Every effort will be made to find all duplicate entries, however if entry has been processed and appears in the official catalog, no refund will be made.

5. Exhibitors must abide by errors made in entering their dogs, regardless of how or by whom the entries were made. Change or cancellation of any entry after closing day and time is prohibited. The Club reserves the right to refuse any entry, subject to C.K.C. rules.

6. Entry fees shall not be refunded in the event that a dog is absent, excused by a Veterinarian or Judge, disqualified or barred from competition by the action of the bench Committee. If because of riots, civil disturbances, or other acts beyond the control of management, it is impossible to open or complete the show, no refund of entry will be made.

7. The show giving Club will use due care and diligence for the welfare of dogs and exhibitors but will not be responsible for or assume any liability in the event of an accident, or other misfortune, to either dogs, exhibitors or patrons.

8. Dogs may arrive any time prior to their scheduled time of judging. Dogs not required for further judging will be excused. Judges will not wait for any dog holding up a class. Owners/agents alone are responsible for the presence of their dogs when their classes are called to be judged.

8. Exhibitors are requested to keep their grooming and crating areas clean and tidy. If space is at a premium, exhibitors must remove exercise pens if requested by the Show Superintendent.

#### **CHAMPIONS & CHAMPIONSHIP POINTS**

SECTION 1: A dog awarded WINNERS of a championship show held under these Dog Show Rules shall be credited with a number of championship points (ranging from 0 to 5) and the determination of the number of championship points to be credited to a dog awarded WINNERS shall be as provided hereunder.

SECTION 2: The schedule to be employed in the determination of the number of points to be allocated a dog awarded WINNERS shall be as follows:

To determine the numbers of championship points earned by a dog awarded WINNERS total all the dogs in competition which the dog defeated, directly or indirectly, for the highest of the following official breed awards: Winners, Best of Winners, Best of Breed or Best of Opposite Sex, and then consult the schedule set forth above. The new system provides for additional points (provided that the dog has defeated another as listed bereunder):

A class dog awarded Best in Show at an all-breed championship show will be credited with five points inclusive of any points earned at the breed or group level. In no case may a dog earn more than five points at any single show.
