CKC Obedience rule 8.6.2-“Judges are not required to wait for dogs. It is the responsibility of each handler to be ready with his dog at ringside when required, without waiting to be called.”

CKC Rally Obedience rule 4.3.3 – “Maximum 20 dogs per hour and after each 2 hour group of dogs, the judge will allow a 10 minute walk thru for the next 2 hour block of dogs. Classes will not start before posted times.”
