#### DIRECTIONS



#### From Toronto or From the East:

Exit the HWY 401 westbound to the HWY 410 and go north. Take the extension that connects to HWY 10 north. Continue until you reach King St. Turn left. Stay on King St. into Terra Cotta. At the stop sign in Terra Cotta go straight through, staying on King St. After the bend in the road to the left you are now on Winston Churchill Blvd. You will cross the bridge over the Credit River and continue up the hill. Just past the top of hill you will see #12900 on your right. If you reach the 80 km speed limit sign you have passed our driveway.

#### From West:



Take HWY 401 east to Trafalgar Rd (exit #328 from 401) and go north about 6.5 km to the 10th Side Rd. Turn right and continue to Norval. Turn left at light onto Winston Churchill (also called Adamson St at this point) and keep going until you reach #12900, which is on your left.

#### From Niagara:

If you take the QEW east to Bronte Rd (HWY # 25 Milton), and travel north to Britannia Rd., turn right at the light. Continue to Trafalgar Rd and turn left (north). Once you pass over the HWY 401 follow the directions 'Coming from West'. OR take HWY 407 east to HWY 401 East exit and then exit the 401 at Winston Churchill Blvd. and travel north to #12900.

**NOTE:** The house numbers on the left and right sides of Winston Churchill do not follow numeric order, so look at the numbers on the west side!

#### **Tentative Running Order**

Trial 1 Instinct begins at 9:00 am followed by Novice thru to Master

Lunch Break 12 noon to 1 pm

Trial 2 Novice begins at 1:00 pm followed by Open to Master

Dogs may enter both the Instinct class and Novice class in the same trial untl the dog has earned the RATN title and they then they can no longer enter the Instince class







**HEIGHT DIVISIONS:** Dogs are divided into groups by the their shoulder height.

Small 13" and under Medium 13.1" to 18" Large over 18"

#### **Judging Order**

Dogs will be run in height order, with dogs being handled by the same person separated into different staged groups. The order of testing in a class shall be from small to large, except when multiple entries of the same handler require separation when possible. Dogs will be staged in groups of 5.

#### **Move Ups**

Dogs earning a title in Trial 1 may be moved up to the next class for the second trial. This up to the handler and not required. Move-ups will be accepted up unto 10 minutes after the conclusion of the relevant Trial 1 class.

Move-up forms will be available at the secretary's table

#### **Awards**

Placement ribbons will be awarded for first through fourth place in Novice, Open, Senior and Master classes in each hieght division. Ribbons will be awarded for all qualifiers in the regular classes and Instinct. Dogs that earn a Barn Hunt title RATN or higher will receive a title resette. High in class ribbons will be offered in Novice, Open, Senior and Master. Other prizes may be offered.

#### **GENERAL INFORMATION AND EVENT RULES can't**

**VALIDATION OF ENTRIES:** Entries must be complete, with entry fees, and signed Participation Agreement included. Entries submitted without this agreement filled in and signed will be refused participation in the tests and workshop.

**REFUND OF ENTRY FEES:** Will not be refunded after the closing date except for bitches in heat and for injured dogs with vet proof.

#### **EVENT SITE:**

The trials will be held outdoors on grass with an outdoor staging/blind area.

Willowbrae is wheelchair accessible.

Port-a-Potty will be on site but not wheelchair accessible.

Bring water, shade and shelter for you and your dogs (E-z Up tent or X-pen).

These trials will be run rain or shine.

Wear appropriate footwear and clothing for the outdoors.

Mosquito and Black Fly repellent.



All dogs must be under control and on a leash at all times, except during the test. Please make sure your crate is secure as the dogs may be highly excited.

All dogs must be under control while on trial grounds except while showing.

Use approved collars only. Dogs MUST run "naked" in the ring. It is strongly encouraged that the collar/harness be of a type that can be easily and quickly removed and replaced in the ring.

#### No flexi leashes are permitted anywhere on the property

**DOG AGGRESSION:** Any dog behaving in a threatening or aggressive manner toward another dog or a person may be dismissed from the trial if justification is found to do so by the judge and/or trial committee.

**BITCHES IN SEASONS:** Bitches in season are eligible for entry, but will be required to be kept separate from all other dogs and will run at the end of their class/test. Please inform the test secretary prior to the Test and inform all exhibitors at the judge's briefing that you are bringing a bitch in heat. Owners of BIS should crate/confine their dogs away from traffic and other dogs, should post "dog in season" signs on their crate/in their area, and potty the dog away from other competitors. Bitches in season MUST wear pants. Entry fees for bitches that come into season will be refunded with veterinary certificate, if you wish to withdraw.

**FOOD:** Morning coffee will be available both days

Lunches - Please arrange your own lunch for both days Fast food restaurants are 10 mins away in Georgetown
