Classifications

The following classes (divided by sex) are offered:

All regular classes as indicated in the Lakehead Kennel Club Premium List:
(i.e. Junior Puppy, Senior Puppy, Bred By, Canadian Bred, Open, Specials) & Exhibition Only

Plus

12 –18 Months 12 Months but under 18 months on the day of the show.
Veterans Class For dogs seven (7) years of age and over on the day of the show. (Dogs entered in this class may be neutered/spayed)
Altered Classes All dogs over 6 months of age which have been sexually altered by veterinary procedure.

Non-Regular Classes

****All dogs entered in the non-regular classes must be entered in a regular class in the specialty or in Exhibition Only. Dogs may be neutered/spayed.**

Judge: Tom Touzel

Brace: Two dogs shown on a single lead. **Ownership does NOT have to be identical.**
Team: Four dogs shown on a single lead. **Ownership does NOT have to be identical.**
Stud Dog: A dog and at least two of his get. (Breeders/Owners **need NOT** be identical)
Brood Bitch: A bitch and at least two of her progeny. (Breeders/Owners **need NOT** be identical)

Sled Dog Classes:

***** For all purebred registered Siberian Huskies **All dogs entered in the non-regular classes must be entered in a regular class in the specialty or in Exhibition Only. Dogs may be neutered/spayed.**

Judge:

Class A: For dogs with any level of "Sled Dog" titles
(SD;SDX;SDU – Canadian and American titles accepted)
Class B: For dogs who have completed a publicized race* greater than 20km.
Class C: For dogs who have completed a publicized race* less than 20km.
(NB: Class B & C entries will require a copy of documentation signed by race official.)

The winners of each sled dog class will compete for Best Overall Sled Dog, and The Henry Csabak Memorial Trophy.

* publicized race means any race that has been announced in a recognized magazine/newsletter or website, such as Sleddog Central, Team & Trail etc.

Junior Handling

A regular junior handling competition will be held in conjunction with the specialty.
Juniors **MUST** handle a Siberian Husky.

Trophies and rosettes will be offered as follows;

Best of Breed; Best of Opposite Sex; Best of Winners; Winners Male & Female; Reserve Male And Female; Best Puppy; Best of Breed (Altered); Best of Opposite Sex (Altered) ; Best Brace; Best Team; Best Brood Bitch; Best Stud Dog; Best Sled Dog; Best Junior Handler & Reserve. An AWARD OF MERIT rosette and trophy is offered. (one AWARD of MERIT for every ten (10) dogs competing for Best of Breed)
