PARTICIPATION WAIVER AND RELEASE

In consideration of the acceptance of this entry by the **Central Okanagan Dog Agility Club (the "Organizing Club")** and the opportunity to have the Dog participate, compete in this event or trial, I, the undersigned, agree as follows:

1. I certify that I am the actual owner of the Dog, or that I am the duly authorized agent of the actual owner of the Dog and that the Dog is not a hazard to persons, property or other dogs.
2. I agree that when not working, the Dog must be secured in an ex-pen or crate in good repair. Failure to comply will result in dismissal from the event with no refund.
3. I agree that the Organizing Club for the Event may refuse my entry for any reason that it deems to be sufficient.
4. I understand and acknowledge that participation in the Event carries certain risks, including, but not limited to injuries (including serious injuries and death) to myself, the Dog, and any dog under my control or persons attending as my guests (my "Related Parties"), damage to property and other losses. I waive any and all claims that I have or may have in the future against, and release from all liability and agree not to sue the Organizing Club or any of the directors, executives, committees, representatives, employees, volunteers or agents of the Organizing Club (the "Personnel") for any injury, death, property damage or other loss that I or my Related Parties sustain due to any cause whatsoever, including negligence, breach of contract, breach of duty, statutory or otherwise, or mistakes or errors of judgment of any kind.
5. I assume full responsibility for the conduct of myself and my Related Parties during the entirety of the Event. I agree to indemnify and save harmless the Organizing Club and the Personnel from and against any and all claims that may be made against them or costs, fees, expenses or liability (including, without limitations, lawyers' fees on a solicitor and own client basis) incurred by the Organizing Club or the Personnel that may arise due to:
 - a. any act or omission of myself, my Related Parties or any party for whom I am liable at law; or
 - b. aggressive behaviour by the Dog or any other dog under my control; and
6. I understand that the Organizing Club may, in the course of administering the Event or conducting its activities generally, collect, use or disclose my personal information and that any personal information collected, used or disclosed by the Organizing Club will be treated in accordance with AAC policy and applicable privacy and personal information laws. I hereby consent to the collections, use and disclosure by the Organizing Club of my personal information.
7. I have been given the opportunity to read and understand the terms of this Agreement before signing it, and have in fact done so. I understand that by signing this Agreement, I am restricting my legal rights and I sign this Agreement voluntarily and of my own free will.
