General Information

The Pictou County Kennel Club will use care and diligence for the safety and welfare of the dogs and exhibitors but will not be responsible in the event of any accident to dogs, exhibitors or spectators.

Handlers and exhibitors with several breeds must arrange for alternative handlers should judging times of different breeds conflict.

The superintendent will be in complete charge of these shows and trials.

Due to the limited amount of space, the superintendent may be required to control the number of and/or area taken up by x-pens. All exhibitors are required to co-operate with the superintendent in this regard.

It shall be the duty and obligation of the show-giving club to see that a judge, club official, volunteer, or any participant at an event held under these rules is not subject to indignities. The Conformation Show Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it

deems fit on receipt of a report indicating that this has occurred. (Conformation Show Rules Sec. 19.7)

Only dogs entered in the Shows & Trials will be permitted on the show premises.

Only a dog individually registered, or eligible to be registered, in the stud book of the Canadian Kennel Club may compete in these shows and trials.

Champions and championship points - chapter 15

Section 1 - a dog awarded winners at a championship show held under these rules shall be credited with a number of championship points (ranging 0-5), and the determination of the number of championship points to be credited to the dog awarded winners shall be as provided hereunder:

Section 2:

Dogs competing 3-5 6-9 10-12 13 or more Points allocated 0 4 5

* includes the dog awarded winners

The system provides for additional points if the dog awarded winners also places in the group.

A class dog awarded best in show at an all breed championship show will be credited with five points inclusive of any points won at the breed or group level. In no case may a dog earn more than five points at a single show.

In order for a dog to be recognized as a Champion and its owner provided with a Championship certificate, the dog must:

- (a) earn at least 10 championship points under at least 3 different judges; &
- (b) be individually registered in the records of the CKC or have an Event Registration Number; &
- (c) have earned at least one 2 point win at either the breed or group level.
