I further agree not to make any claim or claims against anyone that may make a claim for contribution and indemnity against NO CHICKEN RANCH, its partners, officer, directors, employees, agents, contractors, insurers and/or landlords, and each of their successors and assigns.

If the livestock or animal is maimed beyond help by a veterinary, then I agree to pay the full market value of the said livestock or animal that was maimed at the time of death.
3. I understand that this agreement extends forever into the future and will have full force and legal effect each and every time I participate or my Dog participates in lessons/boarding at NO CHICKEN RANCH.
