

# HALIFAX KENNEL CLUB JUDGING SCHEDULE

February 12 & 13, 2011

EXHIBITION PARK

200 Prospect Road - Highway 333 - Halifax - Nova Scotia

- > Judging will start promptly and adhere as closely as possible to this schedule.
- Handlers of several different breeds <u>must</u> arrange for alternate handlers, should judging of their different Breeds conflict. Schedule changes will not be made.
- It is the responsibility of the exhibitor to be at ringside when their classes are called. It is not the responsibility of the ring steward to locate dogs. Judges will not wait for any dog or handler delaying a class.
- The figures following the Breeds indicate the number of dogs entered in (1) Male Classes, (2) Female Classes, (3) Specials Only, Male & Female, (4) Total in Breed and (5) Exhibition Only.
- Time for Conformation Judging is based on 20 25 dogs per hour. Obedience Judging is based on: Utility 6 dogs/hour, Open 7 dogs/hour, Novice A, B, C & Intermediate 8 dogs/hour & Pre-Novice 9 dogs/hour. Rally judging is based on 20 dogs/hour plus 10 min walk through time.
- > Group judging will follow **immediately** upon completion of the breed judging within each group.
- > An In Transit area will be provided. Contact Show Superintendent for the location.
- It shall be the duty and obligation of the show-giving club to see that a judge, club official, volunteer, or any participant at an event held under these rules is not subject to indignities. The Conformation Show Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred. (Section 19.7 Dog Show Rules)

CLEANUP: All exhibitors will be held responsible for clean-up on the show site and surrounding areas for their own dogs or dogs they are handling. Anyone caught not cleaning up after their dogs WILL BE PROHIBITED FROM SHOWING OR TRIALING their dog or dogs at this event.

### NON-MEMBER PARTICIPATION FEE

An annual "Non-member" participation fee for Awards and Titles will be charged to a Canadian "non member" of the Canadian Kennel Club. This fee will match the fee charged for Event Registration Number.


