“It shall be the duty and obligation of the trial-giving club to see that a judge, club official, volunteer or any participant at an event held under these rules is not subject to indignities of any kind. The Field Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.”

OFFICIAL CLASS

OPEN/MIXED – For all eligible hounds including Field Champions.

UNOFFICIAL CLASSES

VETERAN, KENNEL & SINGLES – Veteran (a hound exceeding the age of seven years), Kennel (two hounds entered in the regular stakes owned & kennelled by the same person). Singles shall be limited to 15.

ENTRY & CKC FEES

Make all cheques payable to Johanna Granger

OPEN/MIXED - \$20.00 for the first hound, and \$16.00 for each hound thereafter of the SAME owner to a maximum of \$60.00.

LISTING FEES - \$9.50 per hound per event for hounds not registered but eligible to be registered with the CKC.

SINGLES – as per Open stake fees.

VETERAN & KENNEL – as per Open stake fees.

Veteran is the top scoring veteran from the Open/Mixed Stake.

Kennel is the top two scoring hounds of the SAME kennel. Check the box on the entry form when submitting the entry.

THERE WILL BE NO PRACTICE OR CERTIFICATION RUNS BEFORE OR AFTER THE TRIAL.

ELIGIBILITY TO COMPETE

Only Afghan Hounds, Basenjis, Borzois, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhound, Pharaoh Hounds, Salukis, Scottish Deerhounds and Whippets that are registered with/capable of being registered with the CKC or have a Performance Event Number (PEN) or have an Event Registration Number (ERN) may take part in the trials. Any hound declared ineligible or disqualified in any lure coursing field trial held under other jurisdictions is ineligible to course. Any hound excused for aggression in any CKC event is ineligible to compete.

EQUIPMENT

A drag or continuous lure system shall be used. Field conditions on the day will determine which system is used. The lure shall be plastic attached to the line. Back-up equipment is available.

Handlers **MUST** use slip leads (no metal leads or slips allowed) when releasing hounds for each course. Hounds shall wear blankets/coverings of **HIGH** intensity yellow, pink or blue depending on the colour drawn for the hound. Hounds sporting other than the approved colours will not be allowed to partake. Muzzles without sharp or hard edges and that allow the dog to breath freely may be used. Leg wraps of neutral (not yellow, pink or blue) colour are allowed.

Catch collars may be worn by running hounds. Catch collars must be of neutral colour and will **NOT** have **ANY** loops, tags or ornaments that might snag or catch on anything. Electronic collars, according to CKC BOD & CKC rules, are not considered catch collars.

POINTS & AWARDS

POINTS

1ST Place 4 x the number of hounds competing in the stake
maximum of 40 pts per stake winner/BOB

2nd Place 3 x the number of hounds competing in the stake
maximum of 30 points

3rd Place 2 x the number of hounds competing in the stake
maximum of 20 points

4th Place 1 x the number of hounds competing in the stake
maximum of 10 points

Next Best Qualified Dog (NBQ) No points

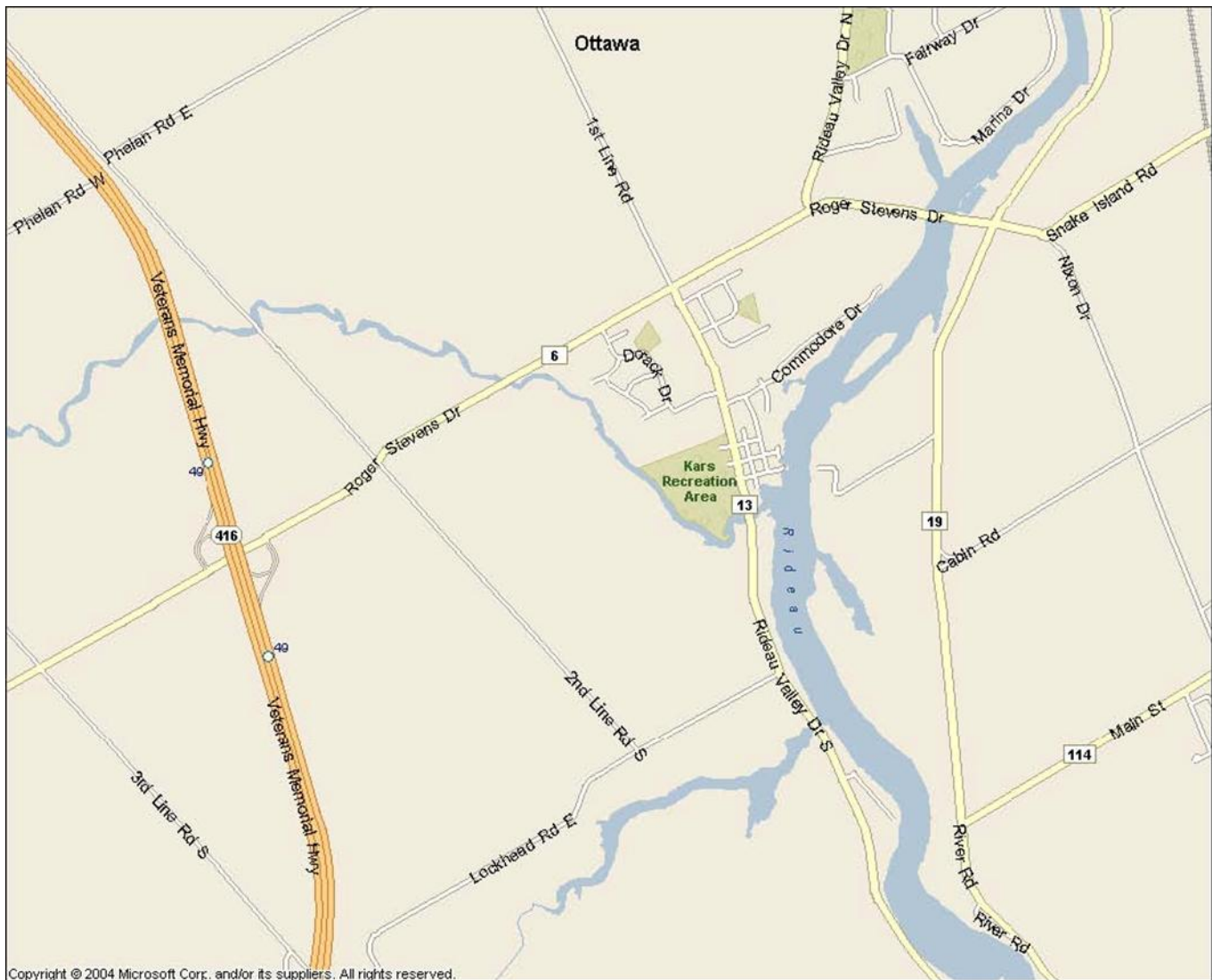

Prizes shall be awarded to all BOB hounds, Veteran & Kennel Stake winners and Singles 1st to NBQ.

ADDITIONAL INFORMATION

- Camping is available on site. A charge of \$15/night shall be collected. Electrical and water may be available.
- Electronic collars and Flexi-Leads are not allowed on the Kars RA grounds.
- Limited shade available.
- Water may not be available. Bring enough for your hounds.
- \$10.00 fine for any hound running loose during a course.
- \$10.00 fine for failing to pick-up after your hounds on the Kars RA grounds.
- Failure to pay fines shall result in expulsion from the trial & the Kars RA grounds.
- **Please be aware that there is a special fee charged to Canadian residents who are not members of the CKC when their hound earns the requirements for a CKC title.**
- **Failure to *complete* and enclose the Participant Waiver with your entries will be considered as incomplete entries and the entry will NOT be accepted.**
- American Exhibitors – Canadian banks will NOT accept cheques marked “payable in Canadian funds.” If you pay by cheque it must be for the full amount in US dollars. Use Money Orders or Bank Drafts payable in Canadian funds.



DIRECTIONS

FROM TORONTO

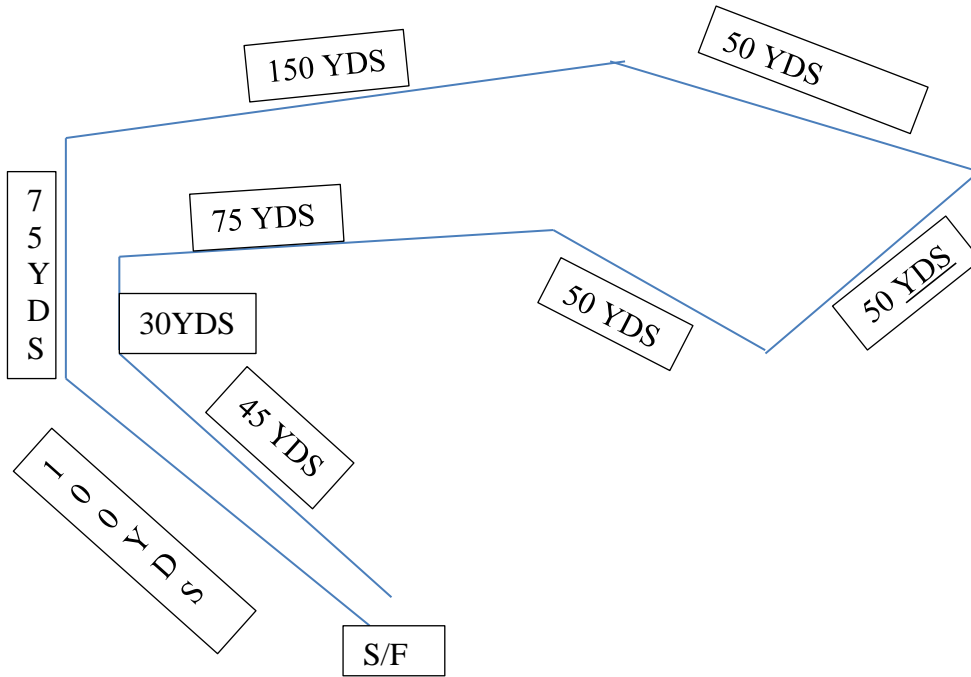
- Take the 401 East to the 416 north exit, direction Ottawa. Proceed north on the 416 until you come to the Kars turn-off. Bear east/right when exiting the 416 and head east on County Road 6. Proceed to the stop sign with the flashing light (approx 3 km). At the stop sign turn right onto Rideau Valley Drive. Proceed to the Kars Recreational Area (approx 2 km south). The entrance to the site is directly across from Old Wellington Street. If you pass the Kars General Store you've gone too far.

FROM MONTREAL

- If you take the 401 proceed to Hwy 416 N and then, as per the directions from Toronto.
- If you take the 417 proceed west until you see the junction for the 416. Head south on the 416 until you reach the Kars exit. Bear left onto County Road 6 toward Kars and follow the directions above.
