GENERAL INFORMATION & SHOW REGULATIONS

- The show building will be open Thursday evening from 6 pm to 10 pm, and at 7 am until 11 pm each day of the show.
- All entries must be complete, including the full name & address of the owner of the dog. The Show Committee reserves the right to refuse any entry subject to CKC rules. Exhibitors must abide by errors made in entering their dogs, **regardless of how and by whom entries were made.** Changes or cancellations after closing date are prohibited except according to CKC rules.
- An exhibitor entering puppies 3 to 6 months of age may not enter more than two of that age.
- No refund of entry fee will be made** if, because of riot, civil disturbance, or other acts beyond the control of the Wheat City Kennel Club, it is impossible to open or complete the show.
- The Wheat City Kennel Club will use due care & diligence to ensure the welfare and safety of dogs and exhibitors but will not be responsible for, nor assume any liability in the event of an accident or other misfortune to dogs, exhibitors, or spectators. **PLEASE NOTE:** Dogs left in the building at owners' risk. There will be **no watchman** hired by WCKC on duty at night in the show and kennel area.
- Dogs must be in the show building at least one hour prior to the judging of their breed. It is the responsibility of exhibitors to have their dog(s) at ringside when required for judging. Dogs not required for further judging may be excused. **ONLY DOGS ENTERED IN THE SHOW/TRIAL ARE ALLOWED IN THE BUILDING.**
- The Show Superintendent will be in full charge of the shows and trials.
- Wheat City Kennel Club is **not** be responsible for contracts made with the show photographer
- Exhibitors **must exercise their dogs in the designated areas provided.** Exhibitors are responsible for cleaning up after their dogs. **No private exercise pens will be allowed without permission from the show superintendent**

CHAMPIONS & CHAMPIONSHIP POINTS

SECTION 1 - A dog awarded Winners at a championship show held under the Dog Show Rules shall be credited with a number of championship points (ranging from 0-5) and the determination of the number of championship points to be credited to a dog awarded Winners shall be as provided hereunder.

SECTION 2 - The schedule to be employed in the determining of the number of points to be allocated a dog awarded WINNERS shall be as follows

*Dogs Competing	1	2	3-5	6-9	10-12	13 or more
Points Allocated	0	1	2	3	4	5

* Includes the dog awarded Winners. In counting the number of eligible dogs in competition, a dog that is disqualified, dismissed, excused or ordered from the ring by the judge SHALL be included in the calculation for championship points

NOTE: In order for a dog to be recognized as a Champion, and its owner provided with a championship certificate, the dog must:

- a) earn at least 10 championship points under at least 3 different judges
- b) be individually registered in the records of the CKC or have an Event Registration Number
- c) have earned at least one 2 point win either at the breed or group level

The new system provides for additional points if a dog awarded WINNERS also places in the GROUP as listed below: (Note: A dog may not be credited with more than a total of 5 points in a single show) Breeds Competing at Group Level	Dog Placement

Where a dog awarded Best of Breed is not a puppy, those puppies which have not been defeated either directly or indirectly by another puppy in the breed will compete for the Best Puppy In Breed award. Judging follows the awarding of Best of Breed. **A puppy awarded Best Puppy In Breed is not required to stay to compete for Best Puppy In Group. HOWEVER: This only applies where the Best Puppy in Breed is not also the winner of the Best of Breed award. If the Best Puppy in Breed is also the Best of Breed winner, the dog *must* stay for the Group Judging or risk losing any points it might have won in the breed competition.**
