**Note:** A listing fee as established by The Canadian Kennel Club must accompany the entry of a dog for which a Canadian Kennel Club individual registration number, Event Registration Number (ERN), Performance Event Number (PEN) or Miscellaneous Certification Number (MCN) is not shown on the entry form.

### ENTRIES

Dogs must be at least 6 months of age to be entered. Entries are limited to the number of dogs able to run during daylight hours and may be limited for brace categories. No entry shall be accepted from any person who is not in good standing with the CKC on the day of the closing of entries.

Entries close midnight Wed. May 9, 2018. If your dog has twice qualified with any of our Judges, notify the Test Secretary before the drawing time. Entrants are responsible for confirming receipt of their entries.

### LATE ENTRIES

Late entries are limited to FDJ and FD classes. There is no guarantee they will be accepted. If accepted, they constitute a legal commitment to pay and cannot be withdrawn or refunded. Online form for late entries will be disabled 6 PM Friday May 11<sup>th</sup> after which paper

entries must be used (see Late Entry form on page 5) and reach the Test Secretary no later than 7:30 AM on the day of the test.

### CANCELLATIONS & REFUNDS

Cancellations must be in writing and received before closing for full refund. No refunds after closing and for bitches which come into season after closing except for bitches entered in FDJ class only which can run at the end of the day.

### NON-PAYMENT OR DISHONoured PAYMENT

Payment must be made in full and accompany the entry form. The VSO reserves the right to refuse entries from persons who have failed to pay entry fees in full at prior tests. Tendering of a dishonored cheque or declined credit card shall be considered non-payment of entry fees and is an offense punishable by disciplinary action and cancellation of awards. Postdated cheques are not acceptable tender.

## MORE INFORMATION

**Start time:** 8:00 AM

**Running Order:** FDX / FDXCh followed by FDA, FD and FDJ.

**Course and Game:** FDJ, FD, and FDA will be a single course with bird field. FDX and FDXCh will be a single course.

FDX/CH, FDX and FDA dogs will be run in braces or individually where applicable with a bye dog for backing.

**Birds:** Chukars will be used in all categories. Dead Chukars will be used in the FDX/FDXCh water retrieve.

**Gunning:** Done by official gunners only. All handlers must carry a starter pistol.

**Safety Gear:** All entrants, judges, gunners, volunteers and spectators who enter or are physically present on the test course, must wear blaze orange clothing and blaze orange head gear in any test where shotguns are used. (Clause 11.3 of CKC *Field Dog Test Rules and Regulations for Pointing Dogs*.)

**Indemnity & Waiver:** All participants are required to sign the attached VSO waiver on page 6 either in advance of or at the test. Any spectator wishing to accompany and view a running dog in the test course must also sign a waiver and wear safety gear as outlined above.

**Immunization:** All dogs must have current immunization status before being entered.

**Other:** If a dog is not present at its starting point within 5 minutes after it is called for by the judges, it may be disqualified. No training or running of dogs on the grounds before and during the tests. We highly recommend tick prevention be used on dogs, handlers, spectators and volunteers.

**Bitches in season:** are permitted ONLY in FDJ and will be run at the end of the day.

**Meals and Refreshments:** Morning coffee and lunch will be available both days for a nominal fee to entrants. Judges and volunteers will be fed first.

### DRAWING & RUNNING ORDER

**Draw:** Running order draw will take place at the home of Test Secretary in Moffat ON, 905-691-8706 on Thursday May 10th at 10:00 AM. Specific times cannot be guaranteed.

**Running Order:** A running order will be e-mailed to all entrants who provide an e-mail address.

### MOVE-UPS

Move-ups to the next level must be done in writing to the Test Secretary prior to commencement of the tests or by the end of the judging on May 13<sup>th</sup> for the next day's tests.

### GOOD SPORTSMANSHIP

All who attend our tests, in any capacity, are expected to conduct themselves in a manner which reflects credit to

themselves, their dogs and the sport of purebred dogs, regardless of circumstance and location. Under Section 7 of the CKC Field Dog Test Rules and Regulations for Pointing Dogs, the Test Committee as well as Judges have the authority to expel any individual who, in their assessment, displays unsportsmanlike behaviour.

- ❖ Standard CKC Blue Ribbons to dogs with qualifying scores.
- ❖ New Title Rosette to each dog completing the requirements for a title (these will not be mailed so please notify the Test Secretary at the time of the announcement of scores).
- ❖ Rosettes to each Jr. Handler (18 yr. and under) whose dog has received a qualifying score. These will not be mailed. Please identify if a Jr. Handler is running a dog on the entry form.
