# **Aspen Grove Sighthound Association**

STRAIGHT RACE MEET – 200 YARDS SUNDAY June 28, 2015 11 AM Held in Okotoks Alberta.

#### RACE HOUND ELIGIBILITY

- OPEN to Afghan hounds, Azawakh, Greyhounds, Italian Greyhounds, Whippets
- ALL HOUNDS MUST BE PRE-CERTIFIED PRIOR TO ENTERING THEIR FIRST CARA RACE MEET. (See exemptions on page 5)
- Hounds must be one year of age or older to be eligible to race.
- All hounds must be individually registered with the CKC, AKC, or any similar registry, or possess a CKC PEN number.
- All hounds must register with CARA. Every dog not registered must submit a payment of \$2.00 and a photocopy of it's Kennel Club registration papers or PEN # with your entry.
- CARA registration is for the life of the dog.

#### **ENTRY FEES**

- PRE-Entries CLOSE at NOON WEDNESDAY JUNE 25, 2015
- Entry fee: \$20.00 per dog. Late Entry fee: \$25.00 no later than 6pm June 27
- E mail us the names of who you are entering and **bring** the signed entry with exact funds in an envelope with your name on it and hand it in upon arrival.
- Singles fee: \$10.00 includes 3 runs, one after each program.
- Single runs are primarily, but not exclusively, intended for dogs that are too
  young to compete, or those that need more experience before attempting
  certification and they need to be pre-entered as there is a limit.

#### INSPECTION AND ROLL CALL

- Check in for all racers is no later than 10:15 AM No exceptions.
- You can arrive as early as 9:30 am and check in for roll call upon arrival.
- All racers must wear muzzles and appropriate race Blankets.
- 3 programs means that hounds will run three times unless scratched, dismissed, or disqualified.
- · Races will be a maximum of 4 dogs.
- Whippets will be **BOX** started, other Breeds will be hand slipped.
- The lure is drag line.

#### THE SITE

- The race is held 10 min. from Okotoks AB
- The Field is park-like grass.
- PLEASE, drive slowly in and out of the driveway (15km/h)
- Port-A-Potty on Site.
- Bring your own chairs, shade and water.
- There is no concession, please come prepared with food and refreshment.
- No Camping available on site, day time set up only.

#### **AWARDS**

- Rosettes for Best of Breed, and Ribbons for 2<sup>nd</sup> through 5<sup>th</sup> place
- Sighthounds accumulate points towards a CARA Race Champion title.

#### **PRIZES**

- · Best of Breeds
- · Whippet Highest scoring Grade A, B, C, D at entry.
- · Highest scoring oldest Veteran.
- Highest scoring show bred Whippet
- Highest scoring FTE Whippet
- And more......

#### **ADDITIONAL INFO**

- Some Whippet size and large breed race blankets will be available on site.
- Racers must provide their own muzzles.
- All dogs on site must be under control. No loose dogs.
- Please, pick up after your dogs and yourselves.
- Containers with black bags are for recyclables and white bags for garbage.
- Set up areas will be designated. (No vehicles allowed on the field.)
- Dogs not present at **ROLL CALL** will be scratched and entry fee not refunded.
- Females in season and lame hounds will have their entry fee refunded provided notice is given prior to or during Roll Call.
- Entries will be refunded or kept for the next race meet (your decision) if we have to cancel the meet due to weather or other unforeseen circumstances.
- A brief handlers meeting will be held prior to the first race.
- Anyone exhibiting unsportsmanlike conduct will be asked to leave the race site.

#### PRE-CERTIFICATION EXEMPTION

A hound is exempt from pre-certification if it has any of the following titles. (Include proof of the following with your entry)

- F.Ch Field Champion (CKC, AKC, or ASFA) or higher title
- Novice Courser (CKC)
- LCM -Lure Courser of Merit (ASFA)
- SC Senior Courser (AKC)
- · ORC Oval Race Champion (NOTRA) or higher title
- SR Straight Racer (NAWRA)
- Gazehound Race Champion (LGRA)
- Coursing Champion Breed (UKC)
- Coursing Champion Mixed (UKC)
- Companion Racer (CWA)

### \* DIRECTIONS TO RACE SITE \*

Come into Okotoks, go past STAPLES and turn right which is Big Rock Trail. Drive up that curvy road to the stop sign on top of the Hill. Proceed across Hwy # 7 to the next stop sign which is 434th Ave. and turn right. Then, at the next road turn left which is 24th Street West. Drive for about a mile the acreage is on the left, you will see a chain link fence around the property and a white 3 rail fence up front with a white entrance gate. \*Please respect the owners property\*

#### **IMPORTANT NOTE**

CARA rules stipulate the number of people needed to run the race meet.

AGSA tries to arrange for the officials. The participants are responsible for arranging for their own loaders and /or catchers, either prior to, or at the meet.

Bring an extra leash for your loader or catcher.

Participants could possibly be required to fill in for foul or line judging.

#### CARA PRE-CERTIFICATION FORM

All hounds must be pre-certified prior to entering an official race meet. Pre-certification will consist of two qualifying runs, with at least two other dogs of the same breed or running style, observed by at least 4 foul judges. If all 4 judges agree that the run was clean, the Race Secretary will sign the dog's certification form.

This certification must be submitted the first time a dog is entered in an official race meet.

Further, the dog will be considered to be on probation for its first two race meets. The designation P will be added to a dog's CARA registration number while it is on probation.
