JUDGES' BIOGRAPHIES

MARY ANN ALSTON

My introduction to the world of show dogs was when I attended the Westminster KC shows in 1963. Shortly thereafter I purchased my first English Setter show dog while living and working in New York City. In 1970 I married George and we moved to Maryland to open Fieldstone Kennels. While pursuing our handling careers, I also bred English, Gordon and Irish Setters, and English Cocker Spaniels. As handlers, we were associated with some of the top breeders of sporting dogs, visited their kennels and watched promising youngsters develop.

We retired from handling in 1991 and I was granted a license to judge all Sporting breeds. Later I was approved to judge Hounds, Working, Best In Show, Miscellaneous and Junior Showmanship. My most memorable assignments: Westminster KC - twice, Ireland, Finland, Australia and most of the USA. I judged a Sporting Dog Specialty in Canada several years ago.

PAT & MIKE LANCTOT - EBONYLANE LABRADORS

Permanently registered with CKC in 1979, dogs bearing the Ebonylane prefix are found in virtually every corner of the world. We were very proud to be named "Pedigree Pal Breeders of the Year" in 1991. Our Motto is to breed dogs with type, temperament and trainability and we have produced over 100 champions with many in hunting homes or top ranking in obedience trial competition. There are many Ebonylane seeing eye dogs and others in drug detection and search & rescue. First and foremost all Ebonylane dogs are valued family companions. Our breeding ranked Top in Breed competition in both Canada and the United States in 1984.

Over the years we have held positions in: CKC Event Officiating Committee, Canadian Dog Judges Assoc, St. Lawrence Region Dog Judges Assoc, Labrador Retriever Club of Canada and Atlantic Labrador Retriever Club. We're Life Members of the CKC, the Labrador Retriever Club of Canada, Labrador Owners Club, Hochelaga Kennel Club & Chateauguay Valley Kennel Club. We are also members of Cornwall Kennel Club and the American Dog Judges Assoc. Approved by the CKC in 1994, we both have judged in all provinces of Canada except Saskatchewan, plus in Argentina, Australia, Bermuda, Holland, Mexico, New Zealand, Puerto Rico and 15 states of the USA. We look forward to judging at TIKO and the opportunity to meet new friends.

ELAINE J. LESSIG - ROIL CAVALIERS

Since acquiring my first Cavalier in 1987, my whole life changed as I became an active participant in the exciting sport of purebred dogs. As a Cavalier breeder, I've produced AKC champions in all four colors and both sexes. Additionally, I have Cdn, obedience, CGC, and CKCSC, USA titles on my dogs. The most thrilling were 2 BIS Specialty winners, Toy group winners, a BOS National Specialty winner, a BOS winner at Westminster, a BOS and Best Bred By at the Eukanuba National Invitational Championship, all on bitches I bred and own. I have judged Cavaliers at championship level since 1996 and in 1999 I became the first Cavalier breeder to attain AKC judging status strictly for the breed. Judging at AKC, CKCSC, USA, English, Irish, Swedish, Chinese, and Canadian shows has been a rewarding experience. At present I am eligible to judge BIS, Toy group, Non-Sporting group, 8 Sporting Breeds, and Standard Manchester Terriers. In addition, I'm an active member in 3 all-breed clubs, 1 group club, 2 national parent clubs, 2 regional breed clubs, and 2 judges' education groups. I have been show chair for Delaware Water Gap KC and National Show Chairman for the American Cavalier King Charles Spaniel Club. At present I serve as President of the Meadowlands Cavalier King Charles Spaniel Club and Delaware Water Gap Kennel Club.

JANET AND JOE LOBB

We began in Dogs in 1974, with our first Doberman and bred our first litter in 1977 under the 'Dobenhau' prefix. In 1988 we added Smooth Fox Terriers which we breed and exhibit on a limited basis under the FauxPaw prefix. We handled professionally on a limited basis, with many excellent dogs, some of which achieved top rankings. As well as Dobes and the smooth Fox we have owned and exhibited a multitude of other breeds ... German Shepherd, Bernese Mtn Dog, Bouvier, Greyhound and B&T Coonhound.

Janet is currently licensed to judge all breeds in Groups 1,2,3,4,6 & 7(Permit for all Group 5). Joe is licensed for Groups 3,4, 7 and the first half of Group 2 (Permit for balance of Hound breeds). We have judged in Canada and the US, and Janet also in China, having had the honour of awarding BIS in all three countries. Assignments included Specialty and All-Breed events. We've both enjoyed judging 'rare breed' events, exposing us to many well known breeds from all parts of the world.

MICHELLE ARMITAGE

As a junior I started training dogs for other people as we were a non dog household. By good fortune I met several wonderful people that let me train their dogs and took me to dog classes. This also opened my eyes to training various breeds. Now my life is enriched with my own dogs. I have trained a Beagle to one leg shy of his OTCh (in the days of the dreaded 3 minute group stand in Utility), and also earned the OTCh on two English Springers and am currently training another in Utility. I was bitten by the Agility bug and earned CKC & AAC championships on two Springers. My Trudy is the first ESS to earn an Agility Championship in Canada. Another bug that bit me is Tracking. I love doing various activities with my dogs. When not working my own dogs, I love judging and seeing others enjoying working with their dogs.

DEANA ABBOTT

Deana has taught CKC Rally Obedience since 2007 in Kingston, Gananoque & Brockville. She is on the Board of Directors for the Kingston District Kennel Club, an active member of the Belleville Kennel Club, and supports classes & events for TIKO whenever possible. She is co-owner of an Association of Canada Agility club based in Kingston, offering summer trials and monthly fun matches. Deana and her husband, Tom, have owned Shetland Sheepdogs for 30 years. She competes with her Shelties in Obedience, Rally Obedience (CKC and CARO) and CKC & AAC Agility.

BRUCE GIBBONS

Bruce has been involved in Dog Sports for over 25 years, as a breeder (Rideauview Goldens), and in his competitive dog obedience training school (*Top Ten Dog Obedience*). "I have had the great fortune to train 2 Top Obedience Dogs in Canada, win over 360 HITS, earn 21 perfect 200 scores, and put GMOTCh titles on my last 2 dogs." Bruce is also a CKC/AKC Obedience & Rally Trial Judge. 2. Building will open at 7:00 am Friday, Saturday and Sunday and close at midnight Friday and Saturday. Exhibitors must vacate the building 1 hour after Best in Show on Sunday.
3. In Transit area available.
4. To comply with instructions issued by the Canadian Kennel Club, we will be unable to accept entries reaching the Show Secretary after the official closing date as published in this premium list.
5. No entry will be accepted unless all particulars called for on the entry form are shown thereon. INCOMPLETE ENTRIES WILL BE RETURNED. NO ENTRY WILL BE ACCEPTED UNLESS ACCOMPANIED BY ENTRY FEES.
6. TELEPHONE & TELEGRAPH ENTRIES CANNOT BE ACCEPTED.
7. DIANA EDWARDS SHOW SERVICES, reserves the right to refuse any entry, subject to C.K.C. Dog Show Rules.
8. Acknowledgement of Entry and judging schedule will be mailed as soon as possible after entries close.
9. The person accompanying the dog must show Acknowledgement of Entry before the dog is allowed in the show and, unless a dog is entered officially, it will not be allowed in the show precincts, with the exception of dogs to be kept in the "In Transit" area. Show Precincts are the whole Memorial Centre building proper plus anything within ten feet of the outdoor rings.
10. It is the responsibility of the exhibitor to have the dog in the ring when the dog's class is scheduled for judging.
11. D.E.S.S. and the T.I.K.O. Club will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, or assume any liability in the event of an accident, or misfortune, to either dogs, exhibitors or patrons.
12. Conflicts between Dog Show Rules and New Breed Standards. The Board of Directors of the CKC has ruled that, where there is a conflict between the Breed Standards and the Dog Show Rules the Dog Show Rules will take precedence.
13. Exhibitors must abide by errors made in entering their dogs regardless of how or by whom the entry was made. Changes or cancellation of any entry after closing date is prohibited.
14. If, because of riots, civil disturbance or other acts beyond the control of the management, it is impossible to open or complete the show, no refund of entry fee will be made.
15. To avoid noise and confusion, there will be no individual dogs called to the ring by loud-speaker. Delays waiting for dogs will not be possible and handlers with several breeds must arrange for alternate handlers if judging times for their breeds conflict.
16. We will have someone clean up during the show times, but remember they cannot be everywhere at once. Your co-operation in cleaning up after your dog is much appreciated.

PLEASE NOTE

It shall be the duty and obligation of the show giving club to see that a judge, club official, volunteer, or any participant at an event held under these rules is not subject to indignities. The Conformation Show Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred. SECTION 1: A dog awarded WINNERS at a championship show held under these Dog Show Rules shall be credited with a number of championship points (ranging from 0 to 5) and the determination of the number of championship points to be credited to a dog awarded WINNERS shall be as provided hereunder.

SECTION 2: The schedule to be employed in the determination of the number of points to be allocated a dog awarded WINNERS shall be as follows:

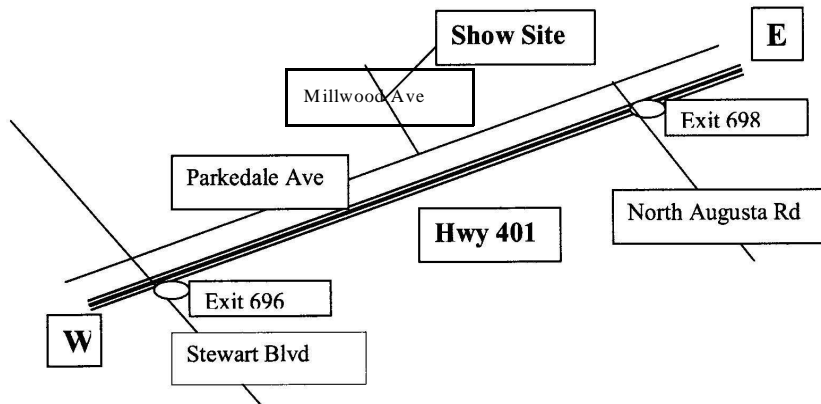
To determine the numbers of championship points earned by a dog awarded WINNERS total all the dogs in competition which the dog defeated, directly or indirectly, for the highest of the following official breed awards: Winners, Best of Winners, Best of Breed or Best of Opposite Sex and then consult the schedule set forth above. The new system provides for additional points (provided that the dog has defeated another as listed hereunder:

A class dog awarded Best In Show at an all-breed championship show will be credited with five points inclusive of any points earned at the breed or group level. In no case may a dog earn more than five points at any single show.
