NO POST DATED CHEQUES accepted. All NSF cheques are subject to a charge of \$35.00. All fees must be paid before the tests.

ATTENTION FOREIGN EXHIBITORS: Please note that fees are due and payable in Canadian dollars. Due to fluctuating currency rates, discounted cheques will not be accepted. Personal cheques are accepted; however, they are to be payable in Canadian funds. If you send a cheque in US funds, it must be made out for the full amount of the entry and no exchange will be refunded to the exhibitor. Please do not mark cheques "Payable in Canadian Funds" or "At Par". They will not be cleared by the banks. To simplify the process, we urge you to purchase bank drafts or money orders payable in Canadian funds.

ATTENTION ALL CANADIANS WHO ARE NOT CKC MEMBERS

Effective January 1, 2011, the CKC initiated an annual Non-Member Participation Fee for awards and titles for a Canadian non-member of the CKC. These fees apply only to dogs wholly owned by a non-CKC member and are not applicable to CKC members. Non-CKC member participants must either purchase a CKC membership or pay the non-member participation fee within 30 days of notification or the CKC will cancel any awards and titles. Each dog may on be entered in ONE of the WC, WCI or WCX test. A dog must have a WC title before running the WCI test, and have earned a WCI title before running the WCX test.

The running order for each test will be determined by random draw by the Test Secretary after the entries close.

Bitches in season may not compete.

Entry and listing fees paid for any dog withdrawn because of a bitch being in season, injury, illness or death shall be refunded in full. An appropriate veterinary certificate must be given to the Test Secretary BEFORE the start of the tests to qualify for the refund.

Ducks will be used for both the land and water marks.

All Bird Boys, Judges and Exhibitors shall wear dark or camouflage clothing, except handlers may wear white for the blinds in the WCX.

All qualifying dogs will be awarded a CKC rosette.

There will be a designated area available for airing your dog on the test grounds. Please contact the Marshall or other member of the Test Committee to confirm the location at the test site before airing your dogs.

Release and Indemnification of Landowners

The Irish Water Spaniel Association of Canada, its Working Certificate Test Committee, its members and the landowners will use due care and diligence for the welfare of the dogs and exhibitors, BUT will not be responsible for, nor assume liability in the event of an accident or other misfortune to either dogs, exhibitors or patrons. By entering this Working Certificate Test, each participant agrees to assume all risks and hazards incidental to participation in the test and agree to release, save harmless and indemnify the owner(s) if any property upon which the test is held together with their officers, agents, employees and representatives from all claims, actions, costs, expenses and demands in respect to death, injury, loss or damage to the person or property of the participant howsoever caused, arising out of or in connection with the participant's use or entry upon the property. It is understood that this agreement is binding upon the participant, or his or her heirs, his or her executors and assigns.

Section 14.7 CKC Working Certificate Test Rules and Regulations

It shall be the duty and obligation of the event-giving club to ensure that a judge, club official, volunteer, of any participant at an event held under these rules, is not subject to indignities. The Working Certificate Test Committee Chair shall promptly report any infringement of this regulation, and the CKC shall have the authority to take such actions as it deems fit on the receipt of that report indicating that this has occurred. A copy of this regulation shall be prominently placed in every premium list and catalogue.
