# **EXHIBITOR INFO:**

No flexi-leashes, pinch, or choke collars will be allowed on site. All dogs must be on a short leash and be under control while on trial grounds. Please ensure crates are well secured, as this is a highly excitable environment.

Dogs will be run in height order (small to large), with dogs being handled by the same person separated into different staging groups. Levels will be run from lowest to highest (Instinct, Novice, etc).

Bitches in season are eligible for entry, but must be kept separate from all other dogs, and will be run at the end of the trial.

There will be simple lunch options available for purchase on site. Given the distance from a major centre, guests are also encouraged to bring food with them.

#### LOCATION:

Trial is located ~20 minutes southwest of Saskatoon, off of highway #7, near Vanscoy. Directions will be available in the welcome letter. There is adequate crating room inside the building.

**Please note:** the facility is affected by weather conditions, so please bring appropriate gear. This is a farm yard location.

#### **ACCOMMODATIONS:**

There are a number of pet-friendly hotels in Saskatoon, which is a short drive to the site.

#### **DOG AGGRESSION:**

Any dog behaving in a threatening or aggressive manner toward another dog or a person may be dismissed from the workshop/matches if justification is found to do so by the judge and/or trial committee.

## **ANIMAL SAFETY:**

The safety of the dogs and the rats are our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and are physically able to perform all course elements safely.

## **REFUNDS:**

Refunds offered only for injured or sick dogs with veterinary note. Requests for refunds must be made by the closing date. Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by action of the Event Committee.
