EXHIBITOR INFORMATION

- 1. BHA registration numbers are **not required** for this event.
- 2. The matches will be held indoors in an unheated / un-air conditioned barn.
- 3. Dogs must be under control at all times while in trial precincts. Please note that many dogs may be highly excited in this environment.
 - a. No flexi-leads, pinch, choke or electronic collars are allowed within trial precincts. All dogs must be on a short (4-6 foot) leash.
 - b. Please ensure that dogs in crates are well secured. Soft side crates are discouraged.
 - c. Due to limited space no Xpens please.
- 4. Exhibitors with multiple dogs will run in different staging groups.
- 5. Bitches in season may participate but must be kept separate from all other dogs, must wear panties while in the trial precincts and will participate last in each event.
- 6. This event is being held in conjunction with the Tyee Kennel Club performance weekend. We will do our utmost to accommodate conflicts with other events, provided the appropriate course set up is still in effect.
- 7. Benching in the Barn Hunt area is free but will be available ONLY for registered participants in Barn Hunt during the period of participation. No rally, obedience or agility benching available in the Barn Hunt premises.
- 8. Exhibitors may enter multiple levels each day.

DOG AGGRESSION

Any animal behaving in a threatening or aggressive manner toward another dog or person may be dismissed from the event.

ANIMAL SAFETY

The safety of the dogs and rats are a primary concern. By entering this trial exhibitors acknowledge that they will follow all instructions / directions from the judge / trial officials.

REFUNDS

Refunds will be offered only for injured or sick dogs with a veterinary note.

Refunds will not be available for dogs that are absent, disqualified, excused or otherwise barred from participation by the judge or trial committee

Introductory Sessions

A brief introduction to the sport will be held prior to the morning sessions on both Saturday and Sunday. This session will review rules and regulations of the sport as well as hints and strategies for participation. **There is no cost for attending the introductory session.** We strongly encourage attendance at the introductory session if at all possible.

Coaching Sessions

A limited number of one-on-one coaching sessions with the judges are available at a cost of \$10 per 5 minutes (one dog per session, but you may request more than one session if you have multiple dogs). Coaching sessions will be offered immediately following the introductory session and prior to the fun runs. Coaching sessions will provide an opportunity to introduce your dog to the rats, tubes and course elements. It is not necessary to sign up for a coaching session to participate in the other events.

WHAT TO BRING

Water and treats for your dog; a chair if you wish to sit and observe.

A secure crate for your dog – hard side or wire crates preferred. Soft side crates are not recommended for this event. No Xpens please.
