An unrecognized breed is a dog of known ancestry not on the CKC's list of recognized or miscellaneous breeds that is registered with a registry recognized by the CKC. Dogs must have a CCN before entering an event. These dogs cannot pay Listing Fees. The fee for a CCN is \$63.40 plus taxes. A Performance Event Number (PEN) allows an unregisterable dog of a CKC breed to participate in competitive events that are appropriate for the breed. To apply for a PEN the owner must complete a CKC PEN application and forward it with the appropriate fee to the CKC (\$62.40 plus applicable taxes). Note: A dog that is eligible for a PEN number may not be entered as a listed dog.

I (we) personally assume all responsibility and liability for any such claim and I (we) further agree to hold the aforementioned parties harmless from any claim for loss of this dog by disappearance, theft, death, or otherwise, and from any claim for damage or injury to the dog, whether such loss, disappearance, theft, damage, injury be caused or alleged to be caused by the negligence of the club or any of the parties aforementioned, or by the negligence of any other person, or any other cause or causes. I (we) hereby assume the sole responsibility for and agree to indemnify and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting there from, sustained by any person or persons, including myself (ourselves), or on account of damage to property, arising out of or in consequence of my (our) participation in this herding trial, howsoever such injuries death or damage to property may be caused by negligence of the aforementioned parties or any of their employees or agents, or any other persons.

I (we) certify and represent that the dog entered is not a hazard to other dogs, animals, or people, and has received instructional training to or above the level of the class he/she is entered in.

I (we) also agree to pay the full market value (\$200.00) per sheep, for any death resulting from my (our) dog's actions, whether willful or accidental. In the case of injury to any sheep resulting from my (our) dog's actions whether willful or accidental, I (we) agree to pay all veterinary fees, up to and including the market value of \$200.00 per sheep.
