Dogs are required to have a Barn Hunt registration number to compete in a Barn Hunt trial. Register your dog online at www.barnhunt.com. Allow at least 48 hours to receive a barn hunt number. Handlers are responsible for entering and writing legibly the correct Barn Hunt number for their dog on entry form. An incorrect number may result in any legs earned being forfeited.

#### **Directions to the trial site:**

From Thunder Bay, head south on Highway 61 towards the US border. We are located at 3020 hwy 61, just past the Thunder Bay Correctional Centre. We are the first driveway on the right hand side after GFL Canada. If you have reached DeBruins Nursery, you have missed the driveway. (We are directly across the highway from DeBruins Nursery)

From the US border, heading north on Highway 61 towards the city of Thunder Bay, we are approximately 45kms from the border. We are the first driveway on the left on the highway past DeBruins Nursery. If you see the Thunder Bay Correctional Centre, you have gone too far.

We will have 1 ring with one judge. 9 am is General briefing and judges briefing.

First dogs should be ready to go to the blinds at 9:15am.

Friday: Trial #1- Masters and Crazy 8s

Saturday Trial#2 Instinct, Novice, Open, Senior, Masters

Saturday Trials # 3 Novice, Instinct, Open, Senior, Masters, Crazy 8s

Sunday Trial #4&5, same order as Saturday

LOOK CAREFULLY AT THE RUN ORDER WHEN IT IS SENT OUT, SO YOU KNOW WHEN TO BE THERE AND BE READY.

Friday runs height order small to large, Saturday height order large to small, Sunday height order small to large. Dogs being handled by the same person will be separated into different staging areas. Move ups will be allowed trial to trial.

The running order and further scheduling details will be emailed to all exhibitors after the actual number of entries are known for each class.

Height divisions: Small: Dogs 15" and under, Medium: Dogs 15.1 to 22", Large: Dogs over 22"

#### **Exhibitor Information:**

Entry forms: can be created on the barn hunt site at www.barnhunt.com then printed or scanned and sent with your payment.

Entering and paying through Dogshow.ca will give you actual online entry for the trials without any other steps. The waiver will need to be signed and sent to the trial secretary or can be filled out at the trial.

### Food & Drinks:

There will be a lunch break at the judge's discretion. Purchase of food will NOT be available on site.

#### Refunds:

Entry fees will not be refunded in the event that a dog is absent, disqualified, excused or barred from competition by action of the Event Committee. No entry fee will be refunded if the trial cannot open or be completed by reasons of riots, civil disturbances, fire, acts of God, public emergency, an act of a public enemy or any other cause beyond the control of the organizing committee. Exhibitors are responsible for complete, accurate and legible information on entry forms; illegible or incomplete entries cannot be entered in the trial. If cancelled due to Covid 19, partial refunds MAY be given.

Dog must be ON LEASH at ALL times unless they are in the ring or crated.

We will be adhering to all restrictions in place for/by Tucker Creek Farms as well as all BHA rules.

The safety of the dogs and rats is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport and that their dogs are familiar with and able to perform all obstacles safely. It is expressly understood that exhibitors alone are responsible for the behavior of their dog(s) and/or children. Any exhibitor whose dog(s) and or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behaviour may, at the discretion of the trial committee, may be asked to leave the site. In that case, no refund of any fees paid will be made.

Exhibitors are responsible for being ready to go to the staging area when it is their turn to run. The judge need not wait for any dog holding up a class. Owners are responsible for any error made on entry forms, regardless of who may have made the errors.

# Loud/Disruptive dogs:

Dogs that are loud and disruptive may be asked to locate away from the rings/crating area and/or staged away from the other dogs getting ready to compete. Any dog behaving in a threatening or aggressive manner toward another dog or a person may be dismissed from the trial if justification is found to do so by the judge and/or trial committee. Terrier sparring is not allowed on trial grounds. Any dog that is sick, injured or lame will be excused from the trial grounds.

#### **NO CRATING NEAR RINGS**

**CRATING:** All dogs must be on leash or crated at all times unless actively working, or going to or from the ring or being pottied.

Dogs can get excited at barn hunt events. Dogs must be securely crated at all times or with the owner and on leash. Dogs may not be left unattended outside of a secure crate.

Please pick up after you dogs and take your waste/garbage with you.

Always be mindful of leaving the grounds as you found them.

Any exhibitor failing to do so may be excused without benefit of refund if the Event Committee deems the exhibitor to be in violation of this requirement per BHA regulations.

#### Accommodation

All dogs should be crated in rooms.

In consideration for participating in any **Barn Hunt or NASDA events at Tucker Creek Farm**, the undersigned agrees as follows for the year of 2022.

I will keep my dog under my direct control at all times. This means that I will keep my dog restrained on a leash unless we are actively engaged in working under the direction of the trainer.

I understand that participating in Instinct Events is inherently dangerous due to the unpredictable nature of dogs. This activity exposes my dog and I to above normal risks of personal injury, and my property to above normal risks of damage.

#### I am participating in the Barn Hunt Events at my own risk.

I am solely responsible for my own safety and that of my dog. I release Tucker Creek Farm et al, the owners of the property on which the barn hunt events takes place, and their agents, managers, employees and volunteers from all liability if I or my dog suffer personal injury and/or my property suffers physical damage.

I will take no legal action against any of the above persons or establishments upon injury to myself or my dog or damage to my property.

I am solely responsible for any personal injury and/or property damage incurred by others and caused by me or my dog, including injury or death to livestock. The replacement cost of the livestock used for this event will be:
