### **Benching**

Limited, free on-site benching for obedience and rally is available within the trial precincts. Please maintain appropriate social distancing (A MINIMUM OF 9 feet / 3 Metres) between benching areas.

### **Photographer**

A show photographer will not be available at this show. A photo area will be setup for you to take pictures of your wins.

### **Routines & Jump Heights**

Routines for each trial will be decided by judges per standard CKC rules.  
Standard Obedience Jumps Heights Apply to the Open and Utility Classes.

### **Refunds**

Entry fees will **not** be refunded in the event a dog is absent, disqualified, excused by the Judge, or barred from competition by action of the Trial Committee.

Entry fees will be refunded when a bitch entered comes into season after the close of entries if a Veterinarian's Certificate (certifying that the bitch was in season within the 10-day period preceding the trial) is delivered to the Trial Secretary on or before the starting date and the time of the trial. The Rocky Mountain Working Herding Club of Alberta will refund entry, recording and TCN fees if the above conditions are met. A 50% refund of entry fees only will be made for a bitch in season without a Veterinarian's certificate with written notification presented to the Trial Secretary at least ONE HOUR before the start of the Trials. The bitch must be available to be examined by the Trial Chairperson to verify she is in season.

No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, an act of a public enemy, strikes, Federal, Provincial or Local requirements or any other cause beyond the control of the Club.

**Should the trial need to be cancelled due to COVID-19 ALL entry fees will be refunded.** Any Credit Card, Apple Pay, Interac or e-transfer service charges **WILL NOT** be refunded. Refunds for mail-in entries will be **MAILED** to the exhibitor. Refunds for online entries will be completed via [The Dog Show](#).

### **COVID-19 Requirements**

All Covid Rules **MUST** be followed by all exhibitors, and they may be subject to change should the Provincial or Federal Covid-19 Restrictions change

**MASKS WILL BE REQUIRED BY ALL EXHIBITORS AT ALL TIMES – INCLUDING WHEN TRIALING YOUR DOG. THIS MAY CHANGE CLOSER TO THE TRIALS.**

Entry to the trial zone / trial rings will be granted only to those wearing a face mask. Individuals who are unable to wear a face mask due to a medical condition must wear a face shield. Exhibitors / participants must wear a face mask or shield that covers their nose and mouth at all times in the trial zones / trial rings/ or within 9 feet of ANY other exhibitor or trial volunteer.

## OFFICIAL OBEDIENCE CLASSES

### REGULAR CLASSES

The following CKC classes will be provided:

<b>PRE NOVICE</b>	This is for any dog of any recognized or listed breed which has not earned the title of PCD. Dogs in this class may be handled by the owner or any other person. A dog that has earned the title of CD is not eligible for this class.
<b>NOVICE A</b>	This is for any dog of any recognized or listed breed which has not earned the title of CD. Only one dog may be entered in this class by any one exhibitor. The dog must be handled by the owner or a member of his immediate family. No person who has previously trained or exhibited a dog through its CDX title shall be allowed to handle a dog in this class.
<b>NOVICE B</b>	This is for any dog of any recognized or listed breed which has not earned the title of CD. Dogs in this class may be handled by any person. No dog may be entered in both the Novice A and Novice B class at any one trial.
<b>NOVICE C</b>	This is for any dog of any recognized or listed breed which has earned the title of CD or any higher obedience title. Dogs in this class may be handled by any person.
<b>NOVICE INTERMEDIATE</b>	This is for any dog of any recognized or listed breed which has earned the title of CD or any higher obedience title. Dogs in this class may be handled by any person.
<b>OPEN HA / 18A</b>	This is for any dog of any recognized or listed breed which has earned the title of CD but has not earned the title of CDX. Only one dog may be entered in this class by any one exhibitor. The dog must be handled by the owner or a member of his immediate family. Any person who has previously trained or exhibited a dog that has earned a UD title may not handle a dog in this class.
<b>OPEN HB / 18B</b>	This is for any dog of any recognized or listed breed which has earned the title of CD. Dogs in this class may be handled by any person. No dog may be entered in both Open HA/18A and Open HB/18B at any one trial. A dog that has earned the title of CDX must compete in Open B. Dogs eligible for entry in the Utility Class are also eligible for entry in this class.
<b>UTILITY A</b>	This is for any dog of any recognized or listed breed that has earned the title of CDX but has not earned the title of UD. The dog must be handled by the owner or a member of his immediate family. Any person who has trained or exhibited a dog that has earned a MOTCH title may not handle dogs in this class.
<b>UTILITY B</b>	This is for any dog of any recognized or listed breed that has earned the title of CDX or UD. Dogs in this class may be handled by the owner or any other person. No dog may be entered in both Utility A and Utility B at the same trial.

### NON-REGULAR CLASSES

<b>EXHIBITION ONLY</b>	Dogs entered in this class may not compete in any Regular class.

## OFFICIAL RALLY OBEDIENCE CLASSES

### REGULAR CLASSES

The following CKC classes will be provided:

<b>NOVICE A</b>	This is for any dog of any recognized or listed breed which has not earned the title of RN. The dog must be handled by the owner or a member of his immediate family. No person who has previously trained or exhibited a dog through its CDX title shall be allowed to handle a dog in this class. No dog may be entered in both the Novice A and Novice B class at any one trial.
<b>NOVICE B</b>	This is for any dog of any recognized or listed breed which has not earned the title of RN. Dogs in this class may be handled by any person.
<b>INTERMEDIATE</b>	This is for any dog of any recognized or listed breed which has earned the title of RN. This class is an elective class and earning the title is not a requirement to enter the Advanced classes.
<b>ADVANCED A</b>	This is for any dog of any recognized or listed breed which has earned the title of RN but has not earned the RA title or any CKC obedience title other than PCD. The dog must be handled by the owner or a member of his immediate family. No person who has previously trained or exhibited a dog through its CDX title shall be allowed to handle a dog in this class.
<b>ADVANCED B</b>	This is for any dog of any recognized or listed breed which has earned the title of RN. Dogs in this class may be handled by any person.
<b>EXCELLENT A</b>	This is for any dog of any recognized or listed breed that has earned the title of RA but had not earned the re title or any CKC obedience title other than PCD. The dog must be handled by the owner or a member of his immediate family. No person who has previously trained or exhibited a dog through its CDX title shall be allowed to handle a dog in this class.
<b>EXCELLENT B</b>	This is for any dog of any recognized or listed breed that has earned the title of RA. Dogs in this class may be handled by any person.
<b>MASTERS</b>	This is for any dog of any recognized or listed breed that has earned the title of RE. Dogs in this class may be handled by any person.

### NON-REGULAR CLASSES

<b>EXHIBITION ONLY</b>	Dogs entered in this class may not compete in any Regular class.

## **GENERAL INFORMATION**

1. **Obedience Trials & Rally Trials Rules and Regulations** are available from the **Canadian Kennel Club** or can be viewed [online](#).
2. The Trial Superintendent will be in full charge of the trial which will be governed by CKC rules.
3. Entries will be acknowledged after entry closing, with receipt, judging schedule and exhibitor passes. If such acknowledgement is not received one week before the trial date, please contact the Event Secretary.
4. "A judge officiating at a trial held under these rules shall not be subjected to indignities of any kind during the progress of the trial. It shall be the duty and obligation of the club holding the trial to see that this rule is effectively carried out" – **Obedience Trial Rules and Regulations** - Section 3.6.1.
5. We welcome all exhibitors, including persons with disabilities. If you require accommodation of a disability, please make your accommodation known to the club in advance. Please contact the trial secretary by entry closing to ensure that we can do our best to accommodate your needs.
6. The trial committee will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, or assume any liability in the event of accident, or other misfortune, to either dogs, exhibitors or patrons.
7. Exhibitors are solely responsible for the conduct or actions of their animals while they are on the trial grounds.

## **TCN FEES**

A CKC TCN fee of \$10.50 (GST Incl.) Canadian or US per dog per show is payable with the entry fee if the entry of the dog does not include a CKC individual Registration number, ERN (Event Registration Number), PEN (Performance Event Number), MCN (Miscellaneous Certificate Number) or Companion Number. The Temporary Competition Number MUST be obtained from the CKC prior to entering any CKC event. TCNs will replace the previous system of entering events with dogs as "listed" and will allow dogs to temporarily participate in CKC events while they pursue permanent registration or an Event Registration Number (ERN). If a CKC registration number is received after the closing date but prior to the date of the show, this number may be added to the entry and noted in the marked catalogue. TCN fees will not be refunded.

## **ENTRY AGREEMENT**

I (we) acknowledge that I (we), all exhibitors, handlers, and patrons, know and abide by the "CKC Dog Trial Rules" and that I am (we are) familiar with their content. I (we) agree that the Rocky Mountain Working Herding Club of Alberta (RMWHCA) has the right to refuse this entry for just cause, which the Club shall deem to be sufficient. In consideration of the acceptance of entries made in these trials, and of the holding of these trials and of the opportunity to have the dog judged and to win prize money, ribbons or trophies, I (we) agree to hold the Rocky Mountain Working Herding Club of Alberta, their members, directors, governors, officers, agents, superintendents, or trial secretaries, and the owner or lessor of the premises and any employees of the aforementioned parties, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of a dog while in or upon the trial premises or grounds or near any entrance thereto, and I (we) further agree to hold the aforementioned parties harmless from any claim for loss of a dog by disappearance, theft, death or otherwise, and from any claim for damage or injury to the dog, whether such loss, disappearance, theft, damage or injury be caused or alleged to be caused by the negligence of the Club(s) or any of the parties aforementioned, or by the negligence of any other person, or any other cause or causes. I (we) hereby assume the sole responsibility for and agree to indemnify and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties because of bodily injuries, including death at any time resulting therefrom, sustained by any person or persons, including myself (ourselves) or on account of damage to property, arising out of or in consequence of my (our) participation in these trials, howsoever such injuries, death or damage to property may be caused and whether or not the same may have been caused and whether or not the same may have alleged to have been caused by negligence of the aforementioned parties or any of their employees or agents, or any other person.

Kindly note that the Rocky Mountain Working Herding Club of Alberta, and/or its agents, may take candid photos, win photos, or videos of the trial, including but not limited to, images of the exhibitors and their dogs. ### **ATTENTION ALL FOREIGN EXHIBITORS!**

All dogs that are foreign-born and foreign-owned and enter Canada for the sole purpose of entering CKC (Canadian Kennel Club) events will no longer require a CKC registration number but will require an ERN - Event Registration Number. This ERN does not register a dog with CKC for breeding purposes as defined in the Animal Pedigree Act but rather enables a foreign-owned dog to be awarded titles by the Canadian Kennel Club. Each dog must have its own number. To obtain an ERN, mail or fax a photocopy of the dog's registration certificate with certified cheque, money order, VISA or MasterCard number (expiry date, cardholder's name and signature). Provide your complete address for return of the ERN to you. ERN MUST BE APPLIED FOR WITHIN 30 DAYS OF FIRST DAY OF ENTERING A CKC EVENT. A CKC ERN registration form can be downloaded [here](#).

### **Information for US Exhibitors on entering Canada**

- To enter Canada from the States, US Citizens must show proof of identity; however, to enter back into the United States, all US Citizens age 16 or older must have a valid Passport or Approved Secure Travel Document.
- Please be aware that all dogs must have a valid rabies certificate to cross the border. A valid rabies vaccination that has been given at least 30 days prior to entry into Canada is required. Government regulations require a rabies vaccination certificate be provided for each dog. NOTE: Dogs less than three months of age do not require rabies vaccination.

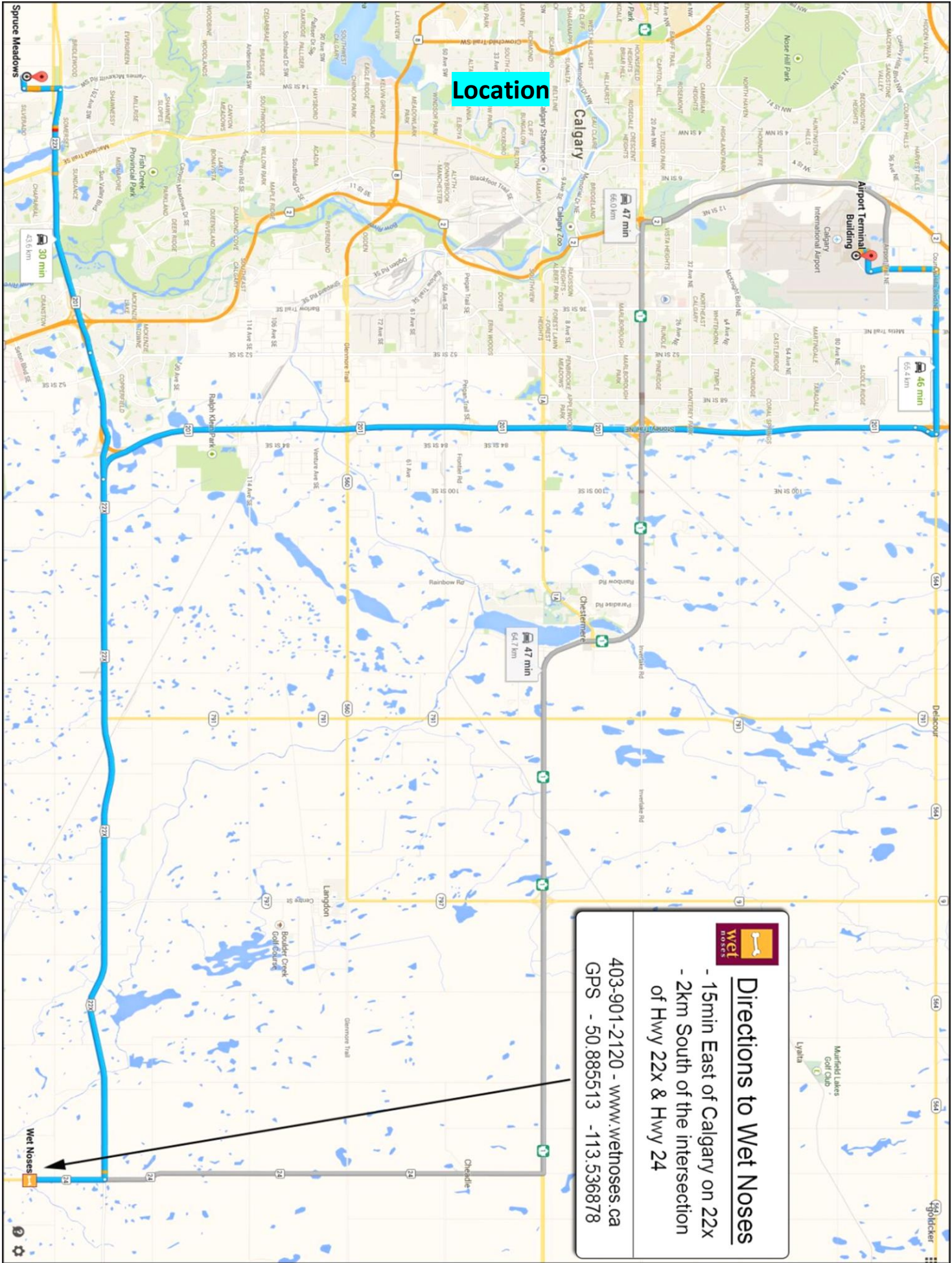

## COVID-19 Requirements

### General Required Practices

1. RMWHCA members, judges and exhibitors are required to follow Federal, Provincial, Local and facility guidelines as presented below. Any changes in guidelines between the posting of this Premium List and the starting of each trial will also be followed.
2. Social distancing must be practiced. Maintain a distance of 9 feet / 3 Metres or more unless individuals are part of a family or cohort unit.
3. Masks are required on the trial grounds and when trialing your dog. Masks are provided by the exhibitors for their personal use. Masks are required in all common areas where social distancing is not guaranteed.
4. There will be plenty of hand sanitizer around the facility for personal use and sanitizer will be provided in the porta-potty
5. Wash hands as frequently as possible. Disinfect gate latches, if touched.
6. No handshakes or hugging.
7. Do not touch dogs that are not your own.
8. Bring your own pen/pencil. No common use pencils, pens or markers will be available.
9. As you park at Wet Noses, leave sufficient space between vehicles to allow for effective social distancing.

### Information applicable to all participants

1. The trial grounds will likely have a limit regarding the number of people that are allowed on the trial grounds at a given time. This limit will be set closer to the trial date and detailed information will be included in the judging schedule. In addition, mask requirements and other COVID rules may change closer to the trial date and will detailed information on all these rules will be included in the judging schedule.
2. Take your win rosette/ribbon only if you plan on keeping it. Do not give rosettes/ribbons back to the RMWHCA.
3. Printed scoresheets may or may not be available to the exhibitor. If they are not available, the opportunity to take a photo of the scoresheet may be possible.
4. The trial secretary's designated space will be considered sacred ground. Barriers will be set up using a 9 Feet / 3 Metre perimeter to protect the trial secretary. Anyone who violates the space of the trial secretary will be asked to leave the trial grounds and may not return for the duration of the trials. No refunds for entries will be provided in this instance.

### Trial Practices

1. Each exhibitor will complete a waiver of liability for RMWHCA and Wet Noses Inc as part of their entry (either online entry or mailed entry). No one will be allowed to participate who has not completed the required waiver. If you enter online, please email a copy of your waiver to the trial secretary or print and bring a copy of your signed waiver if you have guests accompanying you. If you enter via a mailed entry, please ensure your paper entry includes a copy of your signed waiver.
2. Anyone exhibiting COVID symptoms will be asked to leave the trial grounds and will not be allowed to return. No refund will be issued.
3. It is required all exhibitors wear a mask on the trial grounds.
4. MAINTAIN 9 Feet / 3 Metre SPACING at all times.
5. Equipment will be sanitized at the end of each day and in between trials.
6. Gate Boards will be located outside the ring for exhibitors to check-in to their class. Please do not touch the Gate Board – a steward will check you into your class and accommodate any order changes. Maintain the 9 Feet / 3 Metre SPACING around the Gate Boards.
7. Exhibitors will remove and retrieve their own leashes; the leash will placed on a chair-like object in the ring.
8. Wristbands will be issued to all exhibitors and guests provided the guests names are included on the signed waiver that must accompany your entry form.

## **Assumption of the Risk and Waiver of Liability Relating to Coronavirus/COVID-19**

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. **COVID-19 is extremely contagious** and is believed to spread mainly from person-to-person contact. As a result, Federal, Provincial and Local governments and Federal / Provincial health agencies recommend social distancing and have, in many locations, imposed restrictions on the congregation of groups of people.
