REFUND INFORMATION: Entry fees will be refunded for bitches that come into season after the closing date. Entry fees will also be refunded for dogs/bitches that pose a threat of a communicable disease on the day of the trial. To obtain this refund a letter from a Veterinarian must be presented to the trial secretary prior to the commencement of the trials.

DIRECTIONS:

Driving From Fredericton/St. John way: Take exit into Salisbury (SALISBURY BIG STOP exit), turn <u>right</u> at top of exit ramp. Heading into Salisbury, go to end of that road, turn right. Take the first road to the left, RIVERROAD, you will go past the school, and over the Pedicodiac River BRIDGE. About 500 feet past the bridge, you will see the Golden Reins Equestrian Center on your left. We will also have a sign marker at the end of the driveway.

Driving From Moncton way: Take exit into Salisbury (SALISBURY BIG STOP exit), turn <u>left</u> at top of exit ramp. Follow directions as above.

ATTENTION FOREIGN EXHIBITORS

MOVE UPS

There will be an hour between trials each day for move ups. Please see the trial secretary immediately following the completion of the first trial. Once a dog has received three qualifying scores under two different judges in each class, it is eligible to move up to the next class.

ELIGIBILITY

In order to be eligible to compete in these trials, a dog must be registered with the CKC, hold an ERN, PEN, or Misc. Certification Number, or be eligible for same. Dogs may be spayed, neutered and/or debarked. Dogs must be 18 months of age or older. Dogs may not be lame.

These Agility Trials will be held indoors at Golden Reins Equestrian Centre, Salisbury, New Brunswick. The surface is a dirt riding arena. The precincts of the trials will be the arena and the doorway. AGILITY PRIZES

Rosettes will be awarded for all Qualifying Scores. Dogs placing 1st through 4th in each jump height class will receive flat ribbons.

THE FOLLOWING IS GENERAL INFORMATION

1. Dogs should be ready to run when called. We would like to keep the trial running smoothly. Please advice the show secretary if you have a dog absent.

2. Exhibitors must abide by any errors made in entering their dogs regardless of how or by whom the errors were made. PLEASE PRINT OR TYPE YOUR ENTRY CLEARLY AND PLEASE CHECK IT CAREFULLY BEFORE PUTTING IT IN THE MAIL.

3. The committee reserves the right to refuse any entry, subject to CKC rules.

4. The Trial Superintendent will be in full charge of these events, which are governed by CKC rules.
5. Any dog that is NOT entered in the Agility Trial will NOT be allowed within the precincts of the event.
6. The Trial Committee will use care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, or assume any liability in the event of an accident or other misfortune to either dogs, exhibitors or patrons. The Moncton Kennel Club will not be responsible for equipment left behind. It shall be the duty and obligation of the trial-giving club to see that a judge, club official, volunteer or participant at any event held under these rules, is not subject to indignities of any kind.
