EXHIBITORS ARE EXPECTED TO KNOW THE RULES AND REGULATIONS FOR DOG SHOWS. BOOKLETS ON DOG SHOW RULES ARE AVAILABLE FROM THE C.K.C

A judge officiating at a show shall not be subject to indignities of any kind during the progress of the show and it is the duty and obligation of the show-giving club to see that this rule is effectively carried out. (Dog Show Rules, Sec. 4.1.3)

No person may approach a judge, either directly or otherwise, orally or in writing, to favour his entry. Disciplinary action will be taken against any person who violates this rule or against a judge who fails to report any contravention of this rule to the CKC within 14 days of the act. (Dog Show Rules Sec. 4.1.6)

ATTENTION ALL CANADIANS WHO ARE NOT CKC MEMBERS

Effective January 1, 2011, the CKC has instituted an annual Non-Member Participation Fee for awards and titles for a CANADIAN non-member of the CKC. These fees apply only to dogs wholly owned by a non-CKC member and are not applicable to CKC members. Non CKC member participants must either purchase a CKC membership or pay the non-member participation fee within 30 days of notification or the CKC will cancel any awards and titles. Champions and championship points - chapter 15

Section 1 - a dog awarded winners at a championship show held under these rules shall be credited with a number of championship points (ranging 0-5), and the determination of the number of championship points to be credited to the dog awarded winners shall be as provided hereunder:

Section 2:

Dogs competing *	1	2	3-5	6-9	10-12	13 or more
Points allocated	0	1	2	3	4	5

* includes the dog awarded winners



GENERAL INFORMATION

1. The Show/Test/Trial Superintendent will be in full charge of the event that will be governed by CKC rules.
2. Identification cards and judging schedules will be mailed as soon as possible after the Closing Date.
3. The GSDCC will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for or assume any liability in the event of accident, or other misfortunes, to either dogs, exhibitors, or patrons.
4. **REFUND POLICY:** If because of riot, civil disturbance, or other acts beyond the control of the management, it is impossible to open or to complete the show, no refund of entry fees will be made.
5. **All exhibitors will be responsible for clean up on the grounds and surrounding areas for their own dogs and/or dogs they are handling.**
6. The precincts of the show and trial will extend 10' beyond the rings.
7. A judge officiating at a show shall not be subject to indignities of any kind during the progress of the show and it is the duty and obligation of the show giving club to see that this rule is effectively carried out. (Dog Show Rules, Sec. 4.1.3)
8. No person may approach a judge, either directly or otherwise, orally or in writing, to favour his entry. Disciplinary action will be taken against any person who violates this rule or against a judge who fails to report any contravention of this rule to the CKC within 14 days of the act. (Dog Show Rules Sec. 4.1.6)
9. **Temporary Competition Number (TCN)** - * Effective March 2, 2020
A Temporary Competition Number (TCN) must be obtained before submitting an entry for an event. The same TCN must be used for all event entries for a dog until the dog is permanently registered. Once a dog is permanently registered or has an ERN, the TCN will be replaced with the registration number or ERN. A TCN cannot be used for Listed Breeds (MCN) or dogs that will require a Performance Event Number (PEN) or Canine Companion Number (CCN).

There is no fee to obtain a TCN however exhibitors will still be required to pay TCN Fees (formerly called Listing Fees) when entering events using a TCN.

TCN Numbers may be obtained online via the CKC website where the number is issued instantly. Exhibitors may also mail in a printed application or contact CKC Shows and Trials by phone for a number.

Dogs may still enter CKC events until without a registration number or ERN until March 2, 2020 by marking TCN on the entry form (or Listed if it is an older entry form). An email address is required on the entry form in this case. Before applying for a TCN online, exhibitors are encouraged to check their dog's profiles to determine if the CKC has already created a TCN for that dog. There will be a tab called TCN Dogs in the owner's Portal account.

* If your dog does not have a registration number or ERN and has already competed in a CKC event and earned points, scores or awards, there is no need to apply for a TCN. The CKC will update its records accordingly.
