#### **RALLY OBEDIENCE TRIAL RULES AND REGULATIONS**

**Chapter 19 – Section 19.7** of the Obedience Rules and Regulations states: It shall be the duty and obligation of the trial-giving club to see that a judge, club official, ring steward, volunteer, or competitor at an Obedience Trial held under these regulations, is not subject to indignities of any kind. The Obedience Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.

#### **BITCHES IN SEASON**

Bitches in season are not permitted to compete. When a bitch comes into season after entries close, a Veterinarian's Certificate, certifying that the bitch was in season within ten (10) days of the trial, must reach the Trial Secretary on or before the day of the trial, prior to the judging of the class, and the club will refund the entry fees.

**Novice Brace Class SATURDAY ONLY, is limited to 4 entries,** if either or both dogs are not entered in any Official class, they must also be entered Exhibition Only.

#### NON-MEMBER PARTICIPATION FEE

#### Effective January 1, 2011:

a) A non-member participation fee will be charged to a resident of Canada who is a non-member of the CKC.

b) The non-member participation fee is paid in any year a title is earned and covers all titles and dogs owned by that individual.

c) In order for the title to be awarded, the non-member will have a choice to either become a CKC member or pay the non-member participation fee. Failure to comply within 30 days of notification will result in the title being withheld and the dog cannot be moved up to the next level.

d) The fee applies only to dogs wholly

#### ENTRY INFORMATION

1. No entry will be accepted unless all particulars called for on the entry form are completed in full.

2. Incomplete entries will be returned. No entry will be accepted unless accompanied by entry fees.

3. Exhibitors must abide by errors made in entering their dogs regardless of how or by whom the entries were made.

4. Alterations, substitution or cancellation of any entry after the closing date is prohibited.

5. Only dogs that are already registered in the Canadian Kennel Club Stud Book or are eligible for registration can be entered.

6. All dogs shown in a Non-Regular or Unofficial class must be entered in one of the Official classes, or for "Exhibition Only"

7. Dogs entered "For Exhibition only" and otherwise entered only in Non-regular or Unofficial classes may be spayed or neutered

8. The Trial Committee reserves the right to refuse any entry subject to CKC Rules.

9. ENTRIES POSITIVELY CLOSE **October 10, 2023 at 4 pm**, OR WHEN THE ENTRY LIMIT IS REACHED, WHICHEVER OCCURS FIRST.

10. Armband numbers and judging schedules will be sent as soon as possible after the entries close.

11. Tendering of an NSF cheque in payment of fees shall be considered non-payment of fees and is punishable by disciplinary action. Any NSF cheque will be subject to a \$20.00 service charge.

#### **GENERAL INFORMATION**

- 1. The Trial Chair will be in full charge of the trial, which will be governed by CKC rules.
- 2. The Whippet Club of Eastern Canada (WCEC) will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, or assume liability, in the event of accident or other misfortunes, to either dogs, exhibitors or patrons. A dog shall not be touched without permission of the owner or agent.
- 3. If, because of riot, civil disturbance, or other acts beyond the control of management, it is impossible to open or complete the trials, no refund of Entry Fees will be made.
- 4. The trial precincts shall be 5845 Marine Station Rd, Iroquois On, K0E 1K0
- 5. NO FOOD / water on site
- 6. Very little shade
- 7. No toys or treats allowed in the ring
- 8. No provision / refund for inclement weather
- 9. NSF cheques will be subject to a \$20 service charge
- 10. Judging schedules will be emailed after the closing date
- 11. Entries must include correct fees and signed waiver & payment MUST be submitted with entry
