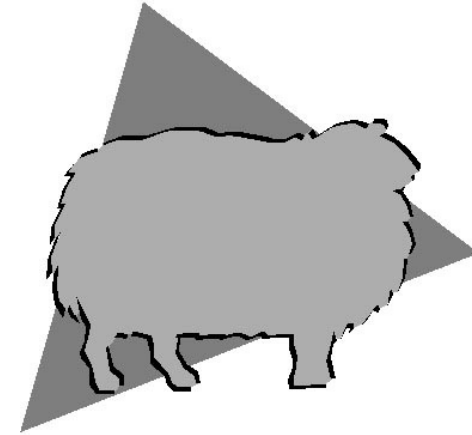

Closing date - 8:00 PM October 8, 2020. Entries must be delivered to the Test Secretary by the closing date. The Club cannot accept entries delivered after this date and time.

Entry Draw: Entry draw will take place at Nova Dogsport, 31 Weavers Lake Drive Harrietsfield NS at 11:00 am on October 9, 2020. Entries not drawn shall be assigned a position on an "Alternate List," to be determined by random draw. Entries from the Alternate List may fill any absentee spaces up until one hour before the start of the Tracking Test. The person making the entry shall be notified of their position on the alternate list. Entries will be refunded within ten (10) days of the Tracking Test to those on the Alternate List who did not participate in the Test.

After the closing date, the club will send out acceptance letters or emails, advising entrants of the status of their entry. A map showing directions to the rendezvous site will be provided, if necessary.

Entries may be mailed, sent by courier or delivered by hand to the postal address of the event secretary. e-mailed entries are acceptable but must be accompanied by an e-transfer made payable to: mgroup7c@gmail.com. All entries must be made on an official CKC entry form. Owners are responsible for errors in making out entry forms, regardless of who completes the entry form. *Incomplete or improper entry forms will not be accepted.* To prevent delays, entrants using couriers are encouraged to mark their envelope with the instructions "no signature required".

Dogs that have not passed a TD must provide a UTD Pre-test certificate as detailed in Section 8.1.1 of the Tracking Test Rules and Regulations.

As per Sec 6.6.2, one test track for UDX will be set aside for Club workers on Saturday.

NOTE: As a specialty club, the MG7 will be following Option 1 of Sec 2.2.5.

Draw for tracks UTD on Saturday, October 24, 2020, will occur at **10:30AM** at the rendezvous site, Stay N Play Canine Centre 214 Crossley Ave Truro NS. The first track will be ready at 10:45am.

Prizes: Passing dogs will receive a rosette.

Entry fees: \$85.00 UTD

Temporary Competition Number - \$11.50 "A TCN fee as established by the Canadian Kennel Club must accompany the entry of a dog which a Canadian Kennel Club individual registration number or Event Registration Number (ERN) is not shown on the entry form."

Fees are payable to: **Maritime Group 7 Club**. Post-dated cheques will not be accepted. NSF Cheques are considered non-payment of entry fees and will be charged a fee of \$25.00. Please note that fees are due and payable in Canadian dollars. Bank drafts or INTERNATIONAL money orders payable in Canadian funds are acceptable. Your understanding and cooperation is appreciated.

Withdrawals and Entry Fee Refunds - If an entry withdraws between the closing date and the test date, and is replaced by an alternate, the entry fee will be refunded. Withdrawals must be made in writing to the Test Secretary. Entries will be refunded within ten days of the tracking test to those on the alternate list who did not participate in the test. Entry fees will not be refunded if a dog is absent, disqualified, excused by a Judge, or barred from competition by action of the Test Committee.

Bitches in Season - Bitches in season **will** be allowed to participate but must run last and must be kept separated from all other dogs during the event.

An annual non-member participation fee for awards and titles will be charged to a Canadian non-member of CKC. The fee will match the ERN fee. In order to protect the awards/titles earned, the non-member will have a choice either to become a CKC member or to pay the non-member participation fee. Failure to comply within 30 days of notification will cause all awards and titles to be canceled. These fees apply only to dogs wholly owned by non-CKC members and are not applicable to CKC members.

The Maritime Group Seven Club will use all reasonable care to ensure the safety of dogs and persons at the test. However, neither MG7 Club nor any individual will accept the responsibility for loss or injury, however caused, to any dog, person or property.

CKC Tracking Rules (13.7): It shall be the duty and obligation of the test-giving club to see that a judge, club official, volunteer, or any participant at an event held under these rules, is not subject to indignities of any kind. The Tracking Test Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred. A copy of this regulation shall be prominently placed in every premium list and catalogue.

On the day of the test all Federal and NS Government restrictions regarding COVID will be implemented.
