A dog must enter three events at the specialty (Conformation, Obedience/Rally Obedience and Working Certificate Test). For conformation a dog must be entered in a class where they compete for Best in Specialty (Exhibition Only classes excluded). Gerardo Saldana Biography

I started my journey in Labradors 37 years. Our foundation bitches came to us from the late Carol Heidl from the Tabatha kennel. In the early 90's a black named Tabatha's Hideaway at Zinfndel (CH. Tabatha's Gadabout x Tabatha's Siren) and much later a yellow, CH. Tabatha's Confection (CH. Dickendall Davaron Gable x CH. Tabatha's Confetti). These two girls are the foundation of all our current Labradors.

Over the past 37 years my wife and I have bred and made up many specialty winning AKC Champions. The High points thus far has been taking WD and Best of Breed from the classes at the Labrador Retriever Club of Potomac (BISS CH.Moraines Malcolm at Zinfndel) also Winners Bitch and Best in Sweepstakes on a few occasions. We have had great success at specialties across the country throughout the years. We have also been fortunate to have bred some other wonderful males like MBISS.GCH Zinfndel's Spanish Oak JH, CH Zinfndel Brigham, BISS.CH Zinfndel Lengley's Big Papi to name a few. We have bred Champions and specialty winners in all three colors.

I was licensed to judge Labradors in 2016 and have judged across the United States and several countries, I was honored to judge the U.S Labrador National Specialty Show in 2020. Joan and I are current members of the Miami Valley LRC and the LRC INC. where I serve on the Board of Directors. Furthermore, I am humbled to be able to give back to the sport of pure-bred dogs whenever called upon.

I would like to thank the IPLRC for this wonderful opportunity to judge the 2025 specialty show. Also thank you to all the exhibitors for entering this year.

Joan Saldana Biorgraphy

My journey in Labradors began shortly after being married to Gerardo Saldana in 1988. Gerardo and I purchased our first Labrador Retriever from the local Pet store in the Mall. Lol

Realizing he looked a bit different from the dogs we were reading about in several Labrador books, we began our search and were told about a Labrador breeder not too far from us.

Shortly after a visit to this kennel we brought home our first show puppy which was bred by the Muskelunge Kennel owned by the late Merwin and Shirley Chambers. Zinfndel's Spanish Oak in the 9-12 sweepstakes class at the Labrador Retriever Club of Potomac in 2015 and going Best In Sweepstakes. Then in 2018 our girl GCH. Zinfndel's Shine Bright Like a Diamond was Winners Bitch and Best Of Winners also at the Labrador Retriever Club of Potomac in 2018. Gerardo and I have had many wonderful wins over the years, but these are a few that come to mind. But most importantly what comes to mind is the knowledge, friendship and memories that have been made over the years. Without this wonderful breed our lives would not be the same.

In my spare time I enjoy watching our dogs work in the water, spending time with my family and reading a good book and oh not to forget I have just taken up golf.

I decided in 2015 to gain my judging license and in 2016 was licensed to judge Labradors and plan to further my license in other breeds. This has given me the honor to go over some beautiful Labradors across the U.S., Canada, Mexico, Brazil and Findland. This November we will travel to Japan to judge for two of their Labrador clubs.

I am an active member of the Miami Valley Labrador Retriever Club and co-show chair of our Labrador Specialty. I am also a member of the Labrador Retriever Club, Inc. Being a part of these clubs gives me the opportunity to give back to the breed that has given so much to me and hopefully allow new fanciers to see what a great breed this is.

Thomas Alexander Biography

I have bred German Shorthaired Pointers under the Thomashenry prefix since 1980. Our kennel has had number one GSP 1986,88,90,91 and 96 with several in the top three in the sporting group in other years. I have had the top winning GSP / number one Sporting Dog & number three all breeds in South America as well as the first GSP ever to win the

group at the World show in 1992. A Thomashenry dog was Best of Winners at the American National Specialty in 2000. We have champions in six countries. I have also bred English Springer Spaniels and grew up with Irish Water Spaniels.

For the last twenty years I have bred Multi BIS, BISS Labrador Retrievers who have placed in the top five, including number one Labrador Retriever for 2016. I am involved WC training with our dogs. I am the field representative for the CKC, EOC.

I have judged Sporting Dog specialties in both Canada and the USA, New Zealand and Australia as well as the Canadian German Shorthaired Pointer National Specialty, the Clumber Spaniel National Specialty (Can.), the Nova Scotia Duck Tolling Retriever National Specialty, regional Golden Retriever Specialty, the Sporting Dog Spectacular, the Nova Scotia Duck Tolling Retriever National Specialty, Weimaraner National as well as several German Shorthaired Pointer and English Springer Spaniel Specialties. I have judged Working and Hound Specialties and Nationals in Canada, USA, Australia, Japan and New Zealand. I have also judged in Iceland, Hong Kong, Indonesia, Chile, Colombia, Manila, China and Korea. I am licensed to judge all breeds in Canada.

CONFORMATION CLASSES

The following Regular CKC Classes (divided by sex) will be offered:

<u>JUNIOR PUPPY CLASS</u> - This class shall be for any dog 6 months of age and under 9 months of age on the day of the show

SENIOR PUPPY CLASS - This class shall be for any dog 9 months of age and under 12 months of age on the day of the show

12 to 15 MONTHS – This class shall be for any dog 12 months of age and under 15 months of age on the day of the show

15 to 18 MONTHS – This class shall be for any dog 15 months of age and under 18 months of age on the day of the show.

<u>CANADIAN BRED CLASS</u> - This class shall be for any dog born in Canada. Champions of any country are excluded. <u>BRED BY EXHIBITOR CLASS</u> - This class shall be for any dog owned and handled in the ring by owner/breeder. The handler MUST be the owner/co- owner AND breeder/co-breeder of the dog. The owner/breeder must handle the dog at the class level, but need not handle the dog for further awards

OPEN CLASS - This class shall be for all dogs divided by colour: Black, Chocolate, Yellow.

<u>VETERAN CLASS</u> - This class is for dogs 7 years of age and older on the day of the show. Class will be divided: 7 Yrs to under 9 Yrs, 9 Yrs to under 12 Yrs, 12+ Yrs. The winners of each class in each sex will compete for Best of Breed. Dogs entered in these classes may be spayed or neutered.

<u>FIELD DOG CLASS</u> – Dogs entered in this class must have attained a title or placement in a field trial or test. This class is to be judged prior to Best of Breed judging and the winners in each sex will compete for Best of Breed. Dogs entered in these classes may be spayed or neutered.

<u>SPECIALS ONLY CLASS</u> - This class shall be for any dog that has a recorded CKC Registration or Event Registration Number and has attained the required points for Championship status. Note: A Listed dog may be moved to the Specials Only Class after the closing of entries, provided the CKC Individual or Event Registration Number was received prior to the first day of the show. The request to move a class dog to the Specials Only Class MUST be received by the Show Secretary ONE HOUR PRIOR TO THE OPENING OF THE SHOW ON THE DAY CONCERNED.

UNOFFICIAL CLASS

GUN DOG – This class is for dogs that have attained a title or placement in a field trial or test. Dogs entered in this class need not have been entered in the regular Field Dog Class; dogs entered in any regular conformation class, or For Exhibition Only, are eligible. Judging of this class will take place after Best of Breed.

PARADE OF TITLE HOLDERS - NATIONAL ONLY

Shall be for all dogs with any CKC or AKC Titles

Titles that are on your dog's registration profile will be the ones that are printed on your rosette.

You must be entered for a class or exhibition in the National specialty.

NON-REGULAR CLASSES

<u>EXHIBITION ONLY</u> - All dogs entered in this class shall be listed in the catalogue with the same particulars as dogs entered in regular competition. Dogs entered in this class MAY NOT COMPETE in any Regular class but may enter and compete in Non-Regular classes and/or Parades ONLY

BABY PUPPY- this class is for dogs 4 months of age and under 6 months of age on the day of the show.

<u>STUD DOG</u> - This class shall be comprised of the stud dog and two or more of his get. Ownership in this class need not be identical. The stud dog may be neutered and must be entered in a regular class or in Exhibition Only. Get must be entered in a regular class. Baby Puppies are not eligible.

BROOD BITCH - This class shall have the same requirements as the Stud Dog and Get. The brood bitch may be spayed. Baby Puppies are not eligible.

BRACE - This class shall be for two dogs of the same breed (not necessarily the same sex). A Brace must be handled by one person on one lead.

<u>SEXUALLY ALTERED CLASSES:</u> Eligibility for the Altered classes shall be limited to dogs over six months of age, which have been sexually altered by veterinary procedure. Points MAY NOT be carried from the regular competition judging to the Altered class judging. This class will be judged upon the completion of Best of Breed divided by sex. Classes will be placed first through fourth in both sexes, the first place winner from each sex will be declared Winners and the second place winner from each sex will be awarded Reserve. The Altered Winners Male and Altered Winners Female will then compete for Best Altered in Breed.

Juvenile Sweepstakes

Preceding Regular Conformation Classes on Friday, July 11, 2025 and Saturday, July 12, 2025 Judges: Marlys Swanson (July 11th) and Joan Saldana (July 12th)

Juvenile Sweepstakes is open to all Labrador Retriever puppies six months and under eighteen months of age regardless of place of birth. All dogs must be entered in one of the regular official classes on the same day. Dogs will be judged in one of the following eight classes (divided by sex):

6 months and under 9 months

9 months and under 12 months

12 months and under 15 months

15 months and under 18 months

For final judging the first place puppy from each of the classes will be brought together for the final judging of Best in Sweepstakes and Best of Opposite Sex in Sweepstakes,

Best in Sweepstakes - rosette & 25% of total fees collected for the Juvenile Sweepstakes
Best of Opposite Sex in Sweepstakes - rosette & 15% of total fees collected for the Juvenile Sweepstakes
First place winners in each class will divide the remaining 35% of the total fees collected for Juvenile
Sweepstakes

25% of fees collected will be retained by the club to defray costs

or in Exhibition Only at this event.

Dogs do not need to be owned by the junior.



The Best Canadian Bred Puppy will be the unofficial colours, as CKC does not allow us to have both as official awards.

The person handling the dog in the ring shall be recognized as the Agent for the owner of the dog. Delivery in the ring of any prizes won shall constitute full delivery of the prize to the rightful owner. No prizes will be mailed.

15.1 Championship Points

15.1.1 A dog awarded Winners at a conformation show shall be credited with a number of championship points (ranging from 0 to 5) and the number of championship points credited to a dog awarded Winners shall be as provided hereunder.

15.1.2 The schedule to be employed in the determination of the number of points awarded Winners shall be as follows;

In counting the number of eligible dogs in competition, a dog that is disqualified, dismissed, excused or ordered from the ring by the judge shall not be included in the calculation for championship points.

- 15.1.3 If a dog awarded Winners is also awarded Best of Breed at the show, then all dogs competing in the breed, including Specials Only, shall be included in the total
- 15.1.4 If a dog awarded Winners is also awarded Best of Opposite Sex to Best of Breed, then all dogs of the same sex including those competing for Specials Only shall be included in the total.
- 15.1.5 If a dog awarded Winners is also awarded Best of Winners, then all dogs defeated directly or indirectly in the breed shall be included in the total.
- 15.1.6 If a dog is awarded Winners only, then all the dogs of the same sex in the class competition shall be included in the total.
- 15.1.7 The number of championship points to be credited to a dog awarded Winners shall be determined by the highest award earned and calculated as per this section.

Clarification:

Example of directly or indirectly defeating: If the Winners Bitch is awarded Best of Opposite Sex but not Best of Winners, the Best of Winners Male shall be deemed to have indirectly defeated the Specials Bitches, and is thus entitled to add them to the number of dogs and bitches defeated.

15.1.8 In addition to championship points allocated at the breed level, a dog awarded Best of Breed that also places in the regular group competition shall be credited with the following additional points provided that a dog was defeated at the Group level.

- 15.1.9 A dog may not be credited with more than five (5) championship points in a single show.
- 15.1.10 Permission shall be granted a club or clubs to hold shows in such a way that any dog may earn three (3) sets of championship points on the same day, provided that one or more of those sets of points is awarded at a Specialty for that breed or group.
- 15.1.11 A dog awarded Winners which also places Best in Show at an all-breed conformation show shall be credited with five (5) championship points inclusive of any points earned at the breed and group level.
- 15.1.12 In order for a dog to be recognized as a Champion and its owner provided with a Championship Certificate, the dog must: (a) earn at least 10 championship points under at least 3 different judges and,
- (b) be registered in the records of the CKC, have an Event Registration Number (ERN), or have a Miscellaneous Certification Number (MCN).
- (c) have earned at least one 2 point win either at the breed or group level.
- 15.1.13 The Board interprets the words "earn at least 10 championship points under 3 different judges" to mean:
- (a) 3 or more Winners awards at not less than 3 different shows, under 3 different judges at the breed level;
- (b) each of the 3 Judge's awards must be one or more championship points won at Winners, Best of Winners, Best of Breed or group placing;
- (c) all points required for championship status may be earned at winners, best of winners, best of breed or group placing.

15.2 Grand Champion (GCh)

15.2.1 The title of Grand Champion may only be earned after the completion of the CKC conformation Championship.

3 to 5

- 15.2.2 Points for this title are only accumulated after the completion of the conformation Championship and do not include the points earned in attaining the conformation championship.
- 15.2.3 To be awarded a Grand Champion title, a dog must attain a minimum of 20 points, which must include a minimum of two (2) wins of at least two (2) points each. Points may be gained at breed, group or Best in Show/Specialty level. Only the highest points earned at a single show are carried forward.
- a) Grand Champion Point System

Points towards the Grand Champion title, at breed level, are awarded to the Best of Breed, Best of Opposite Sex, Select Dog and Select Bitch. Points are calculated based on the number of animals competing at the breed level for the Best of Breed winner and the number of similar sex dogs competing for the other three (Best of Opposite, Select Dog, Select Bitch). The following schedule shall be employed in the determination of points awarded at breed level:

15.3 Grand Champion Excellent (GChEx)

- 15.3.1 The title of Grand Champion Excellent may only be earned after the completion of the CKC grand championship title.
- 15.3.2 Points for this title may be accumulated at any time after the completion of the CKC grand championship but does not include the points earned in attaining the conformation championship or the grand championship.
- 15.3.3 A minimum of 100 points which must include one (A) Best in Show or a Best of Breed at a breed national specialty (where a minimum of ten dogs have competed) plus three (3) Group 1sts or three (3) breed Specialty wins.
- a) Grand Champion Excellent point system

15.3.4 Only the highest points earned at a single show are carried forward. For example, a dog that wins first in group and then wins Best in Show, earns 10 points, not 15.

15.3.5 The title of Grand Champion Excellent shall not be awarded retroactively. However, dogs that have been awarded the Grand Champion title prior to January 1, 2013, will be awarded the Grand Champion Excellent Title on application to the CKC.

15.3.6 Additional Requirements

To attain a Grand Champion Excellent title, a dog must have been awarded a CKC performance title from any CKC event. A CGN, Herding Tested Certificate, or Chase Ability Program title are not considered performance titles for the awarding of this title.

^{*}b) In order to obtain a Grand Champion title, a dog must obtain at least two (2) points after 12 months of age. In counting the number of eligible dogs in competition, a dog that is disqualified, dismissed, excused or ordered from the ring by the judge shall not be included in the calculation for Grand Champion points.

8.2 Entry Forms

- 8.2.1 An official CKC entry form must be completed in full and signed by the owner or authorized agent. Failure to do so may result in the cancellation of all wins.
- 8.2.2 A show-giving club must reject an incomplete entry form and return it immediately to the sender.
- 8.2.3 Entry forms received by the CKC, which are incomplete and/or contain incorrect information may result in awards being cancelled.
- 8.2.5 An error in an age specified class, date of birth, or sex, may be amended on the entry form up to one hour before the start of the show.

8.3 Entries (Green is July 1 2018 update). Implemented March 2 2020

- 8.3.1 Every dog entered in a show must be one of the following: a) registered with the CKC; b) have an Event Registration Number (ERN); c) have a Temporary Competition Number, and must be eligible for registration with the CKC; d) with the exception of Baby Puppy, if it belongs to a listed breed, it must have a Miscellaneous Certification Number (MCN).
- 8.4.1 If a dog is not registered as in 8.3.1 a) or b) but is eligible for registration with the CKC; it may be entered at a show as a listed dog provided:
- a) that if born in Canada, the dog has a Temporary Competition Number, and it is eligible for individual registration; b) that if not born in Canada, the dog has a Temporary Competition Number, and it is eligible for registration in the records of the CKC; c) that if it is a foreign-born and owned dog, the dog has a Temporary Competition Number. An Event Registration Number or CKC registration number must be obtained from the CKC within 30 days of the first show entered.
- 8.9.1 A dog that is registered in the records of the CKC or that has a Miscellaneous Certification Number (MCN) and has completed the requirements for a championship in accordance with these rules but at the time of closing of entries for a show has not received confirmation of the title, may be transferred from one of the regular classes to Specials Only providing the transfer is submitted to the Show Secretary in writing by the owner or handler at least one (1) hour prior to breed judging. A dog that has a Temporary Competition Number is not eligible to be transferred from one (1) of the regular classes to Specials Only.

8.5 Acceptance of Entries

- 8.5.1 If indicated in the premium list, an electronically transmitted entry may be accepted provided the entry is accompanied by a credit card charge authorization.
- 8.5.2 Telephone and telegraph entries are prohibited except as provided by the Board in the event of a postal disruption.
- 8.5.3 No entry shall be accepted from or on behalf of any person who is officially known to be expelled, deprived of privileges, debarred or suspended by the CKC or any other registering body for purebred dogs.
- 8.5.4 After entries close, no further entries may be accepted, cancelled or substituted other than as otherwise stated in this section or as provided for in the case of a postal strike.
- 8.5.7 No entries may be changed or altered after the close of entries with the exception as stated in section 8.2.5.
- 8.5.8 In case of a judge change (substitute or overload), an exhibitor may enter a dog under the replacement judge providing that the dog is entered in one of the regular classes of a show being held at the same venue by the same club and has been assigned a competition number. A new entry, along with accompanying fees, will be accepted by the Show Secretary up to one hour prior to the start of the show (see sections 3.3.1, 3.5.1 and 8.5.4).

8.6 Refusal of Entries

- 8.6.1 The authorities of any show may:
 - (a) decline to accept entries for just cause, and/or
 - (b) refuse to receive, or may remove any dog from the show building on account of disease or viciousness. A club declining an entry or ordering the removal of a dog from its show must report, in writing, all such matters to the CKC with a full explanation and/or reason within 14 days after its show has been held;
 - (c) in the case of non-acceptance, refund the fee with the reason for non-acceptance.
- 8.6.2 A club may refuse an entry from an exhibitor known to have tendered a dishonoured cheque or declined credit card unless entries are accompanied by cash, money order or certified cheque.

11 UNSPORTSMANLIKE CONDUCT

- 11.1 It shall be deemed unsportsmanlike conduct if a person during the running of or in connection with an event abuses or harasses a judge, show official or any other person present in any capacity at the event.
- 11.2 Any handler who displays unsportsmanlike conduct or who is seen to kick, strike or otherwise roughly manhandle a dog at any time during the holding of the event, may be expelled from the show by the Conformation Show Committee.
- 11.3 The judges shall also have the authority to expel a handler from a show if they observe unsportsmanlike conduct on the part of the handler or see the handler kicking, striking or otherwise roughly manhandling a dog while the event is in progress. It will be the duty of the judge to report promptly to the Conformation Show Committee the expulsion of a handler.
- 11.4 The Conformation Show Committee shall investigate, at once, any instance of alleged unsportsmanlike conduct on the part of the handler, or any report that a handler has been observed kicking, striking or otherwise roughly manhandling a dog. If the Conformation Show Committee, after investigation, determines that a handler is in violation of this section, and that the incident, if proven, would constitute conduct prejudicial to the sport or the CKC, it shall exercise its authority in accordance with the Complaints section of these rules.

Attention Foreign Exhibitors

Please note that fees are due and payable in Canadian dollars. Due to consistently fluctuating currency rates, discounted cheques will not be accepted.

Personal cheques will be accepted, however, they are to be payable in Canadian funds. If you send a cheque in US funds, it must be made out for the full amount of the entry and no exchange will be refunded to the exhibitor.

Please do not mark cheques "Payable in Canadian Funds" or "At Par". They will not be cleared by the banks.

To simplify the process, we urge that you purchase bank drafts or money orders payable in Canadian funds.

Your understanding and cooperation is appreciated. Thank You.

12.4 Failure to Compete

12.4.1 Except for Puppy in Group or Show, an owner or handler shall be subject to disciplinary action for withholding a dog from competing for higher awards for which that dog is eligible. Any dog so withheld or absent will result in the cancellation of all awards won at that show (unless the dog is excused by the Show Superintendent).

12.4.2 Should a dog be marked absent in an official class, it may still compete in an unofficial or non-regular class at the same show.

8.9 Moving a Dog to Specials

8.9.1 A dog that is registered in the records of the CKC or that has a Miscellaneous Certification Number (MCN) and has completed the requirements for a championship in accordance with these rules but at the time of the closing of entries for show has not received confirmation of the title, may be transferred from one of the regular classes to Specials Only providing the transfer is submitted to the Show Secretary in writing by the owner or handler at least one hour prior to breed judging.

8.9.2 If it is established that a dog transferred to Specials Only has not completed the championship requirements, all awards will be cancelled and all ribbons and prizes won shall be forfeited. The owner may also be subject to disciplinary action.

8.9.3 When one or more all-breed and/or specialty shows are held on the same day, in the same venue, the request for moving of class dogs to specials must be made a minimum of one hour prior to the scheduled start of the show for which the dog is being moved up to. The Show Secretary shall amend the judge's book and the marked catalogue, which is to be sent to the CKC with the requests attached to the appropriate entry forms.

8.9.4 No dog may be transferred to another class except as provided in sections 8.2.5 and 8.9.1

The club reserves the right to remove any person(s) from the show and the show grounds. The Show Superintendent shall have full control of these shows and trials, which are governed by CANADIAN KENNEL CLUB (CKC) rules.

Any person excused by the Show Superintendent or Veterinarian for any reason shall not, compete in any class for any awards for the balance of the shows, trials and or events. The Show committee will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, or assume any liability in the event of accident or

misfortune to either dogs, exhibitors, spectators or vendors.

Exhibitors may be asked by the show superintendent for proof of third party liability insurance. Failure to produce may result in dismissal from the show grounds.

Dogs must be on the grounds 1 hour prior to the judging of their class.

The owner of a dog entered in these shows is entirely responsible for any error in entering his/her dog regardless of how or by whom the entry was made.

Exhibitors and handlers will be responsible for their dogs and equipment left at the show grounds.

All recreational units will have buckets underneath for their sink drains. Any one found discharging water on the grounds will be removed by order of the Health Department, and may be subject to fine.

If, because of civil disturbance or other acts beyond the control of the club, it is impossible to open or complete the show, there is no refund of entry.

Dogs must be on leash at all times on the show grounds or within the show building.

All dogs must be exercised in the grass areas to the West (Rear) of the Saanichton Fairgrounds. Dogs may not relieve themselves on or near the building. Failure to observe this rule may result in dismissal.

PLEASE REMEMBER TO CLEAN UP AFTER YOUR DOG. Any exhibitor caught abusing this and not cleaning up after their dog will be subject to expulsion from further competition. There will be extra dumpsters on the show grounds, so please use them to ensure our continued use of this site.

Exhibitors are expected to maintain a clean area. Please be considerate when utilizing the building facilities. No dogs are permitted in the washrooms.

The welfare of any children is deemed to be the responsibility of the guardian or parent. Please exercise control and restraint over your child's behaviour.

The club is not responsible for lost or stolen property from exhibitors or vendors/concessions. Check for lost property at the club table. The club reserves the right to refuse an individuals entries, for just cause.

The club reserves the right of restricting exhibitors space.

Fire lanes in all areas will be maintained.

All exhibitors must follow direction by Saanichton Fairgrounds. personnel.

There will be no vendors at these events

The precincts of these shows will be the Saanichton Fairgrounds reserved for the sole use of the club.

MOVING A DOG BACK TO THE CLASSES FROM SPECIALS:

The following motion regarding moving a dog back to the classes from Specials Only was carried at the September meeting of the Board of Directors: "THAT, the Conformation Show Rules & Regulations, Section 8.10 be amended by adding a new section <u>effective immediately</u> to read as follows: 8. ENTRIES & END OF SHOW

8.10 Moving a Dog to Specials

ADD NEW

8.10.5 A dog can be moved back into the classes from a special if it has been entered incorrectly only where shows have already closed."

Notice of Agreement

I (we) acknowledge that I (we), all exhibitors, handlers and patrons, know and abide by the "CKC Dog Show Rules" and that I am (we) agree that Island and Pacific Labrador Retriever Club and the Labrador Retriever Club of Canada, has the right to refuse this entry for cause, which the Club shall deem to be sufficient. In consideration of the acceptance of this entry and of the holding of the Shows and of the opportunity to have the dog judged and to win prize money, ribbons or trophies, I (we) agree to hold the Island and Pacific Labrador Retriever Club, the Labrador Retriever Club of Canada, the Victoria City Kennel Club and Vancouver Island Dog Fanciers Association, their members, directors, officers, agents, superintendents, judges, stewards or show secretary and the owner or lessor of the premises and any employees of the aforementioned parties, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of a dog while in or upon the show premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim, and I (we) further agree to hold the aforementioned parties harmless from any claim for loss of a dog by disappearance, theft, death or otherwise, and from any claim for damage or injury to the dog, whether such loss, disappearance, theft, damage or injury be caused or alleged to be caused by the negligence of the Club or any of the parties aforementioned, or by the negligence of any other person, or any other cause or causes.

I (we) hereby assume the sole responsibility for and agree to indemnify and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties because of bodily injuries, including death at any time resulting therefrom, sustained by any person or persons, including myself (ourselves), or on account of damage to property, arising out of or in consequence of my (our) participation in this show, howsoever such injuries, death or damage to property may be caused and whether or not the same may have been caused and whether or not the same may have alleged to have been caused by negligence of the aforementioned parties or any of their employees or agents, or any other person.

I (we) hereby assume the sole responsibility for and agree to indemnify and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties because of bodily injuries, including death at any time resulting therefrom, sustained by any person or persons, including myself (ourselves), or on account of communicable disease(s), arising out of or in consequence of my (our) participation in this show, howsoever such injuries, death or damage to property may be caused and whether or not the same may have been caused and whether or not the same may have alleged to have been caused by negligence of the aforementioned parties or any of their employees or agents, or any other person.

Communicable Disease refers to any Communicable Disease or mutation thereof. Exhibitors, handlers and patrons are responsible for any cost, loss or expense of any kind, arising directly or indirectly from the actual, potential, alleged or threatened transmission of, contact with, exposure to, existence of, presence of, fear or spread of, a Communicable Disease or any mutation thereof, including any costs or expenses incurred to prevent, respond to, test for, monitor, mitigate, remove, cleanup, contain, treat, detoxify, neutralize, assess or otherwise deal with a Communicable Disease or any mutation thereof. This applies: (i) regardless of any other contributing or aggravating cause or event that contributes concurrently or in any sequence to the cost, loss or expense; and (ii) to all coverage extensions, additional coverages, exceptions to any exclusion and other coverage grant(s).

Communicable Disease means any disease caused by any substance or agent that occurs through any transmission of the substance or agent from an infected individual or via an animal, vector or the inanimate environment to a susceptible animal or human host where:

- (A) the substance or agent includes, but is not limited to, a virus, bacterium, parasite or other organism or any variation thereof, whether deemed living or not, and
- (B) the method of transmission, whether direct or in direct, includes but is not limited to, airborne transmission, bodily fluid transmission,
