Rules and Notes

Dogs MUST be entered in the show, or for Exhibition Only, to be on the show grounds.

CKC Show Rules require that the precincts must consist of all areas of the facility reserved for the use of the Club, exclusive of the parking area. Dogs that are not entered in this show, including puppies under 4 months of age, are not permitted within the show's precincts, including in the commercial booth area. Dogs are to be exercised in the designated area only.

Crates are permitted at RINGSIDE only during the judging of your breed.

*Plastic sheeting / tarps MUST be used under all x-pens.

*Any tape used on the floor MUST be removed after the show with no residue showing.

*No paper from the x-pens or crates or liquid waste are to be disposed of in garbage cans. They must go in the bins provided outside of the building.

*Dogs left in the building overnight are understood to be left at the owner's/agent's own risk.

*Any vehicle parking in the handicapped designated area must display handicapped authorization.

*The grooming building will be closed at 10pm each day.

*The building must be vacated (and left clean) one hour after Best In Show on Monday.

CLASSIFICATION-CONFORMATION: The following classes will be provided, divided by sex.

REGULAR CLASSES

JUNIOR PUPPY - 6 months & under 9 months on the day of the show

SENIOR PUPPY- 9 months & under 12 months on the day of the show

CANADIAN BRED - for dogs born in Canada, Champions in any country excluded.

12 - 18 MONTH CLASS 12 months and under 18 months on the day of the show.

BRED BY EXHIBITOR - shall be for dogs owned and handled in the ring by the breeder.

OPEN CLASS -shall be for all Dogs.

SPECIALS ONLY - This class will NOT be divided by sex. A dog may be entered for "Specials Only" and such dog shall compete for Best of Breed award. If eligible it must compete for the award of Best of Opposite Sex. All awards the dog earned at the show will be cancelled if, at the time of closing of entries for the show, the dog was not registered individually in the records of the Canadian Kennel Club or if the dog has not earned all the championship points required for championship status. The entry of a Listed Dog in this class is NOT allowed.

NON-REGULAR CLASSES

VETERAN CLASS - In this optional class for All Breed Shows, dogs must be 7 years of age and over on the day of the show. Dogs entered in this class may be spayed or neutered. The awards for this class are: Best Male Veteran and Best Female Veteran Best Veteran in Breed

Best Veteran in Group Best Veteran in Show A Veteran awarded Best Veteran in Breed is not required to stay to compete for Best Veteran in Group. A Veteran awarded Best Veteran in Group is not required to stay to compete for Best Veteran in Show.

BABY PUPPY CLASS - Dogs 4months of age and under 6 months of age on the day of the show. The award for this class are: Best Baby Male and Best Baby Female Best Baby Puppy in Breed Best Baby Puppy in Group Best Baby Puppy in Show

BRACE CLASS - This class shall be for two dogs of the same breed (not necessarily of the same sex).

ALTERED: Altered will be divided Males and Females with a Best of Breed judged for each. The Best of Breed winner will go on to Best Altered in Group and Best Altered in Show. All dogs must be surgically altered to enter this show.

EXHIBITION ONLY - Dogs entered in this class may not compete in the regular breed classes.

OTHER EXTRACTS FROM CONFORMATION SHOW RULES & REGULATIONS

ENTRY FORMS – SECTION 8.2.3

Entry forms received by the CKC, which are incomplete and/or contain incorrect information, may result in awards being cancelled.

ENTRY FORMS – SECTION 8.2.5

An error in an age-specified class, the class, date of birth or sex may be amended on the entry form up to one hour before the start of the show.

ENTRIES - SECTION 8.3.1

Every dog entered in a conformation show must be one of the following:

- a. Registered with the CKC
- b. Have an Event Registration Number
- c. Eligible for registration with the CKC, or
- d. With the exception of Baby Puppy, if it belongs to a listed breed, it must have a Miscellaneous Certification Number (MCN)

REFUSAL OF ENTRIES – SECTION 8.6.2

A Club may refuse any entry form from an exhibitor known to have tendered a dishonoured cheque or declined credit card unless entries are accompanied by cash, money order or certified cheque.

DISQUALIFICATIONS – SECTION 14.1.4

Once a dog has been disqualified for any reason at a conformation show, it may not be entered or shown at another show until the dog has been reinstated by the CKC. All awards earned by the dog shown in violation of this section will be cancelled by the CKC and the owner of the dog is subject to disciplinary action.

INDIGNITIES - SECTION 19.7

It shall be the duty and obligation of the show-giving club to see that a judge, club official, volunteer or any participant at an event held under these rules is not subject to indignities. The Conformation Show Committee Chair shall promptly report to the CKC any infringement of this regulation, and the CKC shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred. A copy of this regulation shall be prominently placed in every premium list and catalogue.

GENERAL RULES GOVERNING THESE SHOWS

It is the responsibility of the Exhibitor to be familiar with the rules pertaining to the event in which they are competing. Copies of the Conformation Rule book are available from the CKC, 400 200 Ronson Dr., Etobicoke, ON M9W 5Z9

1. The Club reserves the right to remove any person from the show. The Show Superintendent shall have full control of the above shows and trials, which will be governed by CKC rules.
2. Any dog excused by the Show Superintendent or the Show Veterinarian for any reason shall not, after being excused, compete in any class for any award for the balance of the show.
3. The show committee will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, or assume any liability in the event of accident, or other misfortune, to either dogs, exhibitors or patrons.
4. A Judge or any person participating in any capacity at a Dog Show held under CKC Rules shall not be subjected to any indignity of any kind during the progress of the show and it shall be the duty and obligation of the Club holding the show to see that this rule is effectively carried out. The Show Superintendent shall promptly report to the CKC any infringement of the rules, and the Discipline Committee shall have the power to take such action as it deems fit on receipt of a report indicating that this rule has been violated.
5. Exhibitors are solely responsible for the conduct or actions of their animals while they are on the show grounds.
6. **DOGS MUST BE READY FOR JUDGING.** The Club will not be responsible for and is not obligated to provide any service for notifying owners or agents of breed or class judging. No ring shall be held up waiting for exhibitors or handlers. Exhibitors & Handlers with more than one dog shall have substitute handlers available so the judging will not be delayed. All start times are **PACIFIC TIME**.
7. The owner of a dog entered in these shows is entirely responsible for any error in entering his/her dog, regardless of how or by whom the entry was made.
8. A dog once disqualified for any reason at a championship show held under these rules cannot again be shown at a show held under these rules until the dog has been examined by an official committee appointed by the CKC and the committee finds the dog is free from the condition which prompted the disqualification. Application for reinstatement must be accompanied by a fee of \$107.80 + GST (CKC member) or \$161.60 + GST (non-member) which shall be forfeited to the CKC if the examining committee is satisfied that the dog should remain disqualified. All awards earned at a dog show in violation of this rule shall be canceled by the CKC and the owner of the dog is subject to disciplinary action.
9. Exhibitors and handlers will be responsible for their dogs and for their equipment left at the Show Grounds.
10. For the benefit of the health of animals and the pleasure of the exhibitors and spectators we insist upon keeping our grounds and buildings as clean as possible. Exhibitors are responsible for cleaning up after their dogs. Please exercise your dog **BEFORE** taking it to the Judging ring. Dogs are to be exercised in the designated areas only, not in the vicinity of the ring areas.
11. No entry fee will be refunded if the Show cannot open or be completed by reason of riots, civil disturbances, fire, and Act of God, public emergency, act of public enemy, strikes or any other cause beyond the control of the Club.
12. Entry fees will not be refunded in the event that a dog is absent, disqualified, excused by the Veterinarian or Judge, or barred from competition by action of the Show Committee.
13. The Club has a zero tolerance of abuse of any description involving any person involved with these shows, including spectators.
14. The washrooms and shower facilities are strictly for human use by order of the Health Department. Offenders will be removed from the Grounds for the duration of the shows.

EXHIBITORS PLEASE NOTE

It Is The Responsibility Of The Exhibitor To Be Familiar With The Rules Pertaining To The Event In Which They Are Competing. The "Dog Show Rules & Obedience Regulations Are Available From:

CHAMPIONSHIP POINTS

15.1.2 The schedule to be employed in the determination of the number of points awarded Winners shall be as follows:

Dogs Competing*	1	2	3 - 5	6 - 9	10 - 12	13 +
Points Awarded	0	1	2	3	4	5

*Includes the dog awarded Winners

In counting the number of eligible dogs in competition, a dog that is disqualified, dismissed, excused or ordered from the ring by the judge shall not be included in the calculation for championship points.

15.1.8 In addition to championship points allocated at the breed level, a dog awarded Best of Breed which also places in the regular Group competition shall be credited with the following additional points provided that a dog was defeated at the Group level.

15.1.9 A dog may not be credited with more than five (5) championship points in a single show.

15.1.10 Permission shall be granted a club or clubs to hold shows in such a way that any dog may earn three (3) sets of championship points on the same day, provided that one or more of those sets of points is awarded at a specialty for that breed or group.

15.1.11 A dog awarded Winners that also places Best in Show at an all-breed conformation show shall be credited with five (5) championship points inclusive of any points earned at the breed and group level.

15.1.12 In order for a dog to be recognized as a champion and its owner provided with a championship certificate, the dog must: (a) earn at least 10 championship points under at least three (3) different judges; (b) be registered in the records of the CKC, have an Event Registration Number (ERN) or have a Miscellaneous Certification Number (MCN); (c) have earned at least one 2-point win either at the breed or group level.

15.1.13 The Board interprets the words “earn at least 10 championship points under 3 different judges” to mean: (a) Three (3) or more Winners awards at not less than three (3) different shows, under three (3) different judges at the breed level; (b) each of the three (3) judge’s awards must be one or more championship points won at Winners, Best of Winners, Best of Breed or group placing; (c) all points required for championship status may be earned at Winners, Best of Winners, Best of Opposite Sex, Best of Breed or group placing.

As of July 2021, the rules for awarding of Grand Champion and Grand Champion Excellent have changed. Please see CKC Conformation Rule 15.2 Grand Champion (GCH) & 15.3 Grand Champion Excellent (GCHEX) for details.

Extracts From CKC Dog Show Rules
Chapter 8 Entries and End of Show Section

8.2.5 An error in an age specified class, date of birth or sex may be amended on the entry form up to one hour before the start of the show.

Section 8.3.1 Entries: Every dog entered in a Championship show must be one of the following:

- a) registered with the CKC,
- b) have an Event Registration Number,
- c) be eligible for registration with the CKC, or
- d) if it belongs to a listed breed, it must have a Miscellaneous Certification Number (MCN).

Section 8.4.1 Listed Dogs: If a dog is not registered as in 8.3.1 (a) or (b) but is eligible for registration with the CKC, it may be entered at a show as a listed dog provided:

- b) that if born in Canada, it is eligible for individual registration;
- c) that if not born in Canada, is eligible for registration in the records of the CKC.
- d) that if it is a foreign born and owned dog, an Event Registration Number or CKC registration number is obtain from the CKC within 30 days of the first show entered.

Section 8.4.2 Entry of a listed dog at a show must be accompanied by a listing fee as set by the Board in addition to the regular entry fee.

Section 8.5.1 Acceptance of Entries: If indicated in the premium list, an electronically transmitted entry may be accepted provided the entry is accompanied by a credit card charge authorization.

Section 8.5.3 No entry shall be accepted from or on behalf of any person who is officially known to be expelled, deprived of privileges, debarred or suspended by the CKC or any other registering body for pure bred dogs.

Section 8.5.4 After entries close, no further entries may be accepted, cancelled or substituted other than as otherwise stated in this section or as provided for in case of a postal strike.

Section 8.6.1 Refusal of Entries: The authorities of any show may:

- a) decline to accept entries for just cause, and/or
- b) refuse to receive or may remove any dog from the show building on account of disease or viciousness.
- c) in the case of non-acceptance, refund the fee with the reason for non-acceptance.

Section 8.8.2 Fees: Tendering of a dishonoured cheque or declined credit card in payment of an entry fee shall be considered non-payment of said fee and is an offense punishable by disciplinary action and cancellation of awards.

Section 8.9.1 Moving a Dog to Specials: A dog which is individually registered in the records of the CKC or that has a Miscellaneous Certification Number (MCN) and has completed the requirements for a Championship in accordance with these rules but at the time of the closing of entries for a show has not received confirmation of the title, may be transferred from one of the regular classes to Specials Only providing the transfer is submitted to the Show Secretary in writing by the owner or handler at least one hour prior to the opening of the show.

Section 8.9.2 If it is established that a dog transferred to Specials Only has not completed the Championship requirements, all awards will be canceled and all ribbons and prizes won shall be forfeited. The owner may also be subject to disciplinary action.

Section 8.9.3 When one or more All-Breed and/or Specialty Shows are held on the same day, in the same venue, the moving of class dogs to Specials must be made prior to the scheduled opening of the first show.

Chapter 4 Judges Section 4.1.3 A judge officiating at a show held under these rules shall not be subjected to indignities of any kind during the progress of the show. It shall be the duty and obligation of the club holding the show to see that this rule is effectively carried out.

Section 4.1.6 No person may approach a judge either directly or otherwise, orally or in writing, to favor his entry. Disciplinary action will be taken against any person who violates this rule or against a judge who fails to report any contravention of this rule to the CKC within 14 days of the act.

Chapter 14 Disqualifying or Excusing Dogs

Section 14.1.2 (a) At his discretion, a judge shall have the authority to excuse or disqualify a dog which menaces, threatens, attempts to bite or bites the judge, another person, or another dog in the ring. When a dog is twice excused on this account, it shall have the status of a disqualified dog.

(b) At his discretion, a judge shall have the authority to permanently disqualify a dog which bites the judge or another person in the ring. Dogs disqualified under this provision will not be eligible for reinstatement. The decision to permanently disqualify a dog must be clearly indicated on the Judge's Disqualification Form.

Section 14.1.4 Once a dog has been disqualified for any reason at a conformation show, it may not be entered or shown at another

1. This is an UNLIMITED entry Conformation dog show. Performance shows entry limited to the timing restrictions of each judge.
2. The Show Committee will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, or assume any liability in the event of accident, or other misfortune to either dogs, exhibitors, or patrons.
3. All entries must be in the Show Secretary's hands by the closing date on the front page of this Premium List.
4. ENTRY FEES WILL NOT BE REFUNDED AFTER CLOSING DATE in the event that a dog is absent, disqualified, excused by a veterinarian or judge, or barred from competition by an act of the event club or because it has been entered incorrectly,. Nor will entry fees be refunded if due to riot, civil disturbance or other acts beyond the control of the RDDKC, that make it impossible to open or complete the show. **See COVID Rules for Special Circumstances.** There will be no refunds on duplicate entries or overpayments
5. NON-MEMBER PARTICIPATION FEE:
 - a. An annual non-member fee for awards and titles will be charged to a Canadian non-member of CKC. The fee will match the ERN fee.
 - b. In order to protect the awards/titles earned, the non-member will have a choice either to become a CKC member or pay the non-member fee.
 - c. These fees apply only to dogs wholly owned by non-members of the CKC.
- 6 The Building will LOCK the doors at 11 p.m. each night of the show and OPEN the doors at 6:00 a.m. each morning. There will not be anyone one in the Building overnight Dogs are left at your own risk. FORT ST JOHN & DISTRICT KENNEL CLUB will not be responsible for any liability in the event of an accident or other misfortune to either dogs, exhibitors, patrons or their property.
- 7 It shall be the duty and obligation of the show-giving club to see that a judge, club official, volunteer, or any participant at an event held under these rules is not subject to INDIGNITIES. The Conformation Show or Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the CKC shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred. A copy of this regulation shall be prominently placed in every premium list and catalogue. (19.7 CKC Conformation Show and 20.7 CKC.)
- 8 All EMPTY rings are to be kept free of dogs one hour before the show and during the show.
- 9 Entries will be ACKNOWLEDGED after the closing date. Judging schedule and receipts available online .
10. Dogs must be EXERCISED in designated areas only. If you exercise outside you must clean up after your dog.
11. All dogs in the show building must either be REGISTERED in the show or "IN TRANSIT".
12. All entries must be CLEARLY filled out. The Red Deer & District Kennel Club or the Show Secretary will not correct incorrect entries.
13. SIGNS advertising puppies or other services will not be permitted in the benching area or around the rings
14. FSJDKC has a ZERO tolerance of abuse of any description involving any person involved with FSJDKC Shows, including spectators. Anyone found to be violating this rule will excused from the show and venue and all events held in conjunction with no refund of fees. A report will be filed with CKC and the Disciplinary Committee shall have the authority to take such action as it deems fit. Including and not limited to suspension from attending the event for a specific period of time in the future, including permanently.



ZERO TOLERANCE – Any individual initiating bullying tactics at The Fort St John & District Kennel Club Shows will be asked to leave the show grounds premises immediately and for the remainder of the event (no refunds). A report will be filed with CKC and the Disciplinary Committee shall have the authority to take such action as it deems fit. Including and not limited to suspension from attending the event for a specific period of time in the future, including permanently.

Definition of Bullying: *Refers to a range of behaviors in which targeted individuals are repeatedly, and over time, treated in a mean, insulting or abusive way. Bullying can be initiated deliberately or unconsciously. The affected person may feel upset, afraid, isolated, or humiliated. The bully sometimes acts alone and sometimes as part of a group of people.*

Examples include:

- *insulting a person's skills, looks, or habits*
- *spreading false or malicious rumors, gossip, or innuendo*
- *berating/belittling an individual*
- *unwarranted criticizing or ridiculing, especially in the presence of others*
- *giving insulting nicknames*
- *engaging in practical jokes that humiliate*
- *undermining or deliberately impeding a person's work*
- *physical gesturing that intimidates, offends, degrades, or humiliates*
- *mocking a person's accent, abilities or mannerisms*
- *yelling or shouting which intimidates, coerces, or belittles*
- *intruding on a participant's privacy by pestering, spying or stalking*
- *physically abusing or threatening abuse*
- *criticising a participant persistently*
- *constantly belittling a person's opinions.*
