Juvenile & Veteran Sweepstakes

Juvenile & Veteran Sweepstakes will be held on Friday July 10th, judged by Jessy Brunet, starting after ring set up (exact time will be listed in the Judging Schedule.) Dogs must be entered in one of the regular official classes to be eligible for Sweepstakes.

The following classes will be offered, divided by sex: 4-6 Months, 6-9 Months, 9-12 Months, 12-18 Months, 7+ Years.

The following percentage of entry fees per class will be offered as cash prizes: Best Puppy in Sweepstakes & Best Veteran in Sweepstakes – 15%, Best of Opposite – 10%, Class Winners – 50%.

*****Junior Handling Provincial Finals*****

We are pleased to announce that the Zone 1A (Newfoundland) Provincial Finals will take place on Saturday, July 11th, 2026. This will occur immediately following the end of Best in Show #2.

We encourage everyone to stay and cheer the finalists on. Let's show our support for our junior handlers - they are the future of the sport!

Provincial finals are by invitation only. Junior handlers earn an invitation to the Provincial Finals by competing in a minimum of three Junior Handling competitions and accumulating a minimum of 100 points in the previous calendar year.

Grooming Space

Grooming will only be allowed on areas tarped by the NKC, crates should be placed along the perimeters and grooming tables must be placed a minimum of 3 feet from the edge of the tarped area. This will help protect the floors from overspray. There is to be no spraying of any kind ringside/in any un-tarped areas. Please keep marked aisles clear.

Grooming space may be reserved by payment thru DogShow.ca when you submit your entries. All remaining grooming space is first come first served.

In addition, as always you must bring your own floor covering for your set-ups. All exhibitors must cover the floor of their grooming area. Plastic, paper or fabric material which may be secured with painter's tape. (Duct tape is NOT permissible.) The floors have recently been replaced and there is a ZERO TOLERANCE POLICY for grooming on uncovered space.

Please remember that these are self-cleaning shows and you are responsible for leaving the venue in the same condition you found it. Be sure to sweep up any dog hair left in your grooming space throughout the weekend and after tear down, and make sure all garbage is thrown out or taken home with you.



Photographer Terms of Service

Sadly, we have had several issues with exhibitors using the photographer's set-up for candid's and/or not paying for pictures. Please respect that our photographer gives up their entire weekend to provide professional photography for our shows and deserves to be compensated. Because of this, proofs will not be sent until payment for the initial request has been made. Photos are \$40 and you will be able to view them on the camera. Personal use of the photographer's set-up is strictly forbidden as is the use of cell phones and personal cameras while dogs are in the set-up.

It shall be the duty and obligation of the show-giving club to see that a judge, club official, volunteer or any participant at an event held under these rules is not subject to indignities. The Conformation Show Committee Chair shall promptly report to the CKC any infringement of this regulation, and the CKC shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred. No person may approach a judge either directly or otherwise, orally, in writing or electronically, to favour his entry. Disciplinary action will be taken against any person who violates this rule, or against a judge who fails to report any contravention of this rule to the CKC within 14 days of the action.

UNSPORTSMANLIKE CONDUCT POLICY

The Newfoundland (All-Breed) Kennel Club has an absolute zero-tolerance policy for unsportsmanlike conduct displayed in relation to our shows, whether in person or on social media. If anyone has a concern about a dog or person at a show, the **ONLY** appropriate action is to speak to the Show Superintendent who will seek to resolve the issue and will convene a committee meeting if deemed necessary. Under absolutely **NO** circumstances is it acceptable or appropriate for anyone to approach another handler, judge, or volunteer in a confrontational, aggressive, or demeaning fashion.

The Show Superintendent has the right to excuse any person without refund for the remainder of the weekend on the basis of unsportsmanlike conduct, and the club has the right to reject future show entries and bar entry to the show site on the basis of unsportsmanlike conduct.

AGGRESSIVE/UNCONTROLLED DOG POLICY

All dogs **MUST** be under control at all times when on the show grounds. Incidents such as barking at and/or lunging towards other dogs will not be tolerated, regardless of if contact is made. Consequences for aggressive behaviour could range anywhere from an Excusal for the weekend up to a Disqualification from competing in any future CKC events.

These incidents most often happen while people are distracted chatting with their friends ringside. Dogs should under no circumstances be staring at other dogs or be approaching or attempting to approach other dogs out on the floor or in their crates. These are sanctioned CKC events and as such, there is a bare minimum expectation that all dogs entering these shows are under control of the handler and are safe to be around other dogs.

Please, if you see anything that gives you cause for concern on the show grounds, let the Show Superintendent know so they can resolve the issues before anything happens.

Championship Point Ratings

A dog awarded Winners at a Championship Show held under these Dog Show Rules shall be credited with a number of championship points (ranging from 0 to 5), and the determination of the number of championship points to be credited to the dog awarded winners shall be as provided hereunder:

* Includes the dog awarded winners.

The system provides for additional points if the dog awarded WINNERS also places in the Group.

A class dog awarded Best in Show at an All-Breed Championship Show will be credited with five points inclusive of any points won at the Breed or Group level. In no case may a dog earn more than five points at a single show. In order for a dog to be recognized as a champion it must win at least 10 points under 3 different judges, which includes at least one 2-point win.

General Information

1. The Show Superintendent will be in full charge of the show, which will be governed by CKC Rules.
2. The Newfoundland All Breed Kennel Club will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, or assume liability in the event of accident, or other misfortunes, to either dogs, exhibitors, or patrons.
3. Only dogs entered in the show will be allowed in the building.
4. All exhibitors are required to clean up after their dogs. Clean up bags and garbage bins are available for this purpose throughout the show site. There continues to be those who do not take responsibility for their dogs, jeopardizing the club's access to this venue. For this reason, exhibitors who permit a dog to soil on the show grounds without cleaning up will be denied entry to NKC shows and trials for one full calendar year. NKC has a zero-tolerance policy for unsportsmanlike conduct during and in relation to their events, including on social media.
5. The use of flexi leads, prong, spike, or electronic collars is prohibited on show grounds.
6. Tripaw Photography will be on-site as our official show photographer! Please note that the photographers set up is exclusively for use by Tripaw Pet Photography and may not be used by exhibitors for personal photos or candids.

7. If, because of riot, civil disturbance or other acts beyond the control of management, it is impossible to open or to complete the show, no refund of Entry will be made.
8. Dogs should arrive in adequate time for their breed judging (allowing for absentees) and will be excused each show when not required for further judging. It is the responsibility of the exhibitors to have the dog at ringside when the dog's class is scheduled for judging. Waiting for dogs will not be possible and handlers with several breeds must arrange for alternate handlers if judging times for their breeds' conflict.
9. Judging will commence at 9:00am each day. Starting time of each ring will be specified in judging schedule. The building will open at 8:00am each morning & close 30 minutes after completion of Saturday judging.
10. Building will be open Friday evening for set-up. Exact time will be listed in the judging schedule.
11. Exhibitors MUST vacate the premises one hour after the judging of General Specials on Sunday.
12. SHOW PRECINCTS: Show precincts shall consist of the entire arena. NOTE: The Show Superintendent may restrict the placing of chairs, tables and crates and may limit the use of private exercise pens during show hours.

If you are able to stick around after the shows on Sunday to assist with tear down, please do so. We are often left with only a few volunteers when tearing down after the show weekend and lack of assistance with tear down may affect our ability to continue host three show weekends per year.

HEALTH REMINDERS

No dog may be brought onto the grounds or premises of an event if it:

- 1. Is known to have distemper, parvovirus, kennel cough or other communicable disease.**
- 2. Has recovered from distemper, parvovirus, kennel cough or other communicable disease within the last 30 days (prior to the event).**
- 3. Has been housed within 30 days prior to the event on premises on which there existed distemper, parvovirus, kennel cough or other communicable disease.**

*** Clubs do have the right to remove a dog from the event premises, and the exhibitor may be subject to disciplinary action if it is found that CKC rules have been contravened.**
