TCN (Listing) Fee per dog per. day per event.....\$11.30*

NOTE: A CKC TCN (Listing) Fee of \$11.30 per dog is payable for each dog that does NOT have a CKC Registration Number, Performance Event Number or Event Registration Number, Temporary Competition number. This \$11.30 is in addition to the regular class entry fee.

NOTE : You must sign and submit BOTH the entry form and the waiver to be a valid entry.

CONDITIONS

Each dog needs two handlers – one to release and one to catch.

All dogs will run individually

All dogs must be inspected before each run – dogs found to be lame or unfit will be scratched and entry fee refunded.

Dogs must be present at roll call for your time block. Dogs not present at roll call will be scratched and entry fee not refunded.

Slip leads are recommended, and muzzles are optional

Dogs may wear a flat collar with no tags (or with tags taped up)

NEW* Females in season must wear a clean, dry, snugly fitting panties specifically designed for the purpose of preventing/containing discharge. Females in season will be scheduled last in the day – please notify the secretary in advance. Females in season must wear panties on the grounds, except in the designated potty area.

EQUIPMENT

A gas powered continuous loop system will be used.

The field is fully fenced, but for the safety of all dogs, there will be no fenced 'catch pen' at the end of the track.

DAY OF TEST

When you enter, you will be assigned to a one hour time block (9am, 10 am or 11 am). Please arrive at least 15 minutes prior to your time block.

Once your dog has been inspected, you will be placed on the running order.

Please ensure that your catcher is in place before you come to the start line.

After your run, stop by the secretary to pick up your run time and ribbon.

If you are entered in both tests, after your first run, please return to inspection to be inspected and placed on the running order for your second run.

AWARDS

Flat ribbons will be given for all qualifying runs.

Rosettes are available for new titles.

EXHIBITORS PLEASE NOTE: It shall be the duty and obligation of the trial- giving club to see that a judge, club official, volunteer, or any participant at an event held under these rules is not subject to any indignities of any kind. The Field Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.

1. To hold the Host Club including its members, directors, officer, employees and volunteers (collectively defined as the 'Host Club') as well as the owner and lessor of the real property on which the event is held, harmless from any claim for loss or injury which may be alleged to have caused directly or indirectly to any person or thing by the act of myself or my dog(s), while in or about the event premises or grounds near the entrance thereto and I assume all responsibility and liability for any such claim.
2. To hold the Host Club harmless from any claim for loss of this dog by disappearance, theft, death or otherwise and from any claim for damage or injury, even if such loss or damage/injury was caused or alleged to be caused by negligence of the Host Club or any other person(s);
3.
