Note: Handlers with entries in a class in both trials on either event day should be prepared for "back to back" running of the classes in an effort to manage the peak size of the gathering during the event day. Ie the Trial 1 Novice Intermediate class will be followed by the Trial 2 Novice Intermediate class.

**USA Exhibitors** Only Bank drafts or money orders, payable in Canadian Funds and negotiable at a Canadian Bank, for the full amount of the entry will be accepted. The Club shall not be obliged to refund entry fees after the closing time to any USA or other foreign Exhibitor who cannot attend the event due to any restrictions placed on travelers to Canada by either Federal, Provincial, State or Local government authorities. **NSF Cheques:** Tendering of a dishonoured payment instrument for entry fees shall be considered non-payment of entry fees, and is an offence punishable by disciplinary action and cancellation of awards (6.3.3 of the Obedience Trial Rules & Regulations) In addition, a \$40.00 service charge will be levied by the Club. **LIMITED ENTRY** means advance entry will be limited when the judge's daily assignment reaches 7 hours of judging as calculated in accordance with CKC rules, and will close at the advertised closing time. *'When the advertised limit has been reached, all remaining entries may be assigned a position on the reserve list. The person making the entry shall be notified of his position on the list. Fees will not be refunded for any reason other than a bitch being in season and to those on the reserve list who did not participate in the trial.'*

**New Title Rosettes** – The Poodle Club of Ontario is pleased to offer a rosette for each dog completing the requirements for an Obedience title at these events.

**Change of Entry: Per Section 6.9 in January 1, 2021 rulebook** with following specific additional allowance. A dog that fulfills the requirements for a title in accordance with the rules during the first trial of the day may move-up to a higher level class for the second trial. The change must be on the appropriate move-up form and submitted to the Trial Secretary by the owner or handler 30 minutes before the start of the desired class.

#### **TCN – Temporary Competition Numbers**

If a dog is not registered individually in the records of the CKC, it may be entered at a trial held under these rules with a Temporary Competition Number (TCN), providing that the number is obtained before the closing date of entries. Once the dog is permanently registered or has an ERN, the TCN will no longer be valid. TCN's can be obtained online through the CKC Member Portal. Exhibitors may also obtain a TCN by completing a printed application and submitting it to the CKC by mail, or by contacting the Shows and Trials Division at 1-855-364-7252.

#### **Electronic Communication**

All entry confirmations, Judge Schedule and any other notices will be sent from the <u>Secretary@thepoodlefarm.com</u> to the Handler or Owner as indicated on the Official Entry Form. It is the Entrants responsibility to ensure that their email account settings are configured to designate <u>Secretary@thepoodlefarm.com</u> as a Safe Sender, Trusted Sender, Always Allow or such other designation as may be required to prevent your email service from flagging such communications as Spam/Junk and blocking from your Inbox.

#### CKC REGULATION 20.7:

It shall be the duty and obligation of the trial-giving club to see that a judge, club official, volunteer or any participant at an event held under these rules is not subject to indignities of any kind. The Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.

## **GENERAL INFORMATION**

- 1. The **trial precincts** shall be the non-residential buildings and surrounding grounds of The Poodle Farm. In accordance with CKC rules only dogs officially entered and competing are permitted within the Trial Precincts.
- 2. Show Superintendent has full charge of the show which is governed by CKC rules.
- 3. The Poodle Club of Canada and The Poodle Farm will use **due care and diligence** for the welfare of dogs and exhibitors, but will not be responsible for, or assume liability in the event of accident, or other misfortunes, to either dogs, exhibitors or patrons.
- 4. **BITCHES IN SEASON** are not permitted to compete. When a bitch comes into season after entries close, a Veterinarian's certificate, certifying that the bitch was in season within ten days of the trial, must reach the Trial Secretary on or before the day of the trial, prior to the judging of the class, and the club will refund the entry fees.
- 5. **Mix Breeds and Unrecognized Breeds** must have a Canine Companion Number (CCN) from the CKC to enter the trials. A dog eligible for a CCN may not be entered as a listed dog. Visit <u>www.ckc.ca</u> for more information.
- 6. If, because of riot, civil disturbance, or other acts beyond the control of management, it is impossible to open or complete the trials, no refund of Entry Fees will be made.
- 7. Per CKC rule 6.7.3 "There shall be no intensive or abusive training of dogs within the *venue* of the trail.", the "*venue*" being the entirety of The Poodle Farm property.
- 8. Flexi-leads may not be used on The Poodle Farm property
