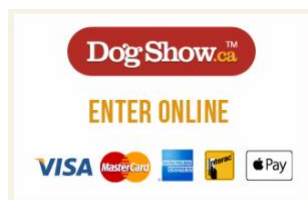

20.7 It shall be the duty and obligation of the trial-giving club to see that a judge, club official, ring steward, volunteer or competitor at an obedience or rally trial held under these regulations is not subject to indignities of any kind. The Trial Chair shall promptly report to the CKC any infringement of this regulation, and the CKC shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred. A copy of this regulation shall be prominently placed in every premium list and catalogue.

Obedience Trial Rules

- * 6.5.2 When a bitch comes into season after entries have closed, the trial giving club must refund the entry fee and listing fee providing the trial secretary receives, on or before the date of the trial, a veterinarian's certificate declaring that the bitch was in season within the 10-day period preceding the trial.
- * 6.7.6 A dog that bites or attempts to bite another dog or a person outside the ring may be removed from the trial by the Trial Committee Chair
- * The Obedience Trial Chair is in complete charge of the trial
- * No dog will be allowed in the building or on the grounds unless entered in the trials or entered as Exhibition Only
- * No dog is to be left off leash at any time on or near the grounds of the trial except in the obedience ring. Violation of this rule can result in dismissal from competition. No refund shall be made.
- * Exhibitors must wear the correct armband while in the ring.
- * Fees must accompany your entries. Tendering a NSF cheque shall be considered an offense punishable by disciplinary action and cancellation of awards by the Canadian Kennel Club. There will be a \$25 fee charge for any NSF cheque. No post-dated cheques will be accepted. Over payments will be donated to the club.
- * The club will use due care and diligence for the welfare of the dogs and exhibitors, but will not be responsible for, or assume any liability in the event of an accident or other misfortune, either to dogs, exhibitors or patrons.
