Dogs competing in junior handling must be entered in the show in one of the regular classes or on exhibition only. Registration will take place in the morning at the Secretary's table.

No post dated cheques accepted. All NSF cheques will be subject to a charge of \$20.00.

N.S.F. cheques are considered non-payment of entry fees and are punishable by disciplinary action and cancellation of awards. Overpayment of entries will be considered a donation to DKC Shows & Trials

Important Note Regarding Emails & Faxes

It will be the responsibility of the exhibitor to ensure that any electronic submission, either email, facsimile, or any document transmitted electronically, reaches

the proper authority or recipient, within the times and limits as regulated for each document in the CKC Rules & regulations. Sent fax receipts, and/or, copies of sent emails, will not be taken as evidence of receipt by recipients.

NON-MEMBER PARTICIPATION FEES ARE IN EFFECT

An annual "Non-member" participation fee for Awards and Titles will be charged to a Canadian "non member" of the Canadian Kennel Club. This fee will match the fee charged for Event Registration Number.

In order to protect the Awards and Titles earned, the "non-member" will have a choice to (a) either become a CKC member; or (b) pay the "non-member" participation fee. Failure to comply within 30 days of notification will cause All Awards and Titles to be cancelled.

Please Note: These fees only apply to dogs wholly owned by "Non-CKC" members and are not applicable to CKC members

OBEDIENCE EXHIBITORS PLEASE NOTE:

1. A separate entry form is required for Obedience trials (for each class)
2. Please designate jump height on entry forms.
3. A bitch in season may not compete. Entry fees will be refunded only if a Veterinarian's Certificate to this effect is received by the Trial Secretary before the commencement of the Trial.

Attention USA exhibitors: Please note that fees are due and payable in Canadian dollars. Due to consistently fluctuating currency rates, discounted cheques will not be accepted. Personal cheques will be accepted, however, they are to be payable in Canadian funds. If you send a cheque in US funds, it must be made out for the full amount of the entry and no exchange will be refunded to the exhibitor.

Please do not mark cheques "Payable in Canadian Funds" or "At Par". They will not be cleared by the banks. To simplify the process, we urge that you purchase bank drafts or money orders payable in Canadian funds. Your understanding and cooperation is appreciated. Thank you

No exhibitor may enter more than 2 puppies.

OBEDIENCE CLASSES

Novice A & B, Open A & B, Utility A & B (Pre-Novice, Novice C and Novice Intermediate)

SEPARATE ENTRIES ARE REQUIRED FOR EACH CLASS ENTERED State Jump Heights

Pre-Novice	for all purebred dogs over 6 months of age.(Not eligible for HIT Competition)
"A" Classes	for dogs handled by owner or immediate family member through all exercises.
"B" Classes	for trainers, multiple entries, exhibitors who have attained a Cdn. OTCh. degree or dogs who have earned titles in another country.
"C" Classes	for dogs who have completed a C.D. title in Canada.(Not eligible for H.I.T.competition)
C.D.I. Class	Novice -Intermediate, for dogs who have earned a C.D. title in Canada (Not eligible for H.I.T. Competition)
Open	for dogs who have earned a C.D. in Canada.
Utility A	for dogs who have earned a C.D.X. but not a U.D.in Canada.
Utility B	for dogs who have earned a C.D.X. or U.D. in Canada
Exhibition	Dogs 6 months & over, not in competition.

RALLY OBEDIENCE CLASSES

Rally ring size is 40' by 60'.

Exhibitors entering both Obedience and Rally must fill out separate entry forms

Novice A	for dogs that have not earned the RN title or a CD or higher and is handled by the owner or immediate family member
Novice B	For any dog until such time as a qualifying score in Advanced is earned.
Intermediate	For any dog that has earned an RN title.
Advanced A	for dogs that have earned the RN title but not earned the RA title and is handled by the owner or immediate family member
Advanced B	For any dog that has earned the RN title
Excellent A	for dogs that have earned the RA title but not earned the RE title and is handled by the owner or immediate family member
Excellent B	For any dog that has earned the RA title

EVENT REGISTRATION NUMBER (ERN)

All dogs that are foreign born and owned and enter Canada for the sole purpose of entering CKC events will require an Events Registration Number (ERN).
To obtain an ERN number simply do the following:

1. Send a photocopy of the dog's registration certificate reflecting current ownership, e.g., AKC Registration Certificate, with a written request for an ERN number.
2. Include with the above a cheque or money order in the amount of \$59.40 (plus GST or HST where applicable) payable to the Canadian Kennel Club.
3. Ensure that you provide us with your full return address to enable the ERN number to be sent to you.
4. Faxed requests will be accepted. Please indicate your VISA / Mastercard number, expiry date, cardholder's name and signature.

This Event Registration Number **MUST** be applied for within 30 days of the first day of entering a CKC event. Dogs may be entered as "Listed", however, failure to apply for an ERN number within 30 days of the first event will result in cancellation of any wins, awards, or scores.

GENERAL INFORMATION

1. The Dartmouth Kennel Club will use care and diligence for the safety and welfare of the dogs and exhibitors but will not be responsible in the event of an accident to dogs, exhibitors or spectators.
2. The building will be open an hour and a quarter before judging commences.
3. Handlers and exhibitors with several breeds must arrange for alternative handlers should judging times of different breeds conflict.
4. The superintendent will be in complete charge of these shows and trials.
5. **Due to the limited amount of space, the superintendent may be required to control the number of and/or area taken up by x-pens. All exhibitors are required to co-operate with the superintendent in this regard.**
6. No dogs will be allowed in the building overnight.
7. In no case may a dog under 3 months of age be allowed within the show/trial precincts.
8. **"Puppy/Dog for sale"** signs will not be permitted within the precincts of the show.
9. It shall be the duty and obligation of the show-giving club to see that a judge, club official, volunteer, or any participant at an event held under these rules is not subject to indignities. The Conformation Show Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.
10. Only dogs entered in the Shows & Trials will be permitted in the building.
11. Only a dog individually registered, or eligible to be registered, in the stud book of the Canadian Kennel Club may compete in these shows and trials.
12. **It is the responsibility of the exhibitor/handler to clean up after their dogs outside the ring and outside the building.** Please make sure your x-pen area is clean before you leave.
13. If because of riot, civil disturbance or other acts beyond the control of the DKC, it is impossible to open or complete the Shows/Trials, no refund of entry fees will be made.
14. The Dartmouth Kennel Club will not be responsible for any equipment left on the show premises.

Champions and championship points - chapter 15

Section 1 - a dog awarded winners at a championship show held under these rules shall be credited with a number of championship points (ranging 0-5), and the determination of the number of championship points to be credited to the dog awarded winners shall be as provided hereunder:

A class dog awarded best in show at an all breed championship show will be credited with five points inclusive of any points won at the breed or group level. In no case may a dog earn more than five points at a single show.
