DIRECTIONS TO TRIAL SITE

From the USA: Take the Pacific Truck Crossing. Go north on 176 Street. Do a U-Turn at 40^{th} Avenue and go south till you get to 3507 - 176 Street.

From Highway 1: Take the 176 Street exit heading south. When you cross 40^{th} Avenue start watching for the driveway on your right.

From Highway 99: Take the 32nd Avenue exit and stay on 32nd until you reach 168th Street. Turn left on 168th Street, Turn right on 40th Avenue. Turn right on 176 Street. Watch for driveway on the right.

EXHIBITOR INFORMATION

All dogs must be on a short leash and under control while on trial grounds except while showing. **FLEXI LEASHES ARE NOT PERMITTED INSIDE ANY BUILDINGS.** There is **NO SMOKING** in this facility or on the grounds. If you must smoke you will need to do so inside your vehicle and dispose of the butts in the vehicle also (this is a City Ordinance). Please pick up after your dog and dispose of waste in appropriate containers.



RUNNING ORDER:

Dogs will be run in height order with dogs being handled by the same person separated into different staged groups.
