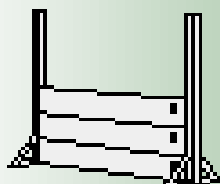

Failure to comply within thirty (30) days of notification will result in the title being withheld and the dog cannot be moved up. The Non-Member Participation Fee is fee paid in the calendar year (January—December) in which the dog achieved its title.

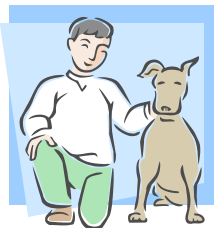
