Conformation All Breed Show 18, 2026 Chilliwack, BC

S 3.3.1 Exhibitors affected by this change may withdraw their entries up to one (1) hour before the judging of the breed, notice of withdrawal must be made in writing. All entry and listing fees for withdrawn dogs shall be refunded. An exhibitor may enter a dog under the replacement judge providing that the dog is entered in one (1) of the regular classes of a show being held at the same venue by the same club and has been assigned a competition number. A new entry, along with accompanying fees, will be accepted by the Show Secretary up to one (1) hour prior to the start of the show.

● ***A reminder that posted times indicate that judging of the class will not begin before the posted time. Judging of Best of Breed dogs in Group will not overlap, however they may for Puppy, Baby Puppy.***

● ***What do the numbers after a breed mean?***

eg 1-2-3-4. indicates 1 Class Dog-2 Class Bitches-3 Special Dogs-4 Special Bitches

eg BP 4-5. indicates 4 Baby puppy Dogs-5 Baby puppy Bitches.

eg EX 1-0. Indicates 1 Exhibition Only Male and 0 Exhibition Only Bitches.

Exhibitor Notice

Access to Hall 1 and 2 with dogs and/or equipment is only by accessing the South end of Hall 2 (near the dog exercise area). There will be a temporary unloading/loading area with four-way flashers to be activated when stopped.

Dogs and/or exhibitors with equipment are not permitted to access or exit via the public entrances with the glass doors at the North end of Hall 1 and 2. You may access via the emergency exit doors.

Any mess created by your dog or damage caused by your equipment must be cleaned or remedied immediately.

Dogs are to be exercised across from the South side of Hall 2 in the designated exercise area. At no time are they to urinate or defecate on/in/near the venue structures, garbage cans, etc.

Failure to comply at any time on venue grounds is subject to immediate disciplinary action.
