#### Notice to Exhibitors

Canine Coaching Club will be open each day at 8 am.

Dogs must be on leash at all times.

**Exhibitors must pick up after the dogs and the entrance way is not to be used as the potty area.** Please go to the north end of the building as the property towards the grounds entrance is not to be used by the trial participants.

Please bring indoor shoes no matter what the weather. The rings will stay much cleaner if everyone cooperates.

**Dogs must be crated at all times, no exceptions.** This will allow the trial dog and warm up dog ease of movement to and from the rings/warm-up area without incident. Crates are available for use at the club, please let me know if you would like to use one of the club crates. It saves on space, allowing for a good size warm-up area, if everyone does not bring personal crates.

During the day, there will be coffee and cold refreshments available in the kitchen area, at a nominal fee to replace the club's supplies. Carla will have homemade snacks to purchase, just covering her costs, but feel free to bring your own lunch.
