RALLY OBEDIENCE CLASSES

No dog may be entered in both the "A" and "B" Class at the same level in any one trial.

Rally Novice A

Dogs competing in this class may not have earned the R. N. title or any CKC Obedience title other than P.C.D.. No handler who has exhibited a dog through its CKC C.D.X. title shall be eligible to enter this class. The handler of any dog in this class must be the owner, co-owner, or a member of their immediate families. A person may enter more than one dog in this class.

Rally Novice B

Any dog may compete in this class until a qualifying score in the Rally Advanced Class is earned. The owner or any other person may handle dogs in this class. A person may enter more than one dog in this class.

Rally Intermediate

This class shall be for dogs that have earned the R.N. title. A dog completing the R.I. or any other obedience or rally titles may continue to compete in this class indefinitely. The owner or any other person may handle dogs in this class. A person may enter more than one dog in this class.

Rally Advanced A

This class shall be for dogs that have earned the R. N. title but have not earned the R. A. title or any CKC Obedience title other than P.C.D.. No handler who has exhibited a dog through its CKC C.D.X. title shall be eligible to enter this class. The handler of any dog in this class must be the owner, co-owner, or a member of their immediate families. A person may enter more than one dog in this class.

Rally Advanced B

This class will be for dogs that have earned the R.N. title. A dog completing the R.A. title may continue to compete in this class indefinitely. The owner or any other person may handle dogs in this class. A person may enter more than one dog in this class.

Rally Excellent A

This class shall be for dogs that have earned the R. A. title, but have not earned the R. E. title or any CKC Obedience title other than P.C.D.. No handler who has exhibited a dog through its CKC C.D.X. title shall be eligible to enter this class. The handler of any dog in this class must be the owner, co-owner, or a member of their immediate families. A person may enter more than one dog in this class.

Rally Excellent B

This class will be for dogs that have earned the R.A. title. A dog completing the R.E. title may continue to compete in this class indefinitely. The owner or any other person may handle dogs in this class. A person may enter more than one dog in this class.

RULES GOVERNING THESE TRIALS.

- 1. Dogs must be kept under control and on leash at all times within the building with the exception of the rally obedience ring. Only dogs entered in the regular classes or for exhibition only are allowed within the precincts of these trials.
- **2.** Exhibitors are responsible for cleaning up after their dogs, inside and outside the building. Dogs are to be exercised in designated areas only.
- **3.** Collars used in Rally must be the same as those accepted for use in Obedience Trials (Rule 8.16.1)
- **4.** F.P.O.&T.C. will use all reasonable care to ensure the safety of the dogs exhibited but will not be responsible for or assume any liability for loss or injury to any dog or exhibitor.
- 5. The owner of a dog entered in these trials is entirely responsible for any error in entering their dog, regardless of how or by whom the entry was made. The entry form must be complete in every respect. Exhibitors must abide by any errors made in entering their dog.
- **6.** No entry fee will be refunded if the trials cannot open or be completed by reason of riot, civil disturbance, fire, act of God, public emergency, act of a public enemy, strike or any other cause beyond the control of F.P.O.&T.C.
- 7. Tendering of an NSF cheque in payment of entry fees shall be considered non-payment, and is an offence punishable by disciplinary action and cancellation of awards.(Ch. 9, Sec. 16, Dog Show Rules)
- 8. The Rally Trials Chairman shall have complete authority at all times.
- **9.** Bitches in season may not compete. Full refunds will be given for dogs withdrawn because of injury, illness or death and for bitches in season, if notification in writing is accompanied by a veterinarian's certificate. CKC event fees and listing fees, if applicable, will be deducted from all refunds.
- 10. It shall be the duty and obligation of the trial-giving club to see that a judge, club official, ring steward, volunteer, or competitor at a Rally Obedience Trial held under these regulations, is not subject to indignities of any kind. The Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred. (Rule 17.7)
- 11. It is the responsibility of each competitor to be familiar with and abide by the current Canadian Kennel Club Rally Obedience Trial Rules and Regulations.

Effective January 1, 2011 Non-Member Participation Fee

- * A non-member participation fee will be charged to a resident of Canada who is a non-member of CKC.
- * The non-member participation fee is paid in any year a title is earned and covers all titles and dogs owned by that individual.
- * In order for the title to be awarded, the non-member will have a choice to either become a CKC member or pay the non-member participation fee. Failure to comply within 30 days of notification will result in the title being withheld and the dog cannot be moved up to the next level.
- * All Premium lists will carry a note stating the fee applies only to dogs wholly owned by non-member residents of Canada and is not applicable to CKC members.
