This WC test is being conducted in conjunction with the LRCA three-day Labrador Specialty Show being held at the Lakedell Agricultural Society facility at Westerose, Alberta (near Pigeon Lake). **Tests will start promptly at 9:00 AM** with the WC land tests, followed immediately by the land tests for WCI and WCX. Water tests will be held after all land tests have been completed. Handlers are requested to initially check in with the Test Secretary at the specialty site by 8:00 AM, where they will be given further directions to the WC test site. **The WC site is approximately 15 minutes away from the specialty. Take Highway 2 to Highway 13.** Follow Highway 13 West for about 23 kilometres. **Drive past the village at Pigeon Lake and watch for Range Road 12. Turn left just before Lakedell School. (see attached map)**

#### **NOTICE TO EXHIBITORS**

Any person participating in any capacity at a Hunt Test or Working Certificate Test held under the CKC rules and regulations shall not be subjected to any indignity of any kind during the progress of the tests and it shall be the duty and obligation of the Labrador Retriever Club of Alberta to see that this rule is effectively carried out. On report to the Labrador Retriever Club of Alberta of an alleged indignity of any kind the Test Chairman will report the infringement to the CKC and the Test Committee shall forthwith conduct an investigation and shall have the power to take action as it deems fit on receipt of a report indicating that this rule has been violated.

#### **GENERAL INFORMATION**

- 1. Working Certificate Test Rules and Regulations Books are available from the Canadian Kennel Club, Suite 400, 200 Ronson Drive., Etobicoke, ON M9W 5Z9
- Entries must be typewritten or clearly printed. Owners are responsible for errors on entry forms. The Labrador Retriever Club of Alberta does not assume any responsibility for incorrect information or errors due to illegibility of information on any entry form. Make cheques payable to the Labrador Retriever Club of Alberta.
- 3. A separate Entry Form for each dog in each test is required (official CKC Entry Form).
- 4. Entry fees **will not** be refunded after **6:00 P.M., 13 August, 2016**. In the event that a dog is absent, disqualified, excused by a judge or barred from competition by action of the Test Committee or the Canadian Kennel Club, or because it has been entered incorrectly, or if it is impossible to open or complete the test, no refund of entry will be made.
- 5. In the event of a mail strike, please courier or hand deliver entries to the Test Secretary prior to the closing date.
- 6. No POST-DATED cheques will be accepted.
- 7. Post entries will not be accepted.
- 8. Running order will be determined by random selection. Running order will be available after 6:00 P.M. Wednesday 17 August 2016.
- 9. Bitches in season shall not be eligible for entry.
- 10. Ducks will be used in all tests.
- 11. For the WC, WCI and WCX Tests, all tests will be run at the same location and all land retrieves for all tests will be run before water tests.
- 12. All throwers, Judges and competitors should wear dark or camouflaged clothing.
- 13. Any dog not appearing within 15 minutes of being called to the line by the Marshall may be disqualified.
- 14. Entry and listing fees paid for any dog withdrawn because of injury, illness, estrus, or death shall be refunded in full. An appropriate veterinary certificate must be given to the Test Secretary BEFORE the start of the test to qualify for a refund. All other refunds must be requested in writing within 14 days of the event, explaining the reason for the scratch. Scratches will be refunded at the discretion of the Test Committee, all but a fee of \$15.00.
- 15. Effective Jan.1992, all dogs that are foreign born and foreign owned and enter Canada for the sole purpose of entering CKC events no longer require a CKC registration number but will require an event registration number (ERN). Each dog must have its own number. To obtain an ERN number, send a photocopy of the dog's foreign registration certificate with cheque or VISA/Mastercard number. Provide your complete address for return of ERN number. Cost \$58.50 (plus GST). ERN numbers must be applied for within 30 DAYS of the FIRST day of entering a CKC event.
- 16. The Labrador Retriever Club of Alberta and its members will use due care and diligence for the welfare of dogs and exhibitors, BUT will not be responsible for, nor assume any liability in the event of an accident, injury or other misfortune to either dogs, exhibitors or patrons.
- 17. Electric Collars (either dummy or live) as well as prong or pinch type collars shall not be worn by any dog on the test grounds at any time during the event.
- 18. There shall be no training of dogs on the test grounds, except for single training bumpers, which are thrown by hand by the trainer, within 24 hours of the commencement of the event or anytime during the event.

### ATTENTION: CANADIAN EXHIBITORS CKC Non-Member Participation Fee

- a) An annual non-member participation fee for awards and titles will be charged to a Canadian non-member of CKC. The fee is \$59.40 + GST.
- b) In order to protect the awards/titles earned, the non-member will have a choice either to become a CKC member or to pay the non-member participation fee. Failure to comply within 30 days of notification will cause all awards and titles to be cancelled.
- c) "these fees apply only to dogs wholly owned by Canadian resident non-CKC members and are not applicable to CKC members"
