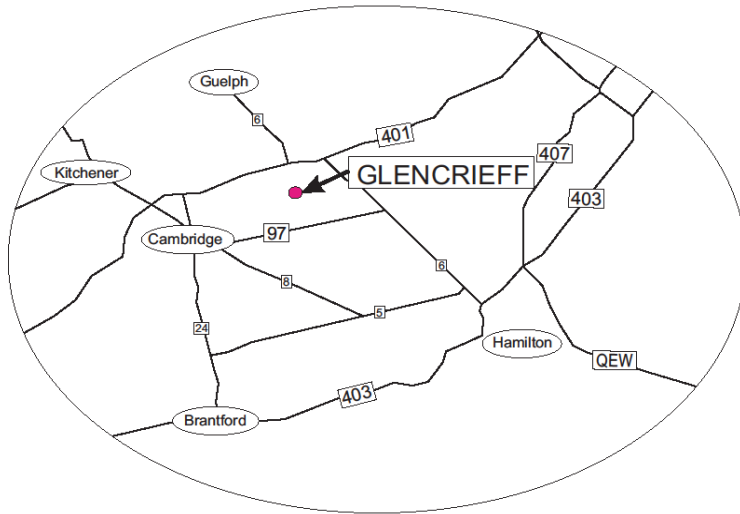

Only those entries submitted in the manner outlined in this Premium List and received BEFORE the Closing date will be accepted.

A maximum of 20 dogs combined in WC/WCI/WCX will be accepted.

If, at closing, fewer than 8 dogs have entered the WC/WCI/WCX test the Labrador Owners Club may cancel the test (WC rule 2.3.1(b)). In such a case all entrants will be notified immediately after closing.

TEST DETAILS:

- Standard CKC rosettes awarded to all qualifying dogs
- Ribbons will be given out at the conclusion of each test.
- Ducks will be used
- Shotguns may not necessarily be used
- Handlers should not wear distinctive white or light clothing except that handlers may wear handling jackets for blinds in WCX.
- Refunds will be given for bitches in season. A Veterinarian certificate must be submitted prior to test
- Running order is by random draw within each test level
- Recommended arrival time is ½ hour prior to the start time for each stake.

All owners of unregistered, CKC-recognized breeds entering events are required to obtain a *Temporary Competition Number* (TCN).

TCNs are replacing the current system of entering events with dogs as “listed”, and allow dogs to temporarily participate in CKC events while they pursue permanent registration or an Event Registration Number (ERN).

- A TCN must be obtained before submitting an entry for an event.
- The same TCN must be used for all event entries for a dog until the dog is permanently registered or has an ERN.
- A TCN cannot be used for Listed Breeds with an MCN (Miscellaneous Competition Number) or dogs that will require a PEN (Performance Event Number) or CCN (Canine Companion Number).

- [Online](#) through CKC’s Portal (Note: Individuals who have not yet used the online Portal will be required to create a Portal account before they can submit a TCN application online);

CKC Rules & Regulation for Working Certificate Tests (section 14.7)

14.7: It shall be the duty and obligation of the event-giving club to see that a judge, club official, volunteer, or any participant at an event held under these rules, is not subject to indignities. The Working Certificate Test Committee Chair shall promptly report to the CKC and infringement of this regulation, and the CKC shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred. A copy of this regulation shall be prominently placed in every premium list and catalogue.

LUNCHES

Due to COVID LUNCHES will not be available this year.

Note: Due to the COVID-19 Pandemic any Public Health restrictions for travel and social gathering at the time of the Test will dictate available spaces and or cancellation of the Test.

All participants are expected to comply with current COVID Public Health Guidelines for the area at the time of the test. These Guidelines will be posted and forwarded with the running Order.

- **Failure to do so will result in forfeiture of your participation and entry fee.**

If the test fills and you wish to go on a wait list a paper entry may be mailed to the test secretary and a list will be compiled on a first come basis. No paper or emailed entries will be accepted prior to the opening or the filling of the test.

Labrador Owners Club COVID Waiver

Assumption of the Risk and Waiver of Liability Relating to Coronavirus/COVID-19

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. **COVID- 19 is extremely contagious** and is believed to spread mainly from person-to-person contact.
